We have performed an audit of the accompanying financial statements of 403(b) Thrift Plan for NeighborImpact (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of June 30, 2025, and the related statement of changes in net assets available for benefits for the year the ended, and the related notes to the financial statements.

Notes to Financial Statements

1. Plan Description

The following brief description of the 403(b) Thrift Plan for NeighborImpact Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General - The Plan was established September 1, 2016, and is a defined contribution plan covering employees of NeighborImpact (the Organization) who meet certain eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan custodian and Plan Administrator are responsible for oversight of the Plan. The Plan custodian and Plan Administrator determine the appropriateness of the Plan's investment offerings and monitor investment performance.

Effective July 1, 2024, the Plan was restated under a 403(b) volume submitter plan document. In October 2024, the Plan switched to Mid Atlantic Trust Company (MATC) as custodian. Prior to October 1, 2024, the custodian of the Plan was Mutual of America Life Insurance Company (Mutual of America). All participant account balances are held by MATC or Mutual of America. The participant directs the investment of all contributions and earnings thereon and may change their investment directive at any time.

Eligibility - Employees are eligible to participate in the Plan on their hire date. Participants are eligible for employer contributions once they have reached 18 years of age and have completed one year of service. Eligible employees do not include non-resident aliens. Eligible employees are automatically enrolled in the Plan at a deferral rate of 1 percent of compensation unless a separate election is made. The automatic deferral percentage will increase by 1 percent per year up to a maximum of 3 percent of compensation unless a separate election is made.

Contributions - Each year participants may contribute up to 100 percent of their annual compensation, as defined in the Plan, subject to statutory limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). For employees other than highly compensated employees, the employer matching contribution is equal to 100 percent of the participant's elective deferrals that do not exceed 3 percent of the participant's compensation. For employees who are considered highly compensated employees, there is no employer matching contribution. For all employees, the employer base contribution is 3 percent of a participant's compensation. For the year ended June 30, 2025, the total employer contribution was \$667,227.

Participant Accounts - Each participant's account is credited with the participant's contributions and the Organization's matching contributions and base contributions, as well as allocations of Plan earnings. Deducted from each participant's account are any distributions made to the participant and an allocation of administrative expenses that are paid by the Plan. Allocations of administrative expenses are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Plan Description - Continued

Vesting - Participants are immediately vested in their contributions and all employer contributions, plus actual earnings thereon.

Payment of Benefits - Upon attaining normal retirement age of 65, termination of service, death, or disability, a participant may elect to receive a lump-sum distribution of the entire vested account balance. Terminated participants whose account balance is \$5,000 or less will automatically receive a lump-sum distribution. In-service distributions are available to participants who have attained age 59.5. Hardship distributions are available only for the purpose of meeting immediate and heavy financial needs.

2. Summary of Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates - The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect reported amounts of net assets at the date of the financial statements, and the reported amounts of additions to and deductions from net assets available for benefits during the reporting period, as well as disclosure of any contingent assets or liabilities. Actual results could differ from these estimates.

Investment Valuation and Income Recognition - Investments in shares of registered investment company funds and pooled separate accounts are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the custodian. Additional information about fair value measurements can be found in *Note 4*.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contract value is the relevant measurement attribute for fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value approximates fair value for the fully benefit-responsive investment contracts. Investments in fully benefit-responsive investment contracts are reported at contract value as described in *Note 5*.

Benefits Paid to Participants - Benefits are recorded when paid. At June 30, 2025, there were no benefits processed and approved for payment, but not paid.

2. Summary of Significant Accounting Policies - Continued

Expenses - Certain expenses are paid by the Organization and are excluded from these financial statements. Certain administration and asset fees are paid by the Plan. Investment related expenses are included in net appreciation in fair value of investments.

3. Certified Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including cash and investments held at June 30, 2025, and net investment income for the period October 1, 2024 through June 30, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by Mid Atlantic Trust Company. Information about investments held at June 30, 2024 and net investment income for the year ended June 30, 2025 was obtained by management and agreed to or derived from information certified as complete and accurate by Mutual of America Life Insurance Company.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at June 30, 2025 and 2024.

4. Fair Value Measurements - Continued

Following is a description of the valuation methodology used for assets measured at fair value on a recurring basis:

Shares of registered investment companies - Valued at the daily closing prices provided by the custodian. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The only assets held by the Plan at June 30, 2024 that are reported at fair value are pooled separate accounts, which are valued at the net asset value per unit as provided by Mutual of America. Net asset values per unit are derived from values of similar investments that have quoted prices in active markets. The net asset value is used as a practical expedient to estimate the fair value and is based on the fair value of the underlying investments less liabilities. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the pooled separate accounts, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure securities liquidations are carried out in an orderly business manner. Investments valued at the net asset value per unit practical expedient are not subject to the fair value hierarchy defined above. Investments held in pooled separate accounts totaled \$5,423,664 at June 30, 2024.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The investment objective for the pooled separate accounts is to lower the costs to investors through economies of scale available by combining the assets of multiple investors, to provide daily liquidity, and to provide better diversification. Each investor owns a participating interest that is calculated in units and represents its portion of the holdings of the fund.

5. Guaranteed Investment Contracts

The Plan had an interest accumulation account with Mutual of America until the custodian change in October 2024. Mutual of America maintained contributions to this account in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The interest accumulation account issuer was contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The interest accumulation account was carried at cost plus accrued interest.

Mutual of America has informed the Plan Administrator that they believe the interest accumulation account is comparable to a cash equivalent, as investments held in the contract are completely liquid, the value provided to the Plan is the redeemable value of the fund, and there are no deferred sales charges, load assessments, or interest rate adjustments that would affect the value as a result of a withdrawal request. The value of the interest accumulation account at June 30, 2024, was \$427,332. The Plan Administrator believes this investment is not subject to the fair value measurement requirements.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the Plan's ability to transact at contract value with Mutual of America. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; or (5) premature termination of the contract. The Plan Administrator does not believe any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

6. Transactions with Parties-in-Interest

The Organization is the Plan sponsor and administrator and pays certain administrative costs, including accounting, legal, and consulting fees, on behalf of the Plan. Fees related to processing benefit payments to participants are charged directly to the participant's account and are included in administrative expenses.

Mutual of America, who served as custodian of the Plan, managed certain Plan investments. Starting in October 2024, MATC serves as custodian of the Plan and manages certain Plan investments. These investments and investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments.

7. Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. However, no such action may deprive any participant or beneficiary under the Plan of any vested right.

8. Income Tax Status

Effective July 1, 2024, the Plan is utilizing a volume submitter 403(b) plan document and is relying on this volume submitter 403(b) plan's opinion letter from the Internal Revenue Service (IRS) dated March 2, 2020. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code (IRC) and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Prior to July 1, 2024, the Plan had been designed to qualify under Section 403(b) of the IRC. The Plan Administrator and the Plan's tax counsel believed that the terms of the Plan were prepared to conform with the requirements of Section 403(b) of the IRC and was operated in conformity with the applicable requirements of the IRC, and, therefore believed that the Plan was qualified.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2025, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible changes in the values of investment securities will occur in the near-term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits, and the statement of changes in net assets available for benefits.
