Independent Auditor's Report

Opinion

We have audited the accompanying financial statements of Acutec Precision Aerospace, Inc. Group Medical Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of June 30, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the year ended June 30, 2024, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

June 30, 2024 and 2023

NOTE A - DESCRIPTION OF PLAN

The following description of Acutec Precision Aerospace, Inc. Group Medical Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a self-insured health benefit plan that provides benefits to all eligible employees of Acutec Precision Aerospace, Inc. (the Company and Plan Sponsor), as well as former employees electing coverage under Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA) provisions.

In order to be eligible for health benefits, the employee must be a regular full-time employee and work at least 30 hours per week. Employees are eligible upon their date of hire. Benefits are also provided to spouses and dependents of these individuals who elect coverage on their behalf. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was a member of Veris Benefits Consortium, LLC, which operated as a health insurance consortium under which the members negotiated and established welfare benefit plans for their employees. Expenses of the health plan were paid through the Veris Benefits Consortium, LLC Trust. The employees were required to pay for a portion of the cost of the benefit.

Contributions:

The Company shall contribute such amounts to the Plan as necessary for timely payment of all claims and administrative expenses of the Plan. The Company provides for stop loss insurance over a specified amount as per agreement with the reinsurance carrier, with the premiums being paid by funds deposited in the Plan. Employee contributions are determined on a fixed fee basis. The amount varies depending on the plan selected and the coverage tier.

Benefits:

The Plan provides health (medical, hospital, surgical, and major medical) and prescription drug benefits to substantially all employees of the Company who meet the service requirement of the Plan and to their covered dependents. The Plan also provides continuation of certain benefits upon termination of employment through COBRA as defined in the plan document.

The Company provides most health insurance benefits and pays the administrative fees incurred. The employees pay a portion of their health coverage based upon the coverage chosen through payroll deferrals.

The health claims are processed through Highmark.

Basis of Accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Estimates:

The accompanying financial statements have been prepared using the accrual basis of accounting. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits:

Premiums paid by the trust from general assets of the Company are recorded as insurance premiums in the accompany statement of changes in net assets available for benefits when paid.

Claim payments are recoded when paid by the third-party claims administrator.

Stop Loss Insurance:

The Plan has a stop loss insurance arrangement whereby the stop loss insurance will cover the Plan's obligations for any plan participant's claims in excess of a fixed dollar amount (self-insured retention). The self-insured retention for the Company was \$100,000 per covered person for the years ended June 30, 2024 and 2023. As of June 30, 2024 and 2023, the specific stop loss reimbursement receivable was \$100,635 and \$23,642, respectively.

In addition, the Plan has an aggregate stop loss insurance arrangement whereby the aggregate stop loss insurance will cover the Plan's obligations if all claims exceed a fixed dollar amount. If the Plan is in a deficit for the year, the stop loss provider will fund the deficit. At the end of the stop loss policy year, the Plan will owe any amounts that were reimbursed in excess of the Plan's deficit. For years ended June 30, 2024 and 2023, the Plan did not owe any amounts to the stop loss provider.

Premiums for stop loss insurance are included in insurance premiums in the accompanying statement of changes in net assets available for benefits. Stop loss refunds of \$884,736 have been netted with claims paid in the accompanying statement of changes in net assets available for benefits for the year ended June 30, 2024.

Plan Benefit Obligations:

Plan Benefit Obligations at June 30, 2024 for health claims incurred by active participants, but not reported at that date are estimated by the Plan's actuary in accordance with accepted actuarial principles based on claims data provided by the Plan's third-party claims administrator. These amounts are paid by the Plan only if claims are submitted and approved for payment. Such estimated amounts are reported in the accompanying statements of benefit obligations. Due to the short-term nature of the reserve liability, time value of money was not used to discount future payments.

Administrative Expenses:

The Plan pays administrative expenses that consist primarily of administrative fees paid to the third-party claims administrator, custodian, and actuary. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Company on behalf of the Plan.

Correction of errors:

The Plan has restated its previously issued 2023 financial statements to accurately exclude claims payments approved but not yet paid as of year end. The accompanying financial statements have been restated to reflect the corrections.

NOTE C - CLAIMS INCURRED BUT NOT REPORTED

Plan obligations at June 30, 2024 and 2023 for claims incurred but not reported are estimated by the Plan's actuary in accordance with accepted actuarial principles based on claims data provided by the Plan's third-party claims administrators. These amounts are paid by the Plan only if claims are submitted and approved for payment. This estimate includes (1) unreported claims; (2) reported but unprocessed claims; and (3) processed but unpaid claims. Claim settlement expense liabilities are not included. A method was used that applies a factor (the reserve factor) to a credible best estimate volume measurement of paid claims. The calculation was performed for medical and drug coverage. Time value of money was used to discount future payments so that the claims that were used to form the given IBNR estimate are on the same time basis as the IBNR evaluation date at June 30, 2024. Due to the short term nature of the reserve liability at June 30, 2023, time value of money was not used to discount payments. Total estimated claims incurred but not paid are \$465,162 and \$326,776 at June 30, 2024 and 2023, respectively. Claims paid by the claims processor prior to the year-end that are not reimbursed by the Plan as of year-end are recorded as claims payable and included in claims payable and claims incurred but not reported on the statements of benefit obligations

NOTE C - CLAIMS INCURRED BUT NOT REPORTED

The foregoing assumptions are based on the presumption that the Plan will continue without any significant modification in its terms or in the benefits being provided under the Plan. Were the Plan, or any or all of the benefits now provided under the Plan, to be materially modified or discontinued, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the incurred but not reported claims (IBNR).

NOTE D - TAX STATUS

The Plan is funded through a non-qualified trust under Internal Revenue Code (IRC) 419(a). The trust files Form 1041 U.S. Income Tax Return for Estates and Trusts. Plan management believes that the Plan is being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and concluded that the Plan had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

NOTE E - RISKS AND UNCERTAINTIES

The Plan maintains cash balances at a financial institution which at times may exceed the Federal Deposit Insurance Corporation limits per depositor at each financial institution. The Plan has never experienced any losses related to these balances.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates and participant demographics, both of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

NOTE F - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to modify the benefits provided to active employees, discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.

NOTE G - RELATED PARTY TRANSACTIONS

The Plan paid certain expenses related to Plan operations to various service providers who are parties in interest under ERISA.
