INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Northwood Health Systems, Inc. 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended June 30, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Northwood Health Systems, Inc. 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of June 30, 2025 and 2024, and for the year ended June 30, 2025, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Note 1 – Description of Plan:

The following description of the Northwood Health Systems, Inc. (“Organization”) 403(b) Plan (“Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General

The Plan was originally formed on July 1, 1992. It was amended and restated effective October 1, 2011 and then amended and restated July 1, 2013 for the purpose of defining employees classified as “Community Provider” and HCEs as employees excluded for purposes of employer contributions. It was then amended and restated effective January 1, 2015 to discontinue their safe harbor provision and replace it with a discretionary matching provision. It was then amended and restated effective July 1, 2019 to comply with current law. Finally, the Plan was amended and restated December 18, 2024 to increase the cash-out limit from \$5,000 to \$7,000. The Plan covers essentially all employees of the Organization who are able to enter the Plan upon their hire date. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective December 17, 2024, the Plan transferred its investments and participant balances from Lincoln Financial Group to Great-West Trust Company, LLC, an agent of Empower Retirement through June 30, 2025. Both entities are qualifying institutions that have certified the Plan’s investments and investment earnings held during the year, for additional information, see Note 3 to the financial statements.

Contributions

Each year, participants may make elective deferrals up to the maximum percentage of eligible compensation or dollar amount permissible under the Internal Revenue Code. Participants who have attained age fifty (50) before the end of the calendar year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. There is also a provision for special 403(b) “catch up” for employees with 15 years of services with a public-school system, hospital, home health services agency, health and welfare agency, church, or convention of association of churches. The elective deferral limit can be increased by the lessor of:

- \$3,000
- \$15,000 reduced by the total elective deferrals made for the qualified employee by the Organization in prior years, or
- \$5,000 multiplied by the number of years of service at the Organization, reduced by the total deferrals made for earlier years.

An employee who qualifies for the 15-year rule can have an elective deferral limit as high as \$23,000 and \$22,500 for the December 31, 2024 and 2023 calendar years, respectively.

Note 1 – Description of Plan (Continued):

The Organization may make discretionary contributions which will be determined each year and contributed to each eligible participant. To be eligible for the Organization’s discretionary contribution, an employee must complete one year of eligibility service (12 consecutive months of service from hire date) prior to being eligible the following July 1 or January 1, reach age twenty-one (21), complete 1,000 hours of service during the current Plan year, and be employed on the last day of the Plan year unless the employee has died, retired, or become disabled. For the year ended June 30, 2025, the Organization made discretionary contributions of 2% of compensation for eligible participants.

Participant Accounts

Each participant’s account is credited with the participant’s and Organization’s contributions and allocation of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants whose hire date is prior to June 30, 2006 are fully vested in the Organization’s discretionary contributions after three (3) years of service. Participants whose hire date is after June 30, 2006 are vested based on the Organizations vesting schedule.

On June 30, 2025, the Organization’s vesting schedule is as follows:

Forfeiture and Expense Accounts

For the years ended June 30, 2025 and 2024, forfeited nonvested accounts totaled \$43,170 and \$10,240 respectively. These accounts are used to reduce future employer contributions, pay administrative expense or restore participant accounts. For the year ended June 30, 2025, \$43,170 were used to fund the Organization’s contribution.

The Organization also had an expense account established with Lincoln Financial Group who was the plan trustee through December 17, 2024. The expense account is to be used to pay Plan expenses. As of June 30, 2025 and 2024, the expense account totaled \$0 and \$22,747, respectively. In addition, for the year ended June 30, 2025, \$52,565 were used to pay Plan expenses.

Note 1 – Description of Plan (Continued):

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amounts equal to the value of the participant's vested interest in his or her account, or annual installments over a specified period of time. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Any loan granted requires a participant to pledge a maximum of 50 percent of his or her vested account balance as collateral for the loan. If the loan represents more than 50 percent of the vested account balance, additional collateral will be required. The loans bear interest at the prime rate plus 1%. Principal and interest are paid ratably through payroll deductions.

Note 2 – Summary of Significant Accounting Policies:

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for the fully-benefit responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation and for which participant compensation is earned.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2025 or 2024. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Consideration of Subsequent Events

For the year ended June 30, 2025, the Plan has evaluated subsequent events for potential recognition through February 2, 2026, the date the financial statements were available to be issued.

Note 3 – Certified Investments:

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at June 30, 2025 and 2024 and net appreciation in fair value of investments, dividends, and interest income on notes receivable from the participants for the year ended June 30, 2025, was derived from information supplied to the plan administrator and certified as complete and accurate by Lincoln Financial Group and Empower Retirement, an agent for Great-West Trust Company, Inc., qualified institutions.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Note 4 – Fair Value Measurements:

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1 – Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the assets or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs that are unobservable and significant for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at June 30, 2025 and 2024.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4 – Fair Value Measurements (Continued):

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Plan Termination:

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination participants would become 100% vested in their accounts.

Note 6 – Related Party Transaction and Party-In-Interest Transactions:

Certain Plan investments were managed by Lincoln Financial Group and Empower Retirement as the trustees as defined by the Plan. The Plan also allows for notes receivable from participants.

Note 7 – Group Annuity Contract with Insurance Company:

The Plan has entered into a fully benefit-responsive guaranteed investment contract with Empower Retirement and the Lincoln Financial Life Insurance Company. Empower maintains the contribution accounts totaling \$1,677,981 as of June 30, 2025 and Lincoln maintains the contribution account totaling \$2,806,145 as of June 30, 2024. The accounts are credited with earnings on underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 4 percent. The crediting rate is reviewed on a quarterly basis for resetting. The Empower account does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the fully benefit-responsive investment contract criteria, and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by the participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported by the Plan, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due are related to the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, (5) premature termination of the contract. No events are probable of occurring which would limit the Plan's ability to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

Note 8 – Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note 9 – Tax Status:

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (Code). The IRS has determined and informed the Organization by a letter dated November 14, 2022, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRS and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRC. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2025, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress. The Plan has not been examined by the Internal Revenue Service for open years under the Statute of Limitations.
