### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Cambridge University Press Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by qualified institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).



### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ### ***Responsibilities of Management for the Financial Statements***

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

## Notes to Financial Statements

---

### 1. Description of Plan

#### *General*

The following description of the Cambridge University Press Retirement Plan (the Plan), a defined contribution 401(a) plan, provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions. On December 1, 1993, Cambridge University Press established the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). In August 2021, Cambridge University Press merged with Cambridge Assessment, a non-teaching department of the University of Cambridge. The new name of the organization is Cambridge University Press & Assessment (the Company or Employer).

Effective February 1, 2023, the Plan was frozen to new participation in the Plan.

#### *Eligibility*

All full-time employees who are 21 years of age and have completed one year or over 1,000 hours of service are eligible to participate in the Plan. Participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Plan does not permit employee deferrals.

#### *Employer Contributions*

Each year the Company will contribute 5% of each eligible participant's before-tax compensation, as defined (the Non-Elective Contribution).

For each participant who makes salary reduction contributions pursuant to the terms of the Cambridge University Press Tax Deferred Annuity Plan (the TDA Plan), which is also sponsored by the Company, the Company will contribute a matching contribution to this Plan. The Company's matching contribution is equal to 100% of the first 5% of compensation on which deferrals have been made by the participant (the Matching Contribution).

In addition, the Company may make additional matching contributions or qualified matching contributions at its discretion.

For the year ended December 31, 2024, the Employer recorded \$651,970 in non-elective contributions and \$556,552 in matching contributions.

#### *Participant Accounts*

The Plan is a participant-directed account plan. Participants direct the investment of contributions made on their behalf into various investment options offered by the Plan. Participants' accounts are credited with Employer contributions and rollovers. Plan earnings and administrative expenses are allocated based upon a participant's account balance in proportion to the balances of all participants' accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested accounts.

### ***Vesting***

Participants with a start date prior to May 15, 2003 are 100% vested in their Employer contribution account in this Plan. Participants with an employment date on or after May 15, 2003 become vested 100% after three years of service. An active participant will become 100% vested upon attainment of the age of 65 or upon the death of the participant.

### ***Investment Options***

Contributions are invested by the Teachers Insurance and Annuity Association (TIAA) and College Retirement Equity Fund (CREF) according to the options elected by the participants. All Employer contributions are directed by the participant among the available investment options. Investment earnings are automatically reinvested into the fund or portfolio from which they were derived.

### ***Payment of Benefits***

Upon termination of service due to death, disability, or retirement, a participant or beneficiary may elect to purchase an annuity contract equal to the value of the participant's account to receive monthly annuity payments or receive a lump-sum distribution. Upon termination of service due to anything other than disability, retirement, or death, a participant will receive a lump-sum distribution.

### ***Forfeited Accounts***

Forfeitures may be used to reduce Employer contributions. The balance of forfeited accounts was \$121,134 and \$107,487 at December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, \$7,950 was forfeited by withdrawing participants and the forfeiture account earned \$5,697 in income.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

### ***Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Payment of Benefits***

Benefits are recorded when paid.

### *Investment Valuation and Income Recognition*

The investments of the Plan are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The Plan presents in the statement of changes in net assets available for benefits the net appreciation in the fair value of its investments, which consists of realized gains and losses and the unrealized appreciation (depreciation) of investments bought and sold, as well as held during the year.

### *Investment Management Fees and Operating Expenses*

Investment management fees and operating expenses charged to the Plan for investments in the various funds are deducted from income earned on a daily basis.

### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

### *Due to Affiliated Plan*

During the year ended December 31, 2024, Plan management remitted a contribution to this Plan that should have gone to an affiliated plan, the Cambridge University Press & Assessment Tax Deferred Annuity Plan. This was corrected and paid back to the affiliated plan during the year ended December 31, 2025.

## **3. Fair Value Measurements**

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes to the valuation methodologies used at December 31, 2024 and 2023.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual Funds* - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*CREF Variable Annuity Contracts* - These separate accounts are registered investments offered through variable annuity contracts issued by CREF that invest principally in equity securities, fixed-income instruments, and short-term investments in accordance with each portfolio's investment objectives. Units held in the registered investments are valued at NAV and published daily on NASDAQ. The NAV is measured based on the fair value of the underlying investments held by the fund less its liabilities. The fair value of the underlying investments is determined using market quotations or prices obtained from independent pricing sources that may employ various pricing methods to value the investments, including matrix pricing. Money market account holdings are generally valued at amortized cost. On a daily basis, units in the registered investments are revalued to reflect performance of the underlying investments minus any fees and charges. Redemption may be made daily without restriction. There are no unfunded commitments.

*Guaranteed Annuity Contracts (non-benefit responsive)* - The non-fully benefit-responsive (TIAA-NBR) fixed annuity contracts, composed entirely of the TIAA Traditional Annuity Contracts, are reported at fair value. Fair value is determined using a discounted cash flow model. The TIAA Traditional Annuity Contracts are not available for sale or transfer on any security exchange. The fixed annuity contracts are subject to various restrictions.

*TIAA Real Estate Pooled Separate Account* - The TIAA Real Estate Pooled Separate Account (REA) generally invests in real estate properties and real estate-related investments. The REA's value is principally derived from the market value of the underlying real estate holdings or other real estate-related investments. Real estate holdings are valued principally using external appraisals, which are estimates of property values based on a professional's opinion. The REA sometimes holds securities as well. The unit value of the REA is published on NASDAQ; however, the REA is not publicly traded. The value of the underlying real estate properties is determined by an external appraisal on a periodic basis, which is an estimate based on professional opinions. The value of the underlying investments in the registered investment companies and securities is based on the daily value of the underlying registered investment companies and securities on an open market. There are restrictions on the trading and withdrawals of funds from this investment; generally, transfers out can be executed on any business day but may be limited to once per calendar quarter. Other limited exceptions may also apply. There are no unfunded commitments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

During 2024, total purchases and sales of the TIAA Traditional Non-Benefit Responsive Contracts were \$164,258 and \$539,853 respectively. During 2023, total purchases and sales of the TIAA Traditional Non-Benefit Responsive Contracts were \$107,167 and \$265,594, respectively.

The Plan had no financial assets that were measured at fair value on a nonrecurring basis during the year ended December 31, 2024 and 2023.

## **4. Certified Investments**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule related to investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA and CREF, qualified institutions.

## **5. Tax Status**

The Plan obtained the latest determination letter on May 5, 2015, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **6. Risks and Uncertainties**

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

### **7. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right at any time to terminate the Plan, in accordance with ERISA, by delivering to the custodian and third-party administrator written notice of such termination. Upon termination of the Plan, no further contributions will be made to the Plan and all amounts credited to participants' accounts will become fully vested.

### **8. Related Party/Party-in-Interest Transactions**

Certain Plan investments are shares in fund accounts that are managed by TIAA and CREF, the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

### **9. Subsequent Events**

The Plan has evaluated subsequent events through December 23, 2025, which is the date the financial statements were available to be issued. No subsequent events that would require disclosure in these financial statements have been noted as of this date.
