Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the WyoTech 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Note 1: Description of the Plan

The following description of the WyoTech 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of DBJJDM Enterprises LLC dba WyoTech (the Company). All Company employees are eligible to participate in the Plan if they meet the requirements of completing three consecutive months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was a part of the Management Solutions 401k Plan (MSP Plan), a multi-employer plan. During November 2024, the plan assets from MSP Plan were transferred to the WyoTech 401(k) Profit Sharing Plan, as described in Note 9.

Contributions

Each year, participants may contribute up to the federal maximum of pre-tax annual compensation as defined by the Plan. Participants may make pre-tax deferral or Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit or contribution plans. The Company may make a discretionary matching contribution by matching the participant's contribution equal to a uniform percentage of the participant's salary deferrals determined by the Company. The Company may also make a employer non-elective contributions. For the year ended December 31, 2024, the Company elected to make discretionary matching contributions of \$44,581. During the year ended December 31, 2024, the Company did not elect to make any employer non-elective contributions.

Effective January 1, 2025, the Plan was amended to include "safe harbor" matching contributions, as described in Note 10.

Effective January 1, 2025, the Plan includes an automatic enrollment feature under which participants are enrolled at a 3% pre-tax deferral rate in the first year of participation. Beginning in the second year, the automatic deferral rate increases by 1% each year until reaching 10% in the ninth year of participation, as noted in Note 10.

Participant Accounts

Each participant's account is credited/debited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings/losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1: Description of the Plan, Continued

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants vest in the Company's discretionary matching and employer non-elective contributions plus actual earnings thereon based on years of continuous service. A participant vests 25% each year and is 100% vested in Company contributions after four years of credited service.

Effective January 1, 2025, participants vest 50% each year and become 100% vested in safe harbor matching contributions after two years of credited service.

Investment Options

The Plan provides participants with various investment options including several mutual funds and a guaranteed interest account. Plan participants may direct the change of their investment options.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum equal to \$1,000 and a maximum equal to the lesser of \$50,000 or 50% of the vested interest in their account. The transactions are treated as a transfer to (from) the investment fund from (to) the participant notes receivable. Notes receivable from participants terms range from one to five years or more for the purchase of a primary residence. The notes receivable are secured by the balance in the participant's account and bear a reasonable rate of interest. Principal and interest is paid ratably through payroll deductions. An outstanding note receivable can be paid in full at any time and participants may have no more than two notes receivable outstanding at any time. Only fully vested participants in the Plan can enter into loans.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, annual installments, or deferment over a period not exceeding the participant's age of 59 ½. For termination of service due to other reasons, a participant may receive or rollover into a qualified plan the value of the vested interest in his or her account as a lump-sum distribution, net of tax withholdings, if applicable. The Plan allows for in-service withdrawals by participants who have attained the normal retirement age of 59 ½. A participant may also receive hardship withdrawals, subject to certain limitations, as defined in the Plan document.

Forfeitures

Forfeitures are made available to pay any administrative expenses and reduce employer contributions. During the year ended December 31, 2024, no forfeitures were used to reduce employer contributions or administrative expense.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants

Notes receivable are reported at their unpaid principal balances plus any accrued, but unpaid interest. Delinquent participant notes receivable are reclassified as distributions based on the terms of the Plan document.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Plan Administrative Expenses

Administrative expenses are paid by the Company. Certain administrative processing fees are charged to the participants and therefore, are reflected in the accompanying statement of changes in net assets available for benefits as administrative expenses.

Note 3: Information Certified by the Plan's Trustees (Custodians)

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by Empower Annuity Insurance Company of America and Empower Trust Company, LLC (Empower), the Plan's trustees (custodians) and was not subjected to any auditing procedures by the independent public accountants:

- Investments as shown on the statement of net assets available for benefits as of December 31, 2024.
- Net depreciation in fair value of investments for the year ended December 31, 2024, as included on the statement of changes in net assets available for benefits.
- The schedule of assets held for investment purposes (held at end of year) as of December 31, 2024, as shown on Schedule H, Line 4i.

At the request of the plan administrator, the Plan's independent certified public accountants did not perform procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule. All other information has been audited in accordance with auditing standards generally accepted in the United States of America.

Note 4: Fair Value Measurement

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). There are three levels of the fair value hierarchy under FASB ASC 820. Level 1 inputs are quoted market prices in active markets for identical investments that the Plan has the ability to access at the measurement date. Level 2 inputs are inputs other than quoted market prices included within Level 1 that are observable for the Plan's investments, either directly or indirectly. Level 3 inputs are unobservable inputs for the Plan's investments.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Note 4: Fair Value Measurement, Continued

The following is a description of the valuation methodologies used for the investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Registered investment companies - These investments are valued at quoted market prices in an exchange and active market, which represents the fair value of the shares held by the Plan at year end and the Plan has concluded that these investments should be classified as Level 1.

Guaranteed Interest Account - This investment is valued at fair value by the insurance company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer. Because the participants transact at contract value, fair value is determined annually for financial statement reporting purposes only. In determining the reasonableness of the methodology, an evaluation of a variety of factors including a review of existing contracts, economic conditions, industry and market developments, and overall credit ratings is performed by the plan administrator. Certain unobservable inputs are assessed through review of contract terms (for example, duration or payout date) while others are substantiated utilizing available market data (for example, swap curve rate) and the Plan has concluded that this investment should be classified as Level 2.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan has concluded that its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5: Parties-in-interest Transactions

Certain Plan investments are managed by Empower. Empower is the trustee (custodian) as defined by the Plan and is a party-in-interest. Ascensus Inc. is the record-keeper and the administrative provider for the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net depreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. The Company pays any other fees related to the Plan's operations.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in all of their employer contributions.

Note 7: Tax Status

Effective January 1, 2024, the Plan adopted an Ascensus Services, Inc. Non-Standardized Defined Contribution Pre-Approved Plan that the Internal Revenue Service (IRS) adopted by a letter dated June 30, 2020. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRS and therefore believes that the Plan is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and believes there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9: Plan Transfer

The Company established the Plan effective January 1, 2024. In October 2024, the Plan entered into a spin-off and transfer agreement with MSP Plan, a multi-employer plan. During November 2024, the assets held in the MSP Plan were transferred to the Plan. The transferred net assets have been recognized in the accounts of the Plan as of November 2024, as their balances as previously carried in the accounts of the MSP Plan.

Note 10: Subsequent Events

Effective January 1, 2025, the Plan was amended to allow for “safe harbor” matching contributions.

Effective January 1, 2025, the Plan includes an automatic enrollment feature under which participants are enrolled at a 3% pre-tax deferral rate in the first year of participation. Beginning in the second year, the automatic deferral rate increases by 1% each year until reaching 10% in the ninth year of participation.
