- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTE A - DESCRIPTION OF THE PLAN

The accompanying financial statements and supplemental schedule are those of the New York City Ballet, Inc. 403(b) Plan (the "Plan"), and users of these financial statements and supplemental schedule are directed to the independent auditors' report on pages 1 through 4. Likewise, the brief description of the Plan contained herein is provided solely for the purposes of general information, and interested persons should refer to the Plan agreement for a more complete description of the Plan's provisions. A copy of the Plan agreement can be obtained from the New York City Ballet, Inc. ("City Ballet"), which is the administrator of the Plan.

[1] General:

The Plan is a participating-employer, defined-contribution plan designed to meet the requirements of Section 403(b) of the Internal Revenue Code (the "Code") and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Plan covers all eligible employees of City Ballet.

For 2024 and 2023, Lincoln Financial Group Trust Company, Inc. ("Lincoln") served as recordkeeper and custodian of the Plan.

[2] Eligibility for participation:

Employee elective deferrals: Employees are eligible to participate in and contribute to the Plan as soon as administratively feasible upon their hiring. However, certain employees may be excluded from participation if they fall within the specific categories for exclusion as listed in the Plan agreement.

Employer contributions: Any full-time employee (with 1,000-plus hours each year) with one or more years of service is eligible to receive employer contributions. Certain employees may be excluded from participation, however, if they fall within the specific categories for exclusion listed in the Plan agreement.

[3] Contributions:

Employee elective deferrals: Participants may elect to contribute, as a pre-tax or Roth deferral, up to 100% of their annual eligible compensation, subject to limitations as provided in the Internal Revenue Code. "Catch-up" contributions are permitted under the Plan if a participant attains the age 50 before the end of the Plan year, thus becoming eligible to make a catch-up contribution in an amount up to \$7,500 for the year ended December 31, 2024. In no event may a participant's pre-tax and Roth contributions exceed any statutory limitations. Participants may also rollover contribution amounts representing distributions from other qualified defined-benefit or defined-contribution plans.

Employer contributions: The employer can elect to make discretionary contributions. The employer elected to contribute 3% of employee's eligible compensation to all eligible employees for the year ended December 31, 2024.

Participants direct the investment of participant and employer contributions.

[4] Participant accounts:

The activity in each participant's account includes: (i) the participant's contributions, (ii) allocations of employer contributions, (iii) benefit payments or withdrawals, and (iv) allocations of the earnings or losses on Plan assets, and are charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, eligible compensation or specific transactions, as defined in the Plan.

NOTE A - DESCRIPTION OF THE PLAN (CONTINUED)

[5] Vesting:

All participant contributions to the Plan are vested immediately when made, as are actual earnings thereon. All employer contributions, plus actual earnings to date, are vested after three years of service.

[6] Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred. A participant may borrow directly from assets within his or her mutual fund accounts, at a minimum of \$1,000 and at a maximum equal to the lesser of \$50,000, or 50%, of his or her deferral or rollover contributions and earnings thereon. Loan terms range from one to five years; however, terms may exceed five years up to 20 years for the purchase of a primary residence. Loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Interest rates on outstanding loan balances range from 4.25% to 9.50% at December 31, 2024 and 2023. Principal and interest are paid monthly or quarterly ratably through payroll deductions. As of December 31, 2024 and 2023, loans to participants of approximately \$384,000 and \$372,000, respectively, were outstanding.

[7] Payment of benefits:

Participants, alternate payees, or beneficiaries of the Plan may receive a distribution of their vested employee and employer contributions upon death, disability, reaching the age of 59½, early retirement, normal retirement, hardship, or termination of employment.

A participant may elect a lump-sum amount, installment payments, or annuity payments depending on (i) how the benefits are invested, (ii) the participant's marital status, and/or (iii) the elections made by the participant or his or her spouse, if any. For termination of service due to other reasons, a participant will receive the value of the vested interest in his or her account as a lump-sum distribution as of the most recent valuation date.

Effective January 1, 2025, terminated balances less than \$5,000 individually shall be disbursed on behalf of the participant or their designated beneficiary, by way of a direct rollover, as determined by the Plan's administrator.

[8] Plan termination:

Although they have not expressed any intention to do so, the Plan administrator has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the accrued benefit of each participant would become 100% vested.

[9] Forfeitures:

Forfeited non-vested accounts may be used to reduce future employer contributions or to pay Plan expenses. At December 31, 2024, forfeited non-vested accounts, totaled approximately \$600. Forfeited non-vested accounts amounting to approximately \$14,000 were used to pay Plan expenses or reduce employer contributions during 2024. At December 31, 2023, forfeited non-vested accounts, totaled approximately \$4,600.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

[1] Basis of accounting:

The accompanying financial statements and supplemental schedule have been prepared using the accrual method of accounting.

Investments held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

[2] Investment valuation and income recognition:

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Participants may direct their contributions, as well as the employer contributions, into three investment alternatives: (i) fixed annuity contracts, (ii) funds held with registered investment companies (see Notes D and E for further discussions concerning each of these investment alternatives), and (iii) self-direct brokerage account.

[3] Payment of benefits:

Benefits are recorded when paid.

[4] Plan expenses:

All expenses incurred with the administration of the Plan are paid by the Plan and allocated to Plan participants, with the exception of participant loan fees and individual advisory fees, which are a direct cost to the affected participant.

[5] Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Plan administrator to make estimates and assumptions that affect (i) the reported amounts of net assets available for benefits at the date of the financial statements, (ii) the changes in net assets available for benefits during the reporting period, and (iii) when applicable, the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

[6] Income taxes:

The Plan has adopted a Volume Submitter 403(b) Plan sponsored by Lincoln Retirement Services Company LLC. On March 31, 2017, the Internal Revenue Service ("IRS") stated in an advisory letter that the Volume Submitter adopted by the Plan, as then designed, was in compliance with applicable requirements of the Code and therefore, the related accounts are exempt from taxation. The Plan has been amended since receiving the letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, the Plan administrator believes that the Plan is qualified and the related accounts are tax-exempt.

U.S. GAAP requires the Plan's administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

[7] Subsequent events:

The Plan has evaluated subsequent events through October 10, 2025, the date on which the financial statements were available to be issued.

NOTE C - INVESTMENT CERTIFICATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Lincoln has certified the completeness and accuracy of all investments and related investment activity and notes receivable from participants and related activity in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE D - INVESTMENTS AND FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; or (4) inputs that are derived principally from, or corroborated by, observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE D - INVESTMENTS AND FAIR VALUE MEASUREMENTS (CONTINUED)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies consist of a variety of mutual funds. These funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Other - self-directed brokerage account consists of a variety of equity securities. These equity securities are valued at the closing price reported on the active market on which the individual securities are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan administrator believes the Plan's valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial-instruments could result in a different fair value measurement at the reporting date.

Changes in Fair Value Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

NOTE E - INVESTMENTS AT CONTRACT VALUE

Lincoln NY Fixed Annuity Account (the "Annuity Fund") is a group fixed-rate guaranteed annuity offered by Lincoln National Life Insurance Co. ("Lincoln Insurance"). Contributions to the Annuity Fund purchase a contractual or guaranteed amount of future benefits for participants. The guarantees and returns of the Annuity Fund are backed by Lincoln Insurance's claims-paying ability. Liquidity restrictions apply to the Annuity Fund under certain types of annuity contracts. When the accumulation is converted to an annuity based on life expectancy, the present value of the stream of payments is equal to the accumulation. The guaranteed annual interest rate for the Annuity Fund is 3.5% for all premiums remitted under the Annuity Fund accumulating contracts. The crediting interest rate is calculated on a daily basis. The Annuity Fund is fully benefit-responsive and is reported at contract value. The contract issuer reserves the right to delay distribution up to six months after request is made.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Code or the failure of the trust to be tax-exempt under Section 501(a) of the Code;
2. Premature termination of the contracts;
3. Plan termination or merger;
4. Changes to the Plan's prohibition on competing investment options; or
5. Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines;
2. A breach of material obligation under the contract;
3. A material misrepresentation; or
4. A material amendment to the agreements without the consent of the issuer.

As of December 31, 2024 and 2023, there were no events probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

NOTE F - RISK AND UNCERTAINTIES

The Plan's investments are included in various investments. Investment securities are exposed to various risks, such as interest-rate, market, credit, liquidity and market-perception risks, as well as risk related to the financial strength of Lincoln Insurance as issuer of the Annuity Fund. Due to the level of risk associated with any investment, it is at least reasonably possible that changes in the values of the Plan's investments will occur in the near term, and that such changes could materially affect the participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuations of investments at December 31, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.

NOTE G - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Under ERISA, a "party-in-interest" is any person or entity who provides services to a plan or its participants, and ERISA prohibits a variety of specified transactions that might occur between a party-in-interest and the plan or its participants. Lincoln provides investment-management services, trustee, and recordkeeping services for the Plan, and investments include a group annuity contract issued by Lincoln Insurance, an affiliate of Lincoln. Therefore, transactions related to those services and contracts qualify as party-in-interest transactions. For the year ended December 31, 2024, the Plan paid fees of \$204,391. The Plan also pays accounting and investment advisory fees. As service providers to the Plan, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to these service providers were \$57,106 for the year ended December 31, 2024. Additionally, certain administrative functions are performed by the officers and employees of City Ballet (who may also be participants in the Plan), at no cost to the Plan.

The custodian provides certain administrative services to the Plan and receives revenue from mutual fund providers for services the custodian provides to the funds. This revenue is used to offset certain amounts owed to the custodian for its administrative services to the Plan. If the revenue received by the custodian from such mutual fund service providers exceeds the amounts owed the custodian remits the excess to the Plan pursuant to the service agreement. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants, depending on the Plan's provisions. During 2024, \$188,916 was received and is included in other income in the statement of changes in net assets available for benefits. Also, during 2024, the Plan expense account was used to pay \$141,188 of professional services expenses. At December 31, 2024 and 2023, there was a remaining balance in the Plan expense account of \$101,184 and \$53,456, respectively.

NOTE H - MUTUAL FUND FEES

Investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads, or Section 12b-1 fees, which are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940 and are annual fees deducted to pay for the marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity and are therefore not separately identifiable as an expense.
