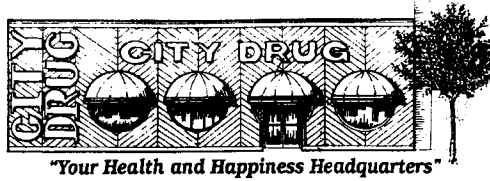

Sirs:

We are filing our 2024 form 5500-SF late after being notified by you. Our plan ended December 2023 and our participants transferred their accounts to other plans shortly after. Our Empower Plan had us file the 5500 form for 2023 in the spring of 2024 and we were not made aware that we needed to file the 2024 Form 5500. As we no longer used Empower to provide us services we did not contact them. Empower did provide a 2024 Form 5500-SF, but through miscommunication we were not notified that it was ready and needed to be filed. I was provided with a form 5500-SF for 2024 today, but Empower could only send me a PDF format. I could not successfully convert the PDF to the XML format so I am sending the create the pdf program as EFAST.

We apologize for the late submission of the form 5500-SF. Again the reason is we had thought our 2023 Form 5500-SF was the last form required. We ask for reduction in penalties as we have missed the filing due to not understanding that a 2024 Form 5500-SF was required.
