Dear Bruce & Dalton:

Except as discussed in the following paragraph, in planning and performing my audit of the financial statements of the Quality Consulting, Inc. 401K Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as of and for the year ended December 31, 2024, in accordance with auditing standards generally accepted in the United States of America, I considered the Plan's internal control over financial reporting (internal control) as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of issuing my report on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, I do not express an opinion on the effectiveness of the Plan's internal control.

I was engaged to perform an ERISA Section 103(a)(3)(C) audit of those financial statements as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. As permitted by ERISA Section 103(a)(3)(C), my audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by Ascensus Trust Company that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. My audit also did not include a consideration of internal control relating to the investment information.

My consideration of internal control was for the limited purpose described in the preceding paragraphs and was not designed to identify all deficiencies in internal control that might be material weaknesses or significant deficiencies and, therefore, material weaknesses or significant deficiencies may exist that were not identified. However, as discussed below, I identified certain deficiencies in internal control that I consider to be significant deficiencies.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis. A material weakness is a deficiency, or a combination of deficiencies in internal control, such that there is a reasonable possibility that a material misstatement of the Plan's financial statements will not be prevented, or detected and corrected, on a timely basis. I did not identify any deficiencies in internal control that I consider to be material weaknesses.

A significant deficiency is a deficiency, or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance. I discuss this in more detail below.

Significant Audit Findings Regarding Financial Statements and Internal Control

Qualitative Aspects of Accounting Practices

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Plan are described in Note 2 to the financial statements. No new accounting policies were adopted, and the application of existing policies was not changed during 2024. I noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Difficulties Encountered in Performing the Audit

I encountered no significant difficulties in dealing with QCI management in performing and completing my audit. I did, however, encounter a number of problems with the quality of the preparation of the accounting information and Form 5500 this year, and the records of Ascensus, which I discuss in further detail below.

Corrected and Uncorrected Misstatements

Professional standards require me to accumulate all known and likely misstatements identified during the audit, other than those that are trivial, and communicate them to the appropriate level of management. As in prior years since 2018, there were errors noted in Ascensus accounting information, such as the fact that they were unable to provide an accurate accounting of deferrals and other information per employee, which matched the totals of items reported on their accounting records and Form 5500, in a timely manner. Ascensus was also very slow to have even the most basic audit documentation ready in a timely manner, and often completely ignored emails for weeks at a time, even after supervisors were copied on such requests. They also again had multiple errors on the initial drafts of Form 5500, and were very slow in acknowledging this, explaining why this occurred, or correcting the errors.

Disagreements with Management

For purposes of this letter, professional standards define a disagreement with management as a financial accounting, reporting, or auditing matter, whether or not resolved to my satisfaction, that could be significant to the financial statements or the auditor's report. I am pleased to report that no such disagreements arose this year.

Management Representations

I have requested certain representations from management that are included in the management representation letter dated September 22, 2025.

Internal Control Issues

I did not discover any weaknesses in internal control by management, although it did appear that Ascensus has minor problems with internal control regarding Form 5500 preparation, and with accounting for forfeitures and suspense account amounts. Nevertheless, I am allowed to rely upon the SSAE 16/SOC 1 report received by Ascensus documenting that its controls are sufficient, and can be relied upon in an audit of this type.

Communication of Significant Deficiencies

My consideration of internal control was for the limited purpose described in the preceding paragraphs and was not designed to identify all deficiencies in internal control that might be significant deficiencies or material weaknesses and, therefore, there can be no assurance that all such deficiencies have been identified. However, as discussed below, I identified two deficiencies in internal control, each of which I consider to be a significant deficiency.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct misstatements on a timely basis. A material weakness is a deficiency, or combination of deficiencies in internal control, such that there is a reasonable possibility that a material misstatement of the plan's financial statements will not be prevented, or detected and corrected on a timely basis. I did not identify any deficiencies in internal control that I consider to be material weaknesses.

A significant deficiency is a deficiency, or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance. I consider the following deficiencies in the Plan's internal control to be a significant deficiency:

- Lack of appropriate segregation of duties involving the CFO and the Accountant.

Other Audit Findings or Issues

I generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditor. However, these discussions occurred in the normal course of my professional relationship and responses were not a condition to my retention of this work.

Since by the time the audit started, Mike Davidson had left QCI, I obtained much of my initial information from Andrew Howe. Those items included information that seemed to indicate that QCI in recent years has been employing personnel that are physically located in states other than the two states in which QCI currently files corporate income tax returns, something I had not previously been informed of. The presence of those employees in those other states could potentially require QCI to file additional income and/or other types of returns in those states. If you would like to discuss further, please contact me.

Based upon seven past years of continuing errors, difficulty in communicating with Ascensus personnel directly responsible for accounting and Form 5500 preparation, difficulty in obtaining requested reports and information from Ascensus, and obtaining that information in a timely manner without having to constantly follow-up with multiple requests reminding them I still need the information already requested more than once, you have decided to change third party administrators to the Principal Financial Group, effective in May of 2025. That means the 2025 audit will be more complicated, since I have to deal with multiple administrators and reports, but after 2025 things should significantly improve.
