INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of
I.B.E.W. Local 607
Health and Welfare Fund

Opinion

We have audited the accompanying financial statements of I.B.E.W. Local 607 Health and Welfare Fund, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of May 31, 2025 and 2024, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and benefit obligations of I.B.E.W. Local 607 Health and Welfare Fund as of May 31, 2025 and 2024, and the changes in its net assets available for benefits and changes in its benefit obligations for the years then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

NOTES TO THE FINANCIAL STATEMENTS**

1. Description of the Fund

The I.B.E.W. Local 607 Health and Welfare Fund (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General- The Plan provides health and death benefits covering all eligible participants in the member labor organizations. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Benefits- The Plan provides various health and welfare benefits, such as hospitalization, medical, surgical, major medical, prescription drug, death, accidental death and dismemberment, loss-of-sight, disability, vision care and dental benefits.

The Plan is insured for medical and prescription, death, accidental death and dismemberment, loss-of-sight, and vision benefits. These benefits are guaranteed through contracts issued by an insurer. The Plan is self-insured for disability and dental benefits.

Participants that have a dollar bank in excess of \$20,000 may be reimbursed for certain noncovered medical expenses and supplementary Medicare or Medicare Advantage premiums.

Eligibility- Employees of a Union employer who have been actively employed for a minimum of 1,000 hours from the date of first employment are eligible to participate in the Plan. Continued eligibility is contingent upon the completion of 144 hours of covered employment per month.

If participants are credited with contributions in excess of the minimum required for eligibility, the excess hours are credited to a benefit credit account to provide extended benefits.

If there are not sufficient dollars in the health and welfare bank, participants may maintain their eligibility by making self-contributions.

Economic Hardship Eligibility- To the extent the Trustees determine that the Fund's assets are sufficient, the Trustees may provide benefits for individuals who are on work layoff and cannot find work opportunities due to economic conditions. Eligibility for this supplemental coverage is contingent upon the participant's hour bank being fully exhausted and the member actively seeking employment within the Local 607 jurisdiction. (See Note 8)

Benefit Obligations- There are no postemployment benefits for retirees. The fund has separated them as a discrete group and the retirees pay the entire cost of the benefits provided.

Plan Termination- The Plan's Board of Administration has the right under the Plan to modify the benefits provided to employees. The Plan may be terminated only by joint agreement between the employer and the union, subject to the provisions set forth in ERISA. Upon dissolution or termination of the Plan, the administrator shall continue to pay the expenses and provide the benefits in effect to all eligible employees, beneficiaries, and dependents until the Plan's assets are exhausted.

NOTES TO THE FINANCIAL STATEMENTS

2. Summary of Significant Accounting Policies

Basis of Accounting- The accompanying financial statements are prepared on the accrual basis of accounting.

Employers' Contributions- The Plan is being funded by employer contributions pursuant to a collective bargaining agreement. Employer contributions are computed on the basis of hours worked reported by participating employers multiplied by the current contractual employer contribution rate. Contributions are included in income during the period in which the work is performed. The receivable represents uncollected contributions at May 31, 2025 and 2024. The current agreement between the Union and the employers provides for hourly contributions of \$15.25 for each hour worked by a participating member.

Use of Estimates- The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition- Investments are reported at fair value. Fair value is the price that would be received to see an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation included the Fund's gains and losses on investments bought and sold as well as changes in the market value of assets held through the end of the year.

Reciprocal Contributions, Payments and Agreements- Reciprocal contributions represent payments received from other local health and welfare plans for work performed by plan participants out of the local union's area of operation. Reciprocal payments represent contributions received by participating employers for members of other local unions that are paid to other local benefit plans.

The benefit fund of each local enters into a cooperative contractual arrangement to allow the contributions to be transferred to the employee's home benefit fund. The agreement determines the amount of contributions that will be transferred to or from the benefit fund. The participant must sign an authorization to transfer the contributions to the participant's home benefit fund.

Accumulated Eligibility Credits- The Plan is required to provide future benefits to certain active and retired members, if such members have accumulated in the current or prior years credit amounts (expressed in dollars) for hours worked in excess of the hours required for current coverage. Actual dollar amounts will be credited to members' accounts each month based on the number of dollar bank credits accumulated.

When the health & welfare dollar bank reserves reach \$20,000 the excess is moved into the Benefit Account Balance. The money in the Benefit Account Balance can be used to cover certain noncovered medical, dental and vision expenses. Also, it can be used to cover 50% of Medicare and Medicare Advantage premiums.

Subsequent Events – The Plan Administrator has evaluated subsequent events through the date the financial statements were available to be issued.

3. Fair Value Measurements

Financial Accounting Standards Board (“FASB”) *Accounting Standards Codification* (“ASC”) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets, that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets.
- quoted prices for identical or similar assets or liabilities in inactive markets.
- inputs other than quoted prices that are observable for the asset or liability.
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at May 31, 2025.

Money Market: Valued at carrying amount of shares in the money market fund held by the Plan.

Mutual Funds: Valued at the quoted prices on active markets for identical investments based on the net asset value (NAV) of shares held by the Plan at year end.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Risks and Uncertainties

Investment Risk- The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statement of net assets available for benefits.

Credit Risk- The Plan maintains bank accounts with financial institutions. These accounts are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. There were times during the Plan year when cash exceeded the federally insured limit. At May 31, 2025, the balance in accounts exceeded the federally insured limit by approximately \$187,000.

5. Tax Status

The trust established under the Plan to hold the Plan's assets is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code and, accordingly the Trust's net investment income is exempt from income taxes. The trust has obtained a favorable tax exemption letter from the Internal Revenue Service, and the Plan sponsor believes that the trust and the Plan as amended, continue to qualify and operate in accordance with applicable provisions of the Internal Revenue Code.

5. Tax Status (Continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

6. Transactions with Parties-in-Interest and Related Parties

Certain Plan investments are shares of money market funds managed by Wilmington Trust. Wilmington Trust is the custodial trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Direct Fees paid by the Plan for investment custodial services were \$418 and \$124 for the years ended May 31, 2025 and 2024, respectively.

Fees paid during the year for legal, accounting, and other professional services rendered by parties-in-interest were based on customary and reasonable rates for such services.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

8. Plan Amendments and modifications

Effective January 1, 2025, medical deductibles were increased to \$2,500/\$5,000 (in network/out of network) and prescription co-payments were increased to 20% of the drug cost.

Effective January 1, 2025, the Economic Hardship eligibility provisions of the Plan was eliminated.

Effective January 1, 2025, each hour worked in the jurisdiction of another IBEW Local Union will reciprocate for eligibility at the IBEW Local 607 rate.
