**Scope and nature of the ERISA Section 103(a)(3)(C) audit**

We have performed audits of the financial statements of Chapman and Cutler LLP Salary Deferral Plan for Partners and Support Staff (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **NOTES TO FINANCIAL STATEMENTS**

**December 31, 2024 and 2023**

**NOTE A - DESCRIPTION OF THE PLAN**

***General***

The Chapman and Cutler LLP Salary Deferral Plan for Partners and Support Staff (the “Plan”) is a defined contribution plan established on January 1, 1982, by Chapman and Cutler LLP (the “Partnership”), an Illinois limited liability partnership. The Chapman and Cutler Master Trust (the “Master Trust”) was adopted by the Partnership to administer all Partnership plans qualified under Section 401(a) of the Internal Revenue Code (“IRC”).

The Plan is subject to the reporting requirements of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The retirement plan administration committee of the Partnership is responsible for the administration and interpretation of the Plan and the Master Trust.

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

***Participation***

Partners and non-attorneys are eligible to participate on the latter of the first day of the month following date of hire and attainment of age 21.

***Contributions and Vesting***

Contributions are made by each Plan participant who elects to contribute by reduction of his or her distributive share or salary. The contribution to the Plan was limited to \$23,000 for the year ended December 31, 2024. Moreover, the maximum amount that may be contributed by or on the behalf of a participant for any year pursuant to a distributive share or salary reduction election, together with other contributions to any other Partnership retirement plan, is subject to certain limitations. Plan participants may also elect to contribute amounts to their Roth account. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Each participant is 100% vested in all contributions made to his or her account, and his or her balance may not be forfeited for any reason. Non-partner employees will be automatically enrolled in the Plan at a 5% pretax contribution rate unless the employee elects a higher or lower pretax contribution rate or declines participation in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers).

Participants may fully direct their account balances into various investment options offered by the Plan through the Master Trust.

The participant contributions are not subject to matching contributions from the Partnership.

***Participant Accounts***

Each participant’s account is credited with the participant’s contributions and an allocation of the Plan’s earnings or losses. Allocations of earnings and losses are based on participant account balances, as defined. Certain Plan administrative expenses are charged to the account of the participant to which they relate.

***Payment of Benefits***

Benefits under the Plan become payable upon attainment of the normal retirement age of 62, death, disability or termination of employment.

The distribution at retirement will be a qualified joint and survivor annuity unless that form of benefit is waived by the participant and eligible spouse. If waived, the account balance will be paid either in a lump sum or in the form of substantially equal annual installments over a period not exceeding the participant's and his or her beneficiary's joint life expectancy.

***Notes Receivable from Participants***

Loans are available to participants in the Plan for certain specified purposes. A participant may borrow the lesser of \$50,000 or 50% of his or her vested account balance, with a minimum loan amount of \$1,000. A participant may not have more than two loans outstanding. The loans are secured by the balance in the participant's account. Principal and interest are repayable through payroll deductions over periods of up to 120 months for loans made for the purchase of a primary residence and 60 months for loans made for other purposes. Interest is charged at an interest rate of Prime plus 1% and is fixed over the life of the note.

***Transfer from Other Plan***

Due to changes in employment classification, certain participant accounts were transferred from the Chapman and Cutler LLP Salary Deferral Plan for Attorney Employees, another Partnership-sponsored plan, which also participates in the Master Trust.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

The Plan's investments are commingled with funds from the Chapman and Cutler LLP Retirement Plan and the Chapman and Cutler LLP Salary Deferral Plan for Attorney Employees in the Master Trust see Note D.

The Plan's investments in the Master Trust are stated at fair value as determined based on the fair value of the underlying investments of the Master Trust. See Note E for discussion of fair value measurements.

Income or loss from self-directed brokerage accounts and participant loans are applied to participants' accounts directly. Net investment income or loss from all other funds is allocated only to the participants in those funds in proportion to their respective balances in those funds.

**December 31, 2024 and 2023**

The net realized gain or loss on sales of investments and the net unrealized appreciation or depreciation in fair market value of investments held are calculated as the difference between market value at the beginning of the year or date of purchase, if later, and market value at date of sale or year end, and are reflected as Plan interest in Chapman and Cutler Master Trust net investment income in the accompanying statement of changes in net assets available for benefits.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date and interest income is recorded when earned.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expense and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loans to be in default, the participant loan balance is reduced and a benefit payment is recorded.

***Payment of Benefits***

Benefits are recorded when paid.

***Administrative Expenses***

Investment manager and administrative fees for the Master Trust are allocated to the individual participating plans and included with each plan's interest in the Master Trust's net investment income. All other expenses relating to the administration of the Plan are paid by the Partnership.

**NOTE C - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Partnership has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

**NOTE D - MASTER TRUST (UNAUDITED)**

The Plan's custodian and trustee is Matrix Trust Company. The Master Trust is a trust account established with Matrix Trust Company, N.A. (the "Trustee") by the Partnership for the Plan and certain other plans of the Partnership. Each participating plan has a specific interest in the Master Trust based on participant-directed accounts. The units in the Master Trust are valued daily, except for certain self-directed investments, to reflect the earnings on investments plus the market value appreciation or depreciation. The Master Trust's units may be redeemed by the Plan for an amount equal to their current market values.

Self-directed brokerage accounts primarily consist of common stocks and mutual funds that are valued on the basis of readily determinable market prices and are classified as Level 1 investments. The Master Trust provides for various investments that, in general, are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE E - FAIR VALUE MEASUREMENTS**

The Financial Accounting Standards Board has issued guidance that establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Master Trust has the ability to access.

Level 2 - Inputs to the valuation methodology include the following:

- Quoted market prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the (Level 2) input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used to measure assets at fair value:

*Money market fund* - Valued at cost, which approximates fair value.

*Registered investment companies* - Valued at the quoted net asset value of shares held by the Master Trust at year end.

*Self-directed brokerage accounts* - Investments include corporate debt instruments valued based on closing price obtained from independent financial services industry recognized vendors as obtained by the Trustee, common stock valued based on closing market price reported on the active market on which the individual securities are traded, registered investment companies valued at the quoted net asset value of shares held by the Master Trust at year-end, and money market funds valued at cost, which approximates fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE F - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain investments in the Master Trust are managed by the Trustees and, therefore, these investments qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions.

**NOTE G - TAX STATUS**

The Internal Revenue Service ("IRS") has determined and informed the Partnership by a letter dated December 5, 2017, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any periods in progress.
