### Note 1: Description of Plan

The following description of the HUI Manufacturing, Inc. 401(k) Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Effective January 1, 2024, the Company changed its name from Household Utilities, Inc. to HUI Manufacturing, Inc. (the "Company") and as a result, the name of the Plan was changed from Household Utilities, Inc. 401(k) Retirement Savings Plan to HUI Manufacturing, Inc. 401(k) Retirement Savings Plan.

### General

The Plan is a defined contribution plan covering all eligible employees of the Company who have completed 30 days of service and have attained age 18. Eligible employees may enter the Plan on the first day of the following month upon meeting eligibility requirements. Participants are also immediately eligible for the Company's discretionary matching contributions upon enrollment. Participants are eligible for Company discretionary profit sharing contributions upon working 1,000 hours of service in the plan year and must be employed on the last day of the plan year.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. Management of the Company is responsible for oversight of the Plan, including the appropriateness of the Plan's investment offerings and monitoring investment performance.

### Contributions

Each year, participants may contribute to the Plan up to 100% of eligible compensation on a pre-tax or Roth basis, as defined in the plan document, not to exceed the maximum allowable limits as defined by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans ("rollover contributions"). Participants direct the investment of their contributions into various investment options offered by the Plan. Effective January 1, 2024, the Plan also includes an auto-enrollment provision whereby all newly eligible full-time employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan or elect an alternate deferral rate. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Company may elect to make discretionary matching contributions and discretionary profit sharing contributions to the Plan. During 2024, the Company made discretionary matching contributions equal to 50% of the first 3% of eligible compensation totaling \$92,455. During 2024, the Company also made an additional discretionary matching contribution equal to 50% of the first 3% of annual eligible compensation totaling \$92,628. The Company did not make any discretionary profit sharing contributions during 2024. Rollover contributions are not matched.

### Note 1: Description of Plan (Continued)

#### Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's discretionary matching contributions, and allocations of (a) the Company's discretionary profit sharing contributions, and (b) plan earnings (losses). Participant accounts are reduced by withdrawals and are charged an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately 100% vested in their voluntary contributions, plus actual earnings thereon. Vesting in the Company discretionary matching and profit sharing contribution portions of their accounts, plus actual earnings thereon, is based on years of continuous service. Participants vest at a rate of 25% per year beginning with the first year of service. The vesting percentage increases an additional 25% each year thereafter, with 100% vesting after four years of service. In addition, a participant becomes 100% vested upon death or disability.

#### Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms shall not exceed five years unless the note qualifies as a home loan, in which case the note shall not exceed ten years. Participants may only have one loan outstanding at any time. The notes are secured by the balance in the participant's account and bear interest at prime plus 1.00%. Interest rates on existing notes as of December 31, 2024, range from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

#### Payment of Benefits

On termination of service due to death, disability, normal retirement (age 60), or termination of employment, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount or, in certain circumstances, installment payments. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2. Participants may withdraw their rollover contributions at any time.

### **Note 1: Description of Plan (Continued)**

#### **Forfeitures**

Plan forfeitures arise as a result of participants terminating service with the Company before becoming 100% vested in Company contributions. Forfeited nonvested accounts totaled \$248 at December 31, 2024, and \$245 at December 31, 2023. These amounts may be used at the Company's discretion. In 2024, forfeitures of \$18,921 were used to pay plan expenses.

#### **SECURE 2.0 Act**

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing laws for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Principle areas of the act addressed participant saving assistance, required minimum distributions (RMD), catch-up contributions, and lost participants. There are provisions which are currently part of the plan design, including the provisions designed to assist with participant savings, automatic enrollment, and the RMD provisions required for 2023 which have already been adopted by the Plan. The catch-up contribution provisions that include an increased catch-up limit for participants aged 60-63 and limiting all catch-up contributions to ROTH for participants earning over \$145,000 in the prior year, are currently being evaluated and implemented in accordance with future guidance. All provisions of SECURE 2.0 will be evaluated and implemented in accordance with future regulations and guidance, and the Plan will be amended as needed.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

#### **Use of Estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative and Investment Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the distributions and administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are allocated proportionately to plan participants based on their respective account balances and are reflected as investment expenses and included in net investment income.

Certain fees incurred by the Plan for investment management services are allocated proportionately to plan participants based on their respective account balances and are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than direct payment. All other expenses paid directly by the Plan are allocated proportionately to plan participants based on their respective balances and are included in administrative expenses.

#### **Subsequent Events**

Subsequent events have been evaluated through July 25, 2025, which is the date the financial statements were available to be issued.

### Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/Collective Trust Fund:* Valued at the NAV provided by the administrator of the fund using NAV as a practical expedient to estimate fair value. This practical expedient would not be used if it were determined to be probable that the fund would sell the underlying investments for an amount different than the reported NAV. This is a stable fund, and its NAV is based on the underlying investments held by the fund less its liabilities. Participant transactions (purchases and sales) may occur daily. Various notice periods are required for certain large redemptions. There are no unfunded commitments as of December 31, 2024 and 2023.

### Note 4: Information Prepared and Certified by the Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and non-interest-bearing cash held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Mid Atlantic Trust Company, the Custodian of the Plan.

### Note 5: Party-In-Interest Transactions

Pension Inc., is the third party administrator, as defined by the plan document; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Pension Inc. for administrative services were \$26,818 for the year ended December 31, 2024. Morgan Stanley is the investment advisor of the Plan, therefore; fees paid to Morgan Stanley also qualify as party-in-interest transactions. Fees paid by the Plan to Morgan Stanley for investment management fees were \$37,976 for the year ended December 31, 2024.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules of ERISA.

### Note 6: Plan Termination

The Company has the right under the plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

### **Note 7: Tax Status**

The Plan adopted a non-standardized pre-approved plan document with an IRS notification letter dated June 30, 2020, which states the non-standardized pre-approved plan document as then designed is in compliance with the applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the notification letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
