## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the Kids First Sports Center 401k Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### Opinion

**Notes to Financial Statements**

**Note A – Description of the Plan**

The following description of the Kids First Sports Center 401k Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document, adoption agreement, and summary plan description (“SPD”) for a complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution retirement plan established and maintained by Kids First Sports Center (the “Company”) for the benefit of its eligible employees. The Plan is intended to qualify under Section 401(a) of the Internal Revenue Code (“IRC”), and the related trust is intended to be exempt from federal income taxes under IRC Section 501(a). The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Administration**

The Company serves as Plan Administrator and is responsible for the overall operation and administration of the Plan. Recordkeeping, custodial, and trustee services are provided by ADP Retirement Services. ADP Strategic Plan Services, LLC (“SPS”) serves as the ERISA Section 3(38) investment manager, exercising discretionary authority to select and monitor the Plan’s investment options throughout the year ended December 31, 2024.

**Eligibility and Participation**

Employees become eligible to participate in the Plan upon satisfaction of the age and service requirements in the Plan document, typically including attainment of age 21 and completion of one year of service. Eligible employees may enter the Plan on the designated entry dates during the year.

**Automatic Enrollment**

The Plan includes an automatic enrollment (“automatic contribution arrangement”) feature under which eligible employees who do not make an affirmative election are automatically enrolled at the default contribution rate established in the Plan. Automatically enrolled contributions are invested in the Plan’s qualified default investment alternative (“QDIA”), generally a target-date retirement fund, until the participant elects otherwise.

**Note A – Description of the Plan (continued)**

**Participant Contributions**

Participants may elect to contribute a percentage of their eligible compensation as pre-tax elective deferrals or Roth contributions, subject to the limitations of IRC Sections 402(g) and 415. Participants age 50 and older may also make catch-up contributions under IRC Section 414(v). Participants may also contribute amounts rolled over from other qualified plans or IRAs.

**Employer Contributions**

The Company provides a matching contribution and may make an additional discretionary profit-sharing contribution, as specified in the adoption agreement. Employer contributions credited during the year ended December 31, 2024 totaled \$89,604. Employer contributions are subject to the Plan’s vesting schedule as described below:

**Participant Accounts**

Each participant’s account is credited with participant contributions, employer contributions, and an allocation of Plan earnings (losses), and is charged with an allocation of Plan administrative expenses, if applicable. Allocations are based on participant contributions, compensation, or account balances, as defined in the Plan.

**Vesting**

Participants are always fully vested in their elective deferrals, Roth contributions, rollover contributions, and related earnings. Vesting in employer contributions is based on years of credited service in accordance with the Plan’s vesting schedule. Participants become 100% vested upon reaching normal retirement age, death, or disability.

**Notes Receivable From Participants**

The Plan permits participants to borrow from their accounts subject to the terms of the Plan and applicable law. Loan amounts generally may not exceed the lesser of \$50,000 or 50% of a participant's vested account balance. At December 31, 2024, the Plan had no outstanding participant loans.

**Payment of Benefits**

Participants (or beneficiaries) may receive distributions of their vested account balances upon retirement, disability, death, or termination of employment, subject to Plan provisions. Distributions are generally made as lump-sum payments.

**Forfeited Accounts**

Forfeited accounts will be used to reduce future employer contributions. As of and for the year ended December 31, 2024, activity in the forfeitures account was de minimis.

**Note B – Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are stated at fair value. Mutual funds are valued at quoted market prices, representing the net asset value ("NAV") of shares held.

The Plan's interest in the common/collective trust ("CCT") stable value fund is valued at contract value. (see Note E).

Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes realized gains/losses and unrealized changes in fair value.

**Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. There were no notes receivable from participants as of December 31, 2024 and therefore no allowance for credit losses has been recorded as of December 31, 2024.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. There were no excess contributions payable as of December 31, 2024.

**Contributions**

Participant and employer contributions are accrued in the period in which they are eligible to be made and are remitted to the trust as soon as administratively feasible.

**Benefit Payments**

Benefits are recorded when paid.

**Administrative Expenses**

Administrative fees may be paid either by the Company or from Plan assets. Certain investment-related expenses are included in net investment income.

**Subsequent Events**

Management evaluated subsequent events through the audit report date, the date the financial statements were available to be issued. No events requiring adjustment were identified.

**Note C – Certified Investments (ERISA Section 103(a)(3)(C))**

Substantially all of the Plan’s investment information is prepared and certified by ADP Retirement Trust Services, LLC (the trustee/custodian), including investment information as of December 31, 2024, and investment income for the year then ended, in accordance with 29 CFR 2520.103-5. The Plan administrator elected to have the Plan audited under the ERISA 103(a)(3)(C) framework; therefore, the auditor does not audit certified investment information.

**Note D – Fair Value Measurements**

The Plan follows the fair value hierarchy under FASB ASC 820, which prioritizes inputs as follows:

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Mutual funds held by the Plan are classified as Level 1.

The Plan's investment in the CCT stable value fund is presented at contract value and therefore excluded from the hierarchy table.

No transfers between levels occurred during the year.

**Note E – Common/Collective Trust (Stable Value Fund)**

The Plan invests in the Invesco Stable Asset Fund – ADP (the “Fund”), which is a common collective trust maintained by Invesco Trust Company and made available through ADP Retirement Trust Services, LLC, the Plan's trustee and custodian. The investment objective of the Fund is to preserve principal while providing a stable rate of return consistent with capital preservation.

The Fund invests primarily in a diversified portfolio of investment contracts issued by insurance companies and banks, together with high-quality fixed-income securities. The investment contracts are designed to protect principal and provide a crediting rate of interest that is reset periodically based on the performance of the underlying investments, subject to contractual minimum interest rate provisions.

The Plan's interest in the Fund is reported at contract value, which represents contributions made to the Fund, plus earnings, less participant withdrawals and administrative expenses. Contract value represents the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

The investment contracts held by the Fund are considered fully benefit-responsive investment contracts in accordance with accounting principles generally accepted in the United States of America. As such, the Fund is reported at contract value rather than fair value. Contract value is the relevant measurement attribute for fully benefit-responsive investment contracts because it represents the amount participants would receive upon permitted participant-initiated transactions.

Participant-initiated transactions, including contributions, withdrawals, loans, and transfers among investment options, are generally permitted at contract value under the terms of the Plan. The Fund does not impose market value adjustments on participant-initiated transactions.

**Note F – Related-Party and Party-in-Interest Transactions**

ADP Retirement Trust Services, LLC (“ADP”), the Plan’s trustee and recordkeeper, provides administrative and recordkeeping services to the Plan and receives fees that are paid either from Plan assets or by the Company. The Plan’s investment options include certain mutual funds that may be affiliated with service providers to the Plan, which constitute party-in-interest transactions permitted under the Employee Retirement Income Security Act of 1974 (“ERISA”). All such transactions were conducted in accordance with applicable statutory and administrative exemptions.

Effective January 1, 2024, ADP provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement (“MSA”) between the Company and ADP. In connection with these services, ADP receives revenue from mutual fund service providers for services ADP provides to the funds. Such revenue is used to offset amounts owed by the Plan for administrative services under the MSA.

If the revenue received by ADP from mutual fund service providers exceeds the amounts owed under the MSA, ADP remits the excess to the Plan’s trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to participant accounts. During the year ended December 31, 2024, there were no excess amounts. The Plan or the Plan Sponsor may make payments to ADP for administrative expenses not covered by revenue sharing.

**Note G. Tax Status**

The IRS has determined and informed the Company by a letter dated October 6, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note H – Risks and Uncertainties**

The Plan invests in various investment securities which are exposed to market, credit, and interest-rate risks. Due to these risks, it is reasonably possible that changes in investment values in the near term could materially affect participants’ account balances and the amounts reported in the financial statements.

Effective January 1, 2025, the Plan was amended to modify certain eligibility, vesting, and contribution provisions, including updates to eligibility and break-in-service rules, employer matching contribution provisions, and vesting schedules applicable to employer contributions. In addition, the Plan includes an automatic enrollment feature under which eligible employees who do not make an affirmative election are automatically enrolled at a default elective deferral rate of 3% of eligible compensation, with automatic annual increases of 1% of compensation, up to a maximum automatic deferral rate of 10% of compensation, unless the participant elects otherwise.

Effective August 1, 2025, the Plan was further amended to revise its automatic enrollment provisions. Under the amended provisions, newly eligible participants who do not make an affirmative election are automatically enrolled at a default elective deferral rate of 6% of eligible compensation, with automatic annual increases of 1% of compensation, up to a maximum automatic deferral rate of 10% of compensation, unless the participant elects otherwise.

These amendments did not affect the amounts reported in the accompanying financial statements for the year ended December 31, 2024 and are disclosed as subsequent events.
