We have performed audits of the accompanying financial statements of Regions Behavioral Hospital LLC 401(k) Profit Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**Note 1-Description of Plan**

The following description of the Regions Behavioral Hospital LLC 401(k) Profit Sharing Plan & Trust ("Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

A. General

The Plan is a defined contribution plan covering substantially all employees of Regions Behavioral Hospital LLC ("the Company"), who are age 21 or older. The Plan is a qualified retirement plan under the Internal Revenue Code (IRC). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan was established to provide employees with an opportunity to accumulate funds for retirement. The Plan's trustee, Reliance Trust Company, holds the Plan's investment assets and executes investment transactions. ADP Inc. provides recordkeeping services for the Plan.

B. Contributions

*Participant Contributions*

A participant may elect to contribute in the aggregate from one percent (1%) to ninety percent (90%) of earned compensation as a pre-tax and/or designated Roth contribution, subject to the maximum allowed by law. Unless an election to contribute zero percent (0%) of compensation is made, employees shall be deemed to have elected to defer three percent (3%) of their compensation as a pre-tax contribution. For participants automatically enrolled in the Plan, their elective deferral percentage will increase by one percent (1%) annually on the anniversary of their hire date, up to a maximum of six percent (6%) of compensation.

*Employer Contributions*

The Company is not required to make matching contributions to the Plan on behalf of qualifying contributing participants. The Company may, in its sole discretion, make a profit sharing contribution to the Plan on behalf of participants who have satisfied all eligibility requirements and are employed on the last day of the Plan year based on a pro rata formula. The Company is not required to make profit sharing contributions to the Plan.

C. Participant Accounts

Each participant's account is credited with the participant's contributions, as well as Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All accounts are participant-directed.

D. Vesting

Participants are immediately vested in their contributions and related earnings, which have been credited to their accounts.

E. Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or fifty percent (50%) of their account balance. Participants are limited to a maximum of two loans against their account. The loans are secured by the balance in the participant's account and bear interest at a fixed rate commensurate with local prevailing rates. Principal and interest are paid ratably through payroll deductions, over a period not to exceed four and a half years (54 months).

F. Payment of Benefits

Upon termination of service due to death, disability, or retirement, participants may elect to receive a lump sum distribution equal to the value of his or her account or installment distributions for a specified term or dollar amount. Active participants who have reached the age of 59 ½ years may elect to receive an in-service distribution from the vested portion of their accounts. Hardship distributions are allowed from the following portion of participants' accounts: Elective Deferral Account and Rollover Contribution Account.

**Note 2-Summary of Significant Accounting Policies**

A. Basis of Accounting

The accompanying financial statements are presented using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

B. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from plan net assets during the reporting period. Accordingly, actual results may differ from those estimates.

C. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

D. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses was recorded as of December 31, 2024 and 2023.

D. Notes Receivable from Participants (Continued)

If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

E. Payment of Benefits

Benefits are recorded when paid.

F. Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

**Note 3-Fair Value Measurements**

FASB ASC 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.
- Level 2 Inputs to the valuation methodology include:
  - quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability; and
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023:

*Mutual Funds*: Valued based on the funds' reported closing net asset value as of the last business day of the Plan year end. The funds are deemed to be actively traded.

*Collective Trust Fund:* Stated at fair value as determined by the issuer of the collective trust fund based on the fair market value of the underlying investments, which is valued at the NAV of units of the collective trust fund. The NAV is used as a practical expedient to estimate fair value. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 4-Tax Status**

The Internal Revenue Service has ruled that the Plan qualifies under Section 401(a) of the Internal Revenue Code (IRC) and is, therefore, not subject to tax under present income tax law. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and exempt from taxation as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

**Note 5-Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the plan agreement to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will remain 100 percent vested in their accounts.

**Note 6-Information Prepared and Certified by the Trustee**

The following information included in the accompanying financial statements and supplemental schedules was prepared by or derived from information provided by Reliance Trust Company, the trustee of the Plan, and furnished to the Plan Administrator. The Plan Administrator has obtained a certification from the trustee that information provided to the Plan Administrator by the trustee related to the following assets and asset activity is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the United States Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the information that appears in the financial statement and supplemental schedules to the following:

**Note 7-Party-in-Interest Transactions**

The Plan engages in transactions with certain service providers who are considered parties-in-interest under ERISA. Investment management fees related to assets held by the Plan are generally included in net appreciation in fair value of investments, as these fees are not separately reported. In addition, fees paid to the contract administrator for recordkeeping and administrative services are separately presented in the accompanying financial statements. These transactions are exempt from the prohibited transaction rules under ERISA Section 408(b)(2) and are disclosed in accordance with FASB ASC 962.

The Company provides certain accounting and administrative services to the Plan for which no fees are charged.

During the Plan's conversion to a new trustee and recordkeeper in 2023, the Company inadvertently failed to remit participant deferrals in the amount of \$9,827, as required under Department of Labor Regulations. The DOL considers late deposits to be nonexempt prohibited transactions. The Company is in the process of correcting this matter.

**Note 8-Risks and Uncertainties**

The Plan invests in various investment securities which are exposed to risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits. It is not possible at this time to reasonably estimate the possible loss or range of loss, if any.

**Note 9-Subsequent Events**

Management of the Plan evaluated subsequent events through December 29, 2025, the date the financial statements were available to be issued. As a result, management noted no subsequent events which required adjustment to, or disclosure in, these financial statements.
