We have audited the financial statements of the ITSC Secure Solutions, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). 

NOTE A – DESCRIPTION OF PLAN

The following information of the ITSC Secure Solutions, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan, which was adopted with an effective date of July 15, 2016, is a qualified automatic contribution arrangement plan under Section 401(k) of the Internal Revenue Code (the IRC) covering all regular employees of ITSC Secure Solutions, LLC (the Company) and is amended from time to time. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees become eligible to participate in the Plan upon attaining age 21 and completing three consecutive months of service. Service is measured by the mere passage of time, and no minimum hours are required. Eligible employees may enter the Plan on the first day of the month following the completion of the eligibility requirements. Certain employees, including non-resident aliens and residents of Puerto Rico, are excluded from participation.

Contributions

Each year, participants may contribute up to 100 percent of annual compensation, as defined in the Plan. The Plan includes an automatic deferral feature. Accordingly, the Company automatically withholds a portion of the employees' compensation each pay period and contributes the amount to the Plan as a pre-tax deferral unless the employee makes a contrary election. Effective February 8, 2024, automatic enrollment was removed. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Each pay period the employer makes a safe harbor contribution equal to 100% of elective deferrals that do not exceed 3% plus 50% of elective deferrals that exceed 3% but do not exceed 5% for all eligible employees. Determination of the safe harbor contribution is based on the pay period. The Company made safe harbor matching contributions in the amounts of \$336,411 and \$269,898 for the Plan Years ended December 31, 2024, and 2023 respectively.

Rollovers from Other Plans

For eligible employees or participants, the Plan allows rollover contributions from all qualified plans. A separate account is maintained by the Plan for a participant's rollover contribution, which is nonforfeitable at all times. The account shares in the income and gains and losses of the funding vehicles in which it is invested.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's profit-sharing contribution (b) plan earnings; and (c) forfeitures of terminated participants' nonvested accounts and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant compensation, participant earnings, account balances or specific participant transactions, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions, safe harbor contributions plus actual earnings thereon. Employer profit sharing contributions are vested on a 6-year graded vesting schedule below:

- 0 to 1 year – 0%
- 2 years - 20%
- 3 years – 40%
- 4 years – 60%
- 5 years – 80%
- 6 years – 100%

Investment Elections

Participants may direct the investment of their contributions and any discretionary matching contributions into various investment options offered by the Plan. Participants may change their investment elections and their total contribution percentage via an automated system at any time.

Notes Receivable from Participants

Loans to plan participants are permitted. Participants may borrow from their vested account balances up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The maximum aggregate amount of loans outstanding to any participant may not exceed \$50,000, reduced by the participant's highest outstanding loan balance during the 12-month period preceding the new loan date. The minimum loan amount is \$1,000, and participants may not have more than two outstanding loans at any time.

Loans must generally be repaid within five years, except for loans used to purchase a principal residence, which must be repaid within fifteen years. Loans are collateralized by the participants' vested account balances and bear interest at a rate determined by the Plan Administrator that approximates prevailing market rates. Interest rates on outstanding loans ranged from 3.25% to 9.50% for the years ended December 31, 2024 and 2023. Loan repayments, including principal and interest, are made through payroll deductions and are reinvested in each participant's account according to current investment elections.

Payment of Benefits

On termination of service for any reason, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. The Plan also permits in-service distributions for participants 59 ½ years and older. Hardship distributions are permitted, provided that the withdrawal is to satisfy a heavy financial need.

Forfeited Accounts

At December 31, 2024 and 2023, the Plan had no forfeited non-vested accounts. No forfeitures were used to reduce employer contributions during either year.

NOTE B – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are maintained and the accompanying financial statements have been prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investments Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income are recorded when received. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

NOTE C – CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Alerus Financial, N.A. and the Standard Insurance Company, custodian of the plan.

NOTE D – FAIR VALUE MEASUREMENTS

FASB *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Investments in these mutual funds can be redeemed daily upon request.

Common trust funds – Valued daily using the net asset value (NAV). The NAV is quoted on a private market that is not active; however, the unit price is based on underlying investments in fully benefit-responsive guaranteed investment contracts that include underlying securities, which are predominantly traded on an active market. The underlying investments consist of guaranteed investment contracts, synthetic investment contracts with investments in securities in U.S. government agencies, mortgage-backed securities, corporate bonds, asset-backed securities, money market instruments and shares of mutual funds and commingled pools invested in the previously mentioned securities.

NOTE E – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE F – TAX STATUS

The Internal Revenue Service has determined, in a letter dated June 30, 2020, that the form of the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G – PARTIES-IN-INTEREST TRANSACTIONS

The Plan extends loans to participants who are considered parties in interest and are exempt from the prohibited transaction rules. Other transactions that may be considered party-in-interest transactions relate to normal management and administrative services and the payment of expenses related thereto.

NOTE H – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE I – SUBSEQUENT EVENTS

Subsequent events were evaluated through November 17, 2025, which is the date the financial statements were available to be issued. We were not made aware of any significant subsequent events.
