As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

**1. DESCRIPTION OF PLAN**

The following description of the IMA Financial Group, Inc. 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan Agreement or Summary Plan Description for a more complete description of the Plan's provisions. The Board of Trustees is responsible for oversight of the Plan. The Retirement Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reviews reporting requirements, and reports to the Board of Trustees.

General - The Plan is a defined contribution plan covering all employees, except union and temporary employees, of IMA Financial Group, Inc. and Subsidiaries (the Company) who are age 18 or older. Once eligible, participants are automatically enrolled in the Plan at 6% unless they elect an alternate percentage, including something less than 6%, or elect not to participate completely. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Amendments - Throughout the year, there were numerous Plan amendments and restatements. These amendments included the following changes to Plan provisions:

- WWW Insurance LLC was added as a participating employer to the Plan in August 2024.

During 2024, assets transferred into the Plan totaling \$14,149,470 included the following:

- March 28, 2024, assets totaling \$8,139,030 and loans totaling \$62,355 were transferred into the Plan from Edwards, Church, & Muse, a participating employer within Big "I" MEP 401(k) Plan.
- October 1, 2024, assets totaling \$2,852,986 and loans totaling \$42,118 were transferred into the Plan from The Benefit Company.
- December 1, 2024, assets totaling \$2,928,054 were transferred into the Plan from EBS Insurance Brokers.
- August 1, 2024, loans totaling \$108,530 were transferred into the plan from WWW Insurance LLC.
- Loans totaling \$16,397 were transferred into the plan from FC Capital, which was acquired by IMA Financial Group, Inc. on July 1, 2024.

Contributions - The Plan provides that active participants may make voluntary pre-tax and post-tax contributions to the Plan, from 1% to 75% of their annual compensation up to the maximum allowed by the Internal Revenue Code (\$23,000 for 2024) as adjusted for applicable percentages of compensation. Participants who have reached 50 years of age are allowed to make additional contributions as adjusted by the IRS (\$7,500 for 2024). The Company makes a Safe Harbor matching contribution equal to 100% of each employee's elective deferrals up to 3%, plus 50% of each participant's elective deferral between 3% and 5%. In addition, the Company may elect to make a discretionary contribution at the end of the fiscal year as determined by the Company. No discretionary contributions were made for 2024. Participants direct the investment of their contributions, as well as their portion of the Company's contributions, into various investment options offered by the Plan.

**1. DESCRIPTION OF PLAN (CONTINUED)**

Participant Accounts - Each participant's account is credited with the participant's contribution and an allocation of the Company's contribution, Plan earnings, and administrative expenses. Allocations are based on participant earnings or account balances, as defined. Participant-requested services may also be charged an administrative fee. The benefit to which a participant is entitled is the amount of the participant's vested account.

Vesting - Participants are immediately vested in their voluntary contributions, the Company's Safe Harbor contributions, and any discretionary Company contributions, plus the earnings thereon.

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance, limited to one outstanding borrowing at a time. These notes receivable are secured by the balance in the participant's account and bear interest at the Prime rate plus 2%. Principal and interest are paid ratably through regular payroll deductions. Notes receivable may not exceed five years.

Normal Retirement - Normal retirement age is 65 years of age.

Payment of Benefits - Payment to participants is in the form of a lump-sum payment or an installment option for participants subject to lifetime required minimum distributions. Participants may also make in-service withdrawals, including for financial hardships as defined by the Plan. Distributions to participants with a vested account balance less than \$5,000 shall be made upon termination of services, unless the participant has an outstanding loan, in which case the full outstanding balance must remain in the participant's account until the loan is fully repaid.

Forfeited Accounts - At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0. Forfeited accounts may be used to reduce nonelective contributions and to pay Plan expenses. During 2024, \$1,316 in forfeited nonvested accounts were used to reduce employer Safe Harbor matching contributions.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting and Use of Estimates - The accompanying financial statements are prepared under the accrual method of accounting. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect: (1) the reported amounts of assets and liabilities, (2) disclosures such as contingencies, and (3) the reported amounts of revenues and expenses included in such financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are valued at fair value, (except for the fully-benefit responsive investment contract, which is at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Contributions - Contributions from Plan participants and the Company matching contributions are recorded in the year in which the participant contributions are withheld from compensation.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance has been recorded as of December 31, 2024 and 2023 for these notes receivable. Delinquent loans are treated as distributions based upon the terms of the Plan document.

Benefit Payments - Benefits are recorded when paid.

Administrative Fees - Certain expenses of the Plan may be paid directly by the Company and are therefore excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative fees. Some investment related expenses may be included in the net change in value of investments.

Subsequent Events - These financial statements considered subsequent events through October 10, 2025, the date the financial statements were available to be issued.

**4. INVESTMENTS AND FAIR VALUE MEASUREMENTS**

Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

The guidance describes three levels of inputs that may be used to measure fair value:

Level 1 - Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 - Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 - Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

*Mutual Funds* - These investments are valued using the Net Asset Value (NAV) provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market.

*Collective Trust Fund* - This investment is valued at the NAV of units in a collective trust. The NAV is used as a practical expedient to estimate the fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

**5. INVESTMENT AT CONTRACT VALUE**

The Plan has entered into a traditional fully benefit-responsive guaranteed investment contract with Great-West Life & Annuity Insurance Company totaling \$8,221,918 and \$6,309,334 at December 31, 2024 and 2023, respectively. Great-West Life & Annuity Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on an annual basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for the fully benefit-responsive investment contract because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

**6. PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan assets are managed by Empower (party-in-interest), and therefore, these transactions qualify as party-in-interest transactions. Total fees incurred and paid directly by the Plan for investment management services were \$576,174. The various funds' operating expense ratios ranged from 0.04% to 0.74% as of December 31, 2024.

**7. TAX STATUS**

The Plan has adopted a non-standardized form of a pre-approved plan. The pre-approved plan provider, Empower Retirement, LLC, received an opinion letter on November 14, 2022 from the Internal Revenue Service as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Management evaluated the Plan's tax positions and concluded that it had taken no uncertain tax positions that require recognition or disclosure in the financial statements. No provision or liability for income taxes has been included in the financial statements.

**8. PLAN TERMINATION**

Although it has not expressed an intention to do so, the Company reserves the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of termination of the Plan, the interests of the participants in the Plan shall be fully vested at the time of termination, and Empower shall liquidate all assets of the Plan and continue to administer the Plan in accordance with its provisions until all obligations have been satisfied.

**9. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
