Independent Auditors' Report

To the Trustee and Plan Participants of

Opinion

We have audited the financial statements of CCI Systems, Inc. Employee Stock Ownership Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of April 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended April 30, 2025, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of April 30, 2025 and 2024, and the changes in its net assets available for benefits for the year ended April 30, 2025, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

Notes to Financial Statements

April 30, 2025 and 2024

1. Description of Plan

The following description of the CCI Systems, Inc. Employee Stock Ownership Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is an employee stock ownership plan (ESOP) established by CCI Systems, Inc. (the Company) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All employees of the Company who have completed at least 1,000 hours of service with the Company during the plan year, as defined in the plan document, are age 20½ or older and employed on the last day of the plan year are eligible to participate. The Company's board of directors is responsible for oversight of the Plan. The board of directors has delegated plan oversight to a plan committee and Ventura Trust Company (the Trustee). The plan committee and the Trustee determine the appropriateness of the Plan's investment offerings and monitor investment performance.

Contributions

Each year, the Company may make contributions, in the form of common stock or cash, to the Plan. Contributions for each year are never less than the amount required to enable the Plan to meet its current distribution requirements, as defined by the Plan.

The Plan was amended, effective May 1, 2023, for a special S Corporation distribution. In June 2024, the Board authorized a S Corporation distribution (S Corp Distribution) in the amount of \$25,000,000, to be allocated in proportion to participant Company common stock (Company stock) account balances as of April 30, 2024.

In accordance with the plan amendment dated September 1, 2023, for all plan years beginning on or after May 1, 2022, participants who separate from service on or after May 1, 2022 with an account balance remaining in the Trust after the April 30th plan year ending date that coincides with or immediately follows the participant's termination date will be treated as an "Undistributed Account". In any year that a participant maintains an Undistributed Account, the Trust will exchange any cash or other liquid assets held by the participants for shares of Company stock held in the Undistributed Account, at an exchange rate based on the most recent appraised fair market value of Company stock. This is done to assure that active participant accounts are invested in Company stock to the maximum extent possible.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each plan year with an allocation of Company contributions, forfeitures and plan earnings. Only those participants who are eligible employees of the Company as of the last day of the plan year will receive an allocation. Contributions allocated are the amount deductible by the Company during the plan year as defined by the IRC. Contributions and forfeitures are allocated based on a participant's covered compensation relative to total covered compensation. Plan earnings are allocated based on the participant's account balance. The benefit which a participant is entitled is the benefit that can be provided from the participants' vested account.

Vesting

If a participant's employment with the Company is terminated for any reason other than retirement, permanent disability or death, vesting in their contributions is based on years of service. A participant is 100% vested after three years or more of credited service.

Voting Rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by Ventura Trust Company, the Trustee, prior to the time that such rights are to be exercised. The Trustee is not permitted to vote any allocated share for which instructions have not been given by a participant.

Payment of Benefits

The vested interest of a participant's account may be distributed upon retirement, death, disability or severance of employment. Distribution of plan benefits will be made entirely in cash either as a lump sum payment or in annual installments over five or more years, depending upon the participant's balance being distributed.

The timing of when the Plan will commence distributions will be based on the participant's vested account balance. If the participant's vested account balance is less than \$125,000, the distribution will be made in a single lump sum payment. If a participant's vested account balance is greater than \$125,000 but less than \$1,330,000, the distribution will be made in annual installments ranging from two to five years depending on the participant's vested account balance. If the vested account balance is greater than \$1,330,000, annual installments will range from five to ten years depending on the participant's vested account balance.

Since the Company is currently an S Corporation, the provisions of the Plan require that any shares held in accounts of participants receiving plan benefits must be immediately repurchased at fair market value as determined by an independent appraiser.

Forfeited Accounts

Forfeitures are allocated in the same manner as Company contributions are allocated. For the year ended April 30, 2025, forfeitures of \$349 were allocated to eligible plan participants. There were no unallocated forfeitures as of April 30, 2025 and 2024.

Put Option

The Company shall issue a put option to each participant who receives a distribution of shares of Company stock if, at the time of such distribution, the Company stock is not then readily tradable on an established market. The put option shall permit the participant to sell such stock at its current stock value, as determined by an independent appraiser, to the Company for a period of sixty days after such shares are distributed to the participant. The Company then has the ability to assign the put option to the Plan. The Company or the Plan, can pay for the purchase with interest over a period of five years. Notwithstanding the foregoing, distributions shall not be made in the form of Company stock during an S Corporation year if it would cause the Company to fail to constitute a "small business corporation" within the meaning of section 1361(b)(1) of the IRC.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a cash distribution within 90 days after the 90-day election period.

Recent Regulatory Updates

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's committee and trustee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments are recorded when payment is issued. Benefits paid during the year are based upon the most recent appraised fair market value of Company stock.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Reclassifying

For comparability, certain 2024 amounts have been reclassified to conform with classifications adopted in 2025. The reclassifications had no effect on reported total assets, total liabilities, or changes in net assets available for benefits, as previously reported.

Subsequent Events

Subsequent events were evaluated through January 7, 2026, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at April 30, 2025 and 2024.

Company common stock: Valued at estimated fair value based on an independent third-party appraisal since it is not actively traded and significant other observable inputs are not evaluated. The independent appraiser used a combination of widely used valuation approaches, including the market and income valuation techniques. The appraiser considered inputs such as historical and projected cash flow and net income, return on assets, return on equity, market comparables and estimated fair value of Company assets and liabilities, along with a discount for lack of marketability where appropriate.

Interest-bearing cash: Stated at cost, which approximates fair value.

Money market fund: Valued at the quoted net asset value (NAV) of shares held by the Plan at year-end.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

6. Plan Termination

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon termination of the Plan, the board of directors directs the Trustee to pay all liabilities and expenses of the Plan. Subsequently, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the plan agreement and the IRC. In the event of plan termination, participants would become 100% vested.

7. Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated March 17, 2017, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving this letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions.

8. Risks and Uncertainties

The Plan investments consist primarily of the Company's common stock, which is exposed to various risks, such as interest rate, market and credit risks, as well as valuation assumptions based on earnings, cash flows and other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

9. Concentrations

The Plan's investment in Company common stock is considered a significant concentration as it represents over 10% of the Plan's net assets as of April 30, 2025 and 2024.


