## Independent Auditors' Report

### The Plan Administrator of Team Direct Management 401(k) Profit Sharing Plan

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Team Direct Management 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (a qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### ***Opinion on the Financial Statements***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

***Basis for Opinion on the Financial Statements***

## Auditors' Communication of Internal Control

### The Plan Administrator of Team Direct Management 401(k) Profit Sharing Plan

Except as discussed in the following paragraph, in planning and performing our audit of the financial statements of Team Direct Management 401(k) Profit Sharing Plan (the "Plan") as of and for the year ended December 31, 2024, in accordance with auditing standards generally accepted in the United States of America, we considered the Plan's internal control over financial reporting (internal control) as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of expressing our opinion on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control.

We were engaged to perform an ERISA Section 103(a)(3)(C) audit of those financial statements as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by Equitable Financial Life Insurance Company that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit also did not include a consideration of internal control relating to the investment information.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis. A material weakness is a deficiency, or combination of deficiencies, in internal control, such that there is a reasonable possibility that a material misstatement of the Plan's financial statements will not be prevented, or detected and corrected, on a timely basis.

Our consideration of internal control was for the limited purpose described in the first paragraph above and was not designed to identify all deficiencies in internal control that might be material weaknesses. Given these limitations, during our audit we did not identify any deficiencies in internal control that we consider to be a material weakness. However, material weaknesses may exist that have not been identified. In addition, we identified matters for consideration that are opportunities for strengthening internal controls and operating efficiency.

### Addendum to Report on Internal Control Related Matters

#### Matters for Consideration that are Opportunities for Strengthening Internal Controls and Operating Efficiency

#### **A. Meeting Fiduciary Responsibilities**

Under ERISA, a fiduciary is any person who has discretionary authority or control respecting management of the Plan, who exercises any authority or control respecting management or disposition of assets of the Plan, or who has discretionary authority or responsibility in administering the Plan. Key responsibilities include: the selection and monitoring of the Plan's investment options, and knowledge about, and evaluation of, the direct and indirect expenses of the Plan and its investment options and services.

##### ***Recommendation***

While we noted that the Plan Sponsor has an investment committee in place to oversee the Plan, we noted that minutes of their meetings were not maintained. We recommend that the investment committee prepare minutes to document all important topics discussed and decisions reached. Board minutes can be a crucial document in recording compliance with Internal Revenue Service and Department of Labor regulations and other regulatory issues.

#### **B. Timely Deposit of Participants' Contributions and Loan Repayments**

During our audit, we noted instances where participants' contributions and loan repayments were not remitted to the Plan in a timely manner. The Department of Labor requires that participants' contributions and loan repayments be remitted to the Plan on the earliest date on which they can be reasonably segregated from the Plan Sponsor's general assets. Failure to remit participants' contributions and loan repayments to the Plan in a timely manner results in a prohibited transaction which must be separately reported to the Department of Labor and may result in penalties to the Plan Sponsor.

##### ***Recommendation***

We recommend that the Plan Sponsor review the procedures currently in place involving the remittance of participants' contributions and loan repayments to the Plan and institute the necessary controls to ensure that participants' contributions and loan repayments are remitted in a timely manner.

#### **C. Participant Contribution Deferral Elections**

During our audit, we noted that management was unable to support the deferral elections chosen by numerous participants selected for deferral election testing.

##### ***Recommendation***

We recommend that the Plan Sponsor implement the necessary processes and procedures to document the deferral elections chosen by participants. These percentages/amounts should be reviewed against the deferral percentages/amounts withheld each payroll period for accuracy. Support can either be maintained by the record-keeper (ie election through the record-keeper's portal) or by paper at the Plan Sponsor.

#### Matters for Consideration that are Opportunities for Strengthening Internal Controls and Operating Efficiency

#### **D. Cybersecurity Review**

During our audit, we noted that the Plan and Plan Sponsor have not had a cyber security assessment performed. On April 14, 2021, the Department of Labor issued guidance addressing cyber security practices of (1) Plan Sponsors, (2) service providers and (3) plan participants. The Department of Labor guidance sets forth the Department of Labor's views on the steps that Plan fiduciaries must take to demonstrate prudence on cyber security matters. The premise of this guidance is that the Department of Labor believes there is a fiduciary duty to mitigate the Plan's exposure to cyber security events (including theft). The Plan Sponsor and fiduciaries have a fiduciary duty to monitor the cyber security practices of relevant service providers.

#### ***Recommendation***

We recommend that the Plan and Plan Sponsor undergo a detailed cyber security review to reveal and address any deficiencies in cyber security. This review would help tighten defenses against cyber security threats and continue normal operations without interruptions.

## **Auditors' Communication with Those Charged with Governance**

We have audited the financial statements of Team Direct Management 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) as of and for the year ended December 31, 2024, and we issued our report thereon dated January 30, 2026. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by Equitable Financial Life Insurance Company which are a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements and ERISA-required supplemental schedules, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America ("U.S. GAAP"). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP. Professional standards require that we provide you with information about our responsibilities under generally accepted auditing standards, as well as certain information related to the planned scope and timing of our audit. We have communicated such information in our letter to you dated July 25, 2025. Professional standards also require that we communicate to you the following information related to our audit.

### **Qualitative aspects of significant accounting practices**

#### *Significant accounting policies*

Plan management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Plan are described in Note 2 to the financial statements. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

#### *Significant accounting estimates*

Accounting estimates made by the Plan's management are an integral part of the financial statements and are based on Plan management's knowledge and experience about past and current events and assumptions about future events.

Certain accounting estimates are particularly sensitive because of their significance to the financial statements and their susceptibility to change. Management believes that the estimates used and assumptions made are adequate based on the information currently available. We evaluated the key factors and assumptions used to develop the estimates in relation to the value of the Plan's investments in determining that they are reasonable in relation to the financial statements as a whole.

### *Financial statement disclosures*

The financial statement disclosures are consistent and clear.

### *Form 5500 procedures*

We obtained and read a substantially completed draft of the Form 5500 prior to dating our auditors' report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

### *Going concern*

We concur with management's assessment that the Plan will continue as a going concern for one year from the auditors' report date.

### *Significant risks*

We have identified the following significant risks in connection with our audit:

- Revenue recognition; and
- Plan management override of controls.

### *Difficulties encountered during the audit*

We encountered no significant difficulties in performing and completing our audit.

### *Corrected and uncorrected misstatements*

Professional standards require us to accumulate all known and likely misstatements identified during the audit, other than those that we believe are trivial, and communicate them to the appropriate level of management. No misstatements were identified during our audit.

### *Disagreements with management*

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditors' report. We are pleased to report that no such disagreements arose during the course of our audit.

### *Representations requested from Plan management*

We have requested certain written representations from the Plan's management in a separate letter dated January 30, 2026.

### *Management consultations with other independent accountants*

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the Plan's financial statements or a determination of the type of auditors' opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

*Other matters discussed with Plan management*

We generally discuss with the Plan's management a variety of matters, including the application of accounting principles and auditing standards, business conditions affecting the Plan, and future plans and strategies that may affect the risks of material misstatement. None of the matters discussed and our responses thereto were a condition to our retention as auditors.

*Other matters supplemental schedules*

Our responsibility for the ERISA-required supplemental schedules accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the ERISA-required supplemental schedules, other than that agreed to or derived from the certified investment information, are presented in compliance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, and whether the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## Independent Auditors' Report

### The Plan Administrator of Team Direct Management 401(k) Profit Sharing Plan

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Team Direct Management 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). ### 1. Plan Description

The following description of the Team Direct Management 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering substantially all eligible employees of Team Direct Management LLC, Bdirect Inc., Vendo, LLC, OnRetail, LLC, PLTFRM Companies, LLC, AMPD Brand, LLC and Cities Retail Services, LLC (collectively, the "Company" or "Employer"). Employees who are age 18 and have completed six months of service are eligible to become participants in the Plan and to make salary deferrals. Employees who are age 18 and have completed one year of service are eligible to receive employer safe harbor matching contributions. The following employees may enter the Plan without regard to the minimum age and service conditions: employees of OnRetail hired on or prior to December 1, 2022 and employees of PLTFRM Companies, LLC and AMPD Brand, LLC hired on or before March 1, 2023. Employees who are collectively bargained employees or nonresident aliens are not eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective April 1, 2024, accounts for employees of Cities Retail Services, Inc., a sub adopter of the ADP TotalSource Retirement Savings Plan MEP, merged into the Plan. As a result, \$10,647,442 of assets were transferred into the Plan during 2024.

In January 2026, the Plan changed vendors from Equitable Financial Life Insurance Company to ADP (record-keeper) and Reliance Trust Company (custodian).

#### **Contributions**

Each year, participants may contribute up to 96% of their annual eligible compensation, as defined in the Plan document, on a pre-tax or Roth basis. Additional after-tax employee contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. There is an annual limit as to the amount that can be deducted from their eligible compensation that is determined by the Internal Revenue Code ("IRC"). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Employer makes a safe harbor matching contribution equal to 100% of the amount a participant contributes not to exceed 4% of eligible compensation. The Employer safe harbor matching contribution is invested in the same manner as the participant's elective deferrals. The Employer may also make a discretionary employer contribution to the Plan. To be eligible, a participant must complete 500 hours of service during the Plan year and be employed on the last day of the Plan year. During 2024, no discretionary employer contributions were made to the Plan.

### 1. Plan Description (*continued*)

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of (a) the Employer contributions and (b) Plan earnings (losses) thereon. Allocations are based on a participant's earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### ***Vesting***

Participants are fully vested in their contributions and the Employer's safe harbor matching contributions plus actual earnings thereon. Vesting in Employer's discretionary contributions is based on years of continuous service, as defined in the Plan Document, in accordance with the following schedule:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than 1	25%
1	50%
2	100%

#### ***Forfeitures***

If a participant terminates employment and is less than 100% vested in their Employer discretionary contributions, the participant will forfeit the non-vested portion of their account. Forfeitures may be used to reduce future Employer contributions or pay Plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$28,364 and \$0. During 2024, no forfeitures were used to reduce Employer contributions or pay Plan expenses.

#### ***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum amount of \$1,000 up to a maximum amount of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at the prime interest rate plus 1%. Loans are repaid through payroll deductions over a period of between one and five years, unless the loan was made to acquire a primary residence, in which case the loan can be repaid over a ten-year period.

#### ***Payment of Benefits***

Upon termination of service due to death, disability or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest, or a partial distribution. In-service withdrawals of vested balances may be elected by participants who have reached 59 ½ years of age.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that reflect assets, liabilities and changes therein, and disclosures on contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2024 and 2023, all of the Plan's investments, that were valued at fair value, were valued using level 2 inputs.

#### ***Investment Valuation and Income Recognition***

All of the Plan's investments are stated at fair value, except for the guaranteed investment contract, which is stated at contract value. The pooled separate accounts are reported at the value reported to the Plan by the insurance company, which represents the fair value of the underlying investments comprising the accounts. The guaranteed interest account is stated at contract value, which represents the beginning balance plus any contributions, transfers in, and credited interest, less withdrawals, transfers out, and administrative expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a deemed distribution when a distributable event occurs.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Expenses***

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the net appreciation in value of investments.

#### ***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is January 30, 2026.

### 3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in value of investments, interest, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Equitable Financial Life Insurance Company (“Equitable”), a qualified institution.

### 4. Guaranteed Interest Option

The Guaranteed Interest Option (the “GIO”) is a fully benefit-responsive guaranteed investment contract with Equitable.

The GIO provides a minimum guaranteed interest rate and does not provide for a defined maturity date. In addition, although the GIO provides for a minimum guaranteed interest rate, the actual rate of interest credited during the time over which funds are invested in the GIO is declared periodically and therefore is subject to change. Further, withdrawals for participant benefits from the GIO are permitted as specified in the contract and are not subject to any market value adjustments. The election of the GIO does not give participants the right to participate in the investment returns on Equitable's general account assets. Rather, it gives participants the right to earn the rates of interest that Equitable periodically declares and guarantees on amounts that a participant deposits into the GIO. In addition, participant's withdrawals from the GIO are not subject to any market value adjustment.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

The credit risk of the issuer was evaluated by nationally recognized statistical rating agencies as follows: Moody's Investors Services (A1 as of May 2025), Standard and Poor's (A+ as of March 2025), and A.M. Best (A as of February 2025).

### **5. Party-In-Interest Transactions**

All of the Plan's investments are managed by Equitable, the trustee of the Plan, and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain administrative functions are performed by the employees of the Company. No such employee receives compensation from the Plan.

### **6. Prohibited Transactions**

During 2023 and 2024, the Company failed to transmit to the Plan certain participants' contributions and loan repayments totaling \$1,703,094 within the period prescribed by the Department of Labor's regulations.

### **7. Plan Termination**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their Employer discretionary contributions.

### **8. Tax Status**

The Internal Revenue Service ("IRS") has issued an opinion letter to the prototype plan document preparer, dated June 30, 2020, which states that the form of the prototype plan qualifies under the applicable provisions of the IRC. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by the taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

### **9. Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
