Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Normandeau Associates, Inc. Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 28, 2025 and June 29, 2024, and the related statement of changes in net assets available for benefits for the year ended June 28, 2025, and the related notes to the financial statements.

Opinion

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule of assets (held at end of year) is presented for purposes of additional analysis and is not a required part of the financial statements but are supplemental information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with U.S. GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. Description of Plan

The following description of Normandeau Associates, Inc. Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan provisions for more information.

General

The Plan is a tax-exempt defined contribution retirement plan sponsored by Normandeau Associates, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Fidelity Management Trust Company (the Trustee) is the recordkeeper and trustee of the Plan.

Eligibility

The Plan is available to all employees of the Company, except those who are leased employees or temporary employees. Employees are eligible for entrance into the Plan upon turning 21 years of age.

Contributions

Each year, participants may contribute up to 60% of their annual compensation, subject to Internal Revenue Service (IRS) limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions, as defined by the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers “core” mutual funds, one money market fund, and one common collective trust as investment options for participants. The Plan also offers self-directed investments through a brokerage account. Upon enrollment, a participant may direct employee and company contributions to any of the Plan’s fund options. At its discretion, the Company may elect to make employer matching contributions to participant accounts. For the year ended June 28, 2025, the Company made matching contributions based on eligible compensation according to the following schedule:

To qualify for the Company’s matching contribution, a participant must be employed on the last day of the contribution period and have been employed for one year.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Notes must be fully repaid within five years or within 10 years for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest at fixed rates determined by the Plan Administrator. The interest rate is fixed for the duration of the note. Principal and interest are paid ratably through payroll deductions. The Plan allows participants to initiate up to two notes in a given plan year. A participant's second note in a given plan year may only be initiated once the first note has been fully repaid.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's and employer's contributions and an allocation of investment income. A participant's account shall be reduced by any distributions, investment losses and certain administrative expenses. Allocations are based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contribution portion of their accounts plus actual earnings thereon is based on years of service. A participant is not vested until achieving three years of credited service and is 100% vested thereafter. A participant also becomes 100% vested upon death or disability.

Forfeitures

At June 28, 2025 and June 29, 2024, forfeited non-vested accounts totaled \$116 and \$721, respectively. These accounts can be used to reduce future employer contributions or pay administrative expenses. During fiscal year ended June 28, 2025, employer contributions were reduced from forfeited accounts by \$2,943.

Benefit Payments

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or a number of installment payments if the participant's vested account balance exceeds \$5,000. For termination of service for other reasons, a participant may elect to maintain his or her current account or receive the value of the vested interest in his or her account as a lump-sum distribution. Furthermore, if terminated, a participant with a vested account balance of less than \$1,000 may be subject to an automatic lump-sum distribution. In addition, participants may withdraw their contributions upon demonstration to the Plan Administrator that they are suffering a hardship, as defined in Section 401(k) of the Internal Revenue Code (the Code).

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting and are presented in conformity with U.S. generally accepted accounting principles (U.S. GAAP).

Accounting Period

The Plan has elected to use an annual accounting period, which varies from 52 to 53 weeks and ends on the last Saturday in June each year. The fiscal year ended June 28, 2025, contained 52 weeks.

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 28, 2025 and June 29, 2024. If a participant ceases to make note receivable repayments, and the Plan Administrator deems the participant note receivable to be in default, the participant note receivable balance is reduced and a benefit payment is recorded.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Benefit Payments

Benefit payments to participants are recorded upon distribution.

Subsequent Events

Management has considered transactions or events occurring February 6, 2026, the date the financial statements were available to be issued.

3. Information Prepared and Certified by the Trustee

The investments, investment transactions, notes receivable from participants, net appreciation in fair value of investments, and interest and dividend amounts were obtained by management and agreed to or derived from information certified by the Trustee as complete and accurate. This information is included in the following:

- Statements of Net Assets Available for Benefits
- Statement of Changes in Net Assets Available for Benefits; and
- Schedule H, Part IV line 4i - Schedule of Assets (Held at End of Year).

4. Fair Value Measurement

Financial Accounting Standards Board Accounting Standards Codification Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value that provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 28, 2025 and June 29, 2024.

Mutual and Money Market Funds: Valued using market quotations.

Common Collective Trust: Valued based on inputs that are derived principally from or corroborated by observable market data by correlation of the underlying assets and valued using the market approach based on the net asset value (NAV) of the units held by the Plan at year-end. The NAV is provided by the trustee and is used as a practical expedient to estimate fair value. The primary investment objective of the collective trust is to preserve principal while generating earnings at rates competitive over time with short-term high quality fixed income investments. Daily redemption of the common collective trust is allowed.

5. Related-Party and Party-in-Interest Transactions

Certain plan investments are shares of mutual funds managed by Fidelity Investments. Fidelity Management Trust Company, an affiliate of Fidelity Investments, is the trustee as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Fidelity Investments provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement (MSA) between the Company and Fidelity Investments. Fidelity Investments receives revenue from mutual funds and common collective trusts. This revenue is used to offset certain amounts owed to Fidelity Investments for its administrative services to the Plan.

If the revenue received by Fidelity Investments from such mutual funds or common collective trusts service providers exceeds the amount owed under the MSA, Fidelity Investments remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2025, an excess of \$16,634 was earned and is included in other income on the statement of changes in net assets available for benefits.

The Plan participants made payments to Fidelity Management Trust Company, the third-party administrator, of \$9,307 for services provided directly to them. The Company pays directly any other fees related to the Plan's operations.

Notes receivable from participants also qualify as party-in-interest transactions.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their company contributions.

7. Income Tax Status

The Plan has adopted a pre-approved plan which received a favorable IRS opinion letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Code. The Plan has been amended since the opinion letter was issued. The Plan Administrator believes the Plan is currently being operated in compliance with the terms of the Plan and the Code and remains qualified under the Code and applicable regulations and, as such, is exempt from taxes as of the financial statement date.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
