## **Independent Auditors' Report**

To the Plan Sponsor of  
Defined Benefit Pension Plan for United Way of New York City

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed the audits of the financial statements of Defined Benefit Pension Plan for United Way of New York City ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, the statement of accumulated plan benefits as of December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audit in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors' Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on these financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audits.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audits in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### ***Other Matter - Supplemental Schedule Required by ERISA***

The supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**NOTE 1 – DESCRIPTION OF PLAN**

The following brief description of the Defined Benefit Pension Plan for United Way of New York City (the "Plan") is provided for general information purposes only. Readers should refer to the Plan agreement and all amendments for a more complete description of the Plan's provisions.

A. **General** – The Plan is a noncontributory defined benefit pension plan covering employees of United Way of New York City (the "Sponsor"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and subsequent amendments. The Plan formerly covered employees of United Way of Tri-State, Inc. in addition to the Sponsor's employees. However, effective January 1, 1993, the allocated assets and liabilities of United Way of Tri-State, Inc. were segregated from the Plan to be maintained as an independent pension plan at another insurance carrier.

The Plan was frozen effective as of June 30, 2009 ("Effective Date"). Benefit accrual service shall not be credited to any service or employment for any participant after the Effective Date. No employee hired after the Effective Date shall be eligible to become a participant in the Plan. The actuarial valuation reflects this Plan amendment.

B. **Eligibility** – An employee is eligible for participation on the first day of the month following or coinciding with his or her date of hire. No employee hired after June 30, 2009 shall be eligible to participate in the Plan.

C. **Pension Benefits** – Employees are entitled to annual pension benefits beginning at normal retirement age (65) of 1-3/8% of their highest average monthly compensation (during any consecutive 60 months within the last 120 months of service) for each year of service plus 0.4% of their highest average monthly compensation (during any consecutive 60 months within the last 120 months of service) in excess of the Social Security average maximum taxable wage base for each year of service up to 35 years. The Plan permits early retirement at age 55-64 after five years of service with a reduction of benefits if retirement is prior to age 60. Effective June 30, 2009, benefit accrual service ceased for all participants. Compensation after July 1, 2009 shall not be included in final average earnings.

D. **Vesting** – The Plan has been frozen since 2009. All remaining participants are fully vested.

E. **Death Benefits** – If a vested participant dies before retirement benefits have begun, a monthly annuity is payable to a spouse or (if there is no spouse and death occurs after age 55, or before age 55 with ten years of service) a child under 19 in specified amounts, as if the employee had retired on the date of death and elected the 2/3 joint and survivor annuity with ten years certain option (in the case of a spouse).

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

A. **Basis of Accounting** – The Plan prepares its financial statements using the accrual basis of accounting. The Plan adheres to accounting principles generally accepted in the United States of America ("U.S. GAAP").

B. **Administrative Expenses** – The Sponsor pays certain expenses related to the Plan which are excluded from the Plan's financial statements.

C. **Payment of Benefits** – Benefit payments to participants are recorded upon distribution.

D. **Use of Estimates** – The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities and the actuarial present value of accumulated Plan benefits at the date of the financial statements. Actual results could differ from those estimates.

E. **Valuation of Investments and Income Recognition** – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

F. **Actuarial Present Value of Accumulated Plan Benefits** – Accumulated Plan benefits are those future periodic payments that are attributable under the Plan’s provisions to the service employees have rendered. Accumulated Plan benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, and (b) present employees or their beneficiaries. Benefits under the Plan are based on employees’ average monthly compensation during any consecutive 60 months of their last 120 months of credited service. The accumulated Plan benefits for active employees are based on the average compensation of their discounted actual compensation during the five years ending on the date which the benefit information is presented (the valuation date). Benefits payable under all circumstances – retirement, death, and termination of employment – are included to the extent they are deemed attributable to employee service rendered to the valuation date. Effective June 30, 2009, benefit accrual service ceased for all participants. Compensation after July 1, 2009 shall not be included in final average earnings.

The actuarial present value of accumulated Plan benefits is determined by an actuary from USI Consulting Group (“USI”) (as of January 1, 2024 and 2023) and is that amount which results from applying actuarial assumptions to adjust the accumulated Plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death or retirement) between the valuation date and the expected date of payment. The Pension Protection Act of 2006 enacted on August 17, 2006, made significant changes to the pension funding rules that are generally effective for Plan years commencing after December 31, 2007. The significant actuarial assumptions used in the valuations as of January 1, 2024 and 2023 were as follows:

- Weighted Average Retirement age: Age 60, or immediate if beyond age 60 for both years
- Life expectancy of participants: Internal Revenue Service (“IRS”) 2024 Generational Mortality Table (as prescribed by IRC 430).
- Interest rate: 6.00% per year for both years
- COLA increases: none for 2024 or for 2023
- Investment return: the 2024 and 2023 valuations included an estimated rate of return of 5.74% and 5.92%, respectively

The actuarial assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated Plan benefits.

The computations of the actuarial present value of accumulated Plan benefits were made as of January 1, 2024 and 2023. Had the valuations been performed as of December 31, there would be no material difference.

**NOTE 3 – FUNDING POLICY**

It is the policy of the Sponsor to fund the contributions recommended by USI, the actuary. Such funding shall be at least equal to the amount required by the minimum funding standards of ERISA. The minimum funding requirements of ERISA have been met for the years ended December 31, 2024 and 2023.

Upon termination or partial termination of the Plan, each participant’s right to his or her benefit accrued to the date of termination, to the extent funded, and the right of each participant to the amount credited to his or her account at such time shall be non-forfeitable.

**NOTE 4 – PLAN TERMINATION**

In the event the Plan terminates, the net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

- a. Annuity benefits former employees, or their beneficiaries have been receiving for at least three years, or that employees eligible to retire during that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the benefit that was payable (or would have been payable) during those three years based on the lowest benefit that would be payable under the Plan provisions in effect at any time during the five years preceding Plan termination.
- b. Other vested benefits insured by the Pension Benefit Guaranty Corporation (“PBGC”) up to the applicable limitations discussed below.
- c. All other vested benefits not insured by the PBGC.

Certain benefits under the Plan are insured by the PBGC, a U.S. Government Agency, if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor’s pensions. However, the PBGC does not guarantee all types of benefits under the Plan and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan’s termination. However, there is a statutory ceiling on the amount of an individual’s monthly benefit that the PBGC guarantees. The ceiling applies to those pensioners who elect to receive their benefits in the form of a single-life annuity and are at least 65 years old at the time of retirement or plan termination (whichever comes later). For younger annuitants or for those who elect to receive their benefits in some form more valuable than a single-life annuity, the corresponding ceilings are actuarially adjusted downward. All participants may become vested in the event of Plan termination.

Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at that time, of the Plan’s assets to provide those benefits, and may also depend on the level of benefits guaranteed by the PBGC. PBGC premiums were \$119,624 and \$114,444 for the years ended December 31, 2024 and 2023, respectively.

**NOTE 5 – INVESTMENTS - INFORMATION PREPARED AND CERTIFIED BY THE INVESTMENT CUSTODIANS AS COMPLETE AND ACCURATE**

As noted in the independent auditors' report, the Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's *Rules and Regulations for Reporting and Disclosure* under ERISA. Accordingly, as permitted under such election, the following information and the information included in the supplementary schedule on page 14, were certified as complete and accurate by Principal Trust Company and Equitable (“custodians”) and were not subjected to any auditing procedures performed by the independent auditor except for comparing such information to information included in the Plan's financial statements.

**NOTE 6 – FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurement* provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the assets or liabilities; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Collective Investment Funds** – The valuation of the fund occurs daily and is valued at net asset value (“NAV”) used as a practical expedient to estimate fair value. NAV is determined by dividing the value of the fund by total number of units outstanding on the valuation date. The estimated fair values of the Collective Investment Fund may neither reflect amounts that could be realized upon immediate sale nor amounts that ultimately may be realized. Accordingly, the estimated fair values may differ significantly from the values that would have been used had a ready market existed for these investments. The fair value of the Plan’s investments generally represents the amount the Plan would expect to receive if it were to liquidate its investment, excluding any redemption charges that may apply. The funds are direct filing entities. The NAV is based on fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

These investments that are measured in fair value using the NAV practical expedient have not been classified in the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 7 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan has a fully benefit-responsive investment contract with Equitable. Equitable maintains the contributions in a general account, which is credited with earnings and charged for participant withdrawals and administrative expenses. The investment contract is included in the financial statements at contract value. Contract value represents contributions made under the contract, plus transfers to the fund and credited interest, less participant withdrawals, transfers out of the fund and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The investment contract does not have any restrictions that impact the ability of the Plan to collect the full contract value. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. Equitable may not terminate the contract at any amount less than the contract value.

Equitable is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with Equitable but may not be less than 2.50%. Such interest rates are reviewed on a semi-annual basis for resetting. The crediting rate of the product will be established based on current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account. These rates are established without the use of a specific formula.

**NOTE 9 – PLAN TAX STATUS**

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service dated December 17, 2008, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 10 – RELATED-PARTY TRANSACTIONS**

Investments of the Plan are managed by the custodians of the Plan, and therefore, these transactions qualify as party-in-interest transactions. These party-in-interest transactions are deemed to be “exempt” as defined by Department of Labor regulations. Certain administrative fees are paid by the Plan Sponsor. The Plan paid bank fees and service provider fees to Principal and the actuary for a total of \$242,409 and \$60,583 for the years ended December 31, 2024 and 2023, respectively. The Plan paid fees to Equitable amounting to \$3,563 for each of the years ended December 31, 2024 and 2023.

**NOTE 11 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonable that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

The Plan contributions are made, and the actuarial present value of accumulated Plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would-be material to the financial statements.

**NOTE 12 – SUBSEQUENT EVENTS**

Management has evaluated subsequent events from the date of the statement of net assets available for benefits through January 22, 2026, the date the financial statements were available to be issued.

## Summary of Principal Plan Provisions

This summary has been prepared for valuation purposes only. It summarizes the plan provisions necessary to perform the actuarial valuation.

### *Effective Date*

July 1, 1945; Amended and restated effective January 1, 2012

### *Plan Year*

Calendar year.

### *Covered Employees*

All employees are eligible to participate on the first day of the month following or coinciding with their date of hire. Effective July 1, 2009, any employee hired on or after July 1, 2009 shall not be eligible to participate in the plan.

### *Definitions*

#### **Vesting Service**

100% vesting upon the completion of 5 years of service, where twelve months of service equals 1 year.

#### **Credited Service**

A participant shall receive credit for one year of credited service for years and months of employment. As of June 30, 2009, credited service is frozen for all participants.

#### **Frozen Accrued Benefit**

The accrued benefit as of the fresh start date determined under the provisions of the Plan then in effect.

#### **Normal Retirement Date**

First of month coincident with or next following the attainment of age 65.

#### **Normal Retirement Benefit**

The monthly normal retirement benefit is computed as follows:

The greater of (A) or (B)

(A) The sum of (i) and (ii)

(1) The frozen accrued benefit multiplied by the ratio of final average earnings as of the normal retirement date to final average earnings as of the fresh start date.

(2) 1.375% of final average earnings multiplied by credited service completed after the fresh start date.

(B) 1.375% of final average earnings multiplied by credited service.

**Final Average Compensation**

Highest five year average of compensation over sixty consecutive months. The average annualized amount is used if the participant works less than sixty consecutive months.

**Accrued Benefit**

A participant's accrued benefit is equal to the normal retirement benefit accrued as of the date of determination.

**Disability Annuity Credit**

Periods of disability while a participant receives Social Security Disability Income are counted as credited service excluding the first 6 months of disability and ending on June 30, 2009.

**Pre-retirement Spouse Benefit**

The surviving spouse's benefit required by the Retirement Equity Act, which is the spouse's portion of the 66 2/3% joint and survivor annuity that would have been payable had the participant terminated employment on his date of death, survived to his earliest possible retirement date and begun receiving benefits as a 66 2/3% joint and survivor annuity. This benefit is payable at the earliest date the participant could have retired under the plan.

If a participant is not survived by an eligible spouse, then the annual death benefit shall be payable to the children. If there is not an eligible child, then the death benefit shall be payable to the beneficiary appointed by the participant.

*Eligibility for Benefits*

**Normal Retirement**

Retirement as of the normal retirement date.

**Early Retirement**

Retirement before the normal retirement date and on or after attaining age 55 with 5 years of vesting service.

**Disability**

Permanent and total disability with 10 years of service.

**Deferred Vested**

Termination for reasons other than death or retirement after completing five years of vesting service.

*Monthly Benefits Paid upon the Following Events*

**Normal Retirement**

Monthly pension benefit determined as of the normal retirement date.

**Early Retirement**

Monthly accrued pension benefit determined as of a participant's early retirement date, actuarially reduced by 1/15 for each of the first 5 years and 1/30 for each of the next 5 years by which the early retirement date precedes the normal retirement date.

Effective after January 1, 1998, any participant with over 10 years of service may retire early at age 60 with no reduction,

or reductions at 1/20 for each of the five years by which the early retirement date precedes age 60.

**Disability**

Periods of disability while a participant receives a Social Security Disability Income are counted as credited service excluding the first 6 months.

**Termination with Deferred Vested Benefits**

Monthly accrued pension benefit determined as of the participant's termination date and is payable at age 65.

**Death with Pre-retirement Spouse Benefit**

Monthly pre-retirement spouse benefit is payable at the participant's earliest retirement date.

*Forms of Payment*

Unmarried participants receive a non-refund life annuity. Married participants receive a 66 2/3% joint and survivor annuity with 120 months certain. Other available optional payment forms are 50%, 75% and 100% joint & survivor annuities and life annuity, and 5,10, and 15 year certain and continuous annuities.

Participants are able to receive a lump sum for benefits accrued prior January 1, 1999 instead of a monthly annuity at retirement.
