Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Moravian Care Employee Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 (in liquidation) and 2023 (on going), and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Moravian Care Employee Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 (in liquidation) and 2023 (on going) and for the year ended December 31, 2024 (in liquidation), stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Moravian Care Employee Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As discussed in Note 1 and Note 2 to the financial statements, the Plan Sponsor elected to terminate the Plan and determined that liquidation of the Plan was imminent during 2024, the date management approved the plan of liquidation. In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting from the ongoing plan basis in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. NOTE 1 DESCRIPTION OF PLAN

The following description of Moravian Care Employee Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Moravian Care Ministries (the Company). The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Plan Termination

December 6, 2023, the Retirement Committee approved to amend and terminate the Plan effective December 31, 2023. The Plan administrator notified eligible participants of their options, subject to amended provisions. All assets of the Plan were paid out to participants, at their direction, by December 31, 2024.

Eligibility

Employees were eligible for Company contributions upon attainment of age 19 and the completion of one year of service. Employees entered the Plan for Company contributions monthly immediately following the attainment of the eligibility requirements.

Employees were eligible to participate in the deferral provisions of the Plan upon their date of hire.

Contributions

The Plan included a salary deferral arrangement allowed under Section 403(b) of the Internal Revenue Code (IRC). Eligible participants were permitted to elect to have a percentage or flat dollar amount, subject to IRC limits, of their compensation contributed as pre-tax 403(b) or Roth contributions to the Plan. Prior to Plan termination, the Plan included an automatic enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate. Automatically enrolled participants had their deferral rate set at 3% of eligible compensation and their contributions invested in the designated default fund until changed by the participant. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions.

The Company, at its discretion, could elect to contribute to the Plan. There were no Company contributions for the year ended December 31, 2024.

Participants could also contribute amounts representing distributions from other qualified defined benefit or contribution plans or conduit IRAs.

Contributions (Continued)

Participants directed the investment of contributions into various investment options offered by the Plan. The Plan offered various separate accounts, mutual funds and general accounts as investment options for participants. Contributions were subject to certain limitations.

Participant Accounts

Each participant's account was credited with an allocation of the participant's contributions, Company's contribution and an allocation of Plan earnings or losses. Allocations were based on participant earnings or account balances, as defined. Income was allocated daily based on the shares in the participant's account. The benefit to which a participant was entitled was the benefit that could be provided by the participant's account.

Vesting

The Retirement Committee elected to formerly terminate the Plan effective December 31, 2023. As a result of the termination, participants became 100% vested in their Employer contributions. Participants became fully vested in any Company contributions of their accounts upon termination of the Plan effective December 31, 2023.

Plan Loans

Participants borrowed amounts directly from The Variable Annuity Life Insurance Company (VALIC), the insurance company, in an amount up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant's account and bore interest at a rate based established each calendar quarter based on Moody's Corporate Bond Yield Average – Monthly Average Corporates for the month ending two months prior to the calendar quarter. Loan terms were up to five years, except for loans to fund the purchase of a principal residence, for which the loan may be repaid over a reasonable period that may not exceed 10 years. Upon establishment of the loan, the amount of the loan, the first quarter's interest payment, and any applicable VALIC withdrawal charges were transferred from the participant's account and placed in a separate account held by the Plan. As the loan was repaid quarterly, the amount of the separate account was reduced by the payment amount. Because VALIC was the lender, a portion of the interest payment was retained by VALIC. At December 31, 2024 and 2023, collateralized amounts were \$-0- and \$24,973, respectively.

Notes Receivable from Participants

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes were secured by the balance in the participant's account and bore interest at a prime plus two percentage points. Principal and interest was paid ratably through payroll deductions.

NOTE 1 DESCRIPTION OF PLAN (CONTINUED)

Benefit Payments

Upon termination of service, death, disability, or retirement (age 65) the participant received the value of the vested interest in his or her account in the form of a qualified joint and survivor annuity unless another type of benefit was elected. The Plan allows for in-service distributions if a participant reaches age 59½ or for hardships for certain situations. If a participant terminated employment and the participant's account balance did not exceed \$5,000, the Plan administrator would authorize the benefit payment without the participant's consent.

Forfeited Accounts

Forfeited nonvested accounts were used to reduce future Company contributions or pay for Plan expenses. Forfeited nonvested accounts as of December 31, 2024 and 2023 were \$-0- and \$9,779, respectively. Forfeitures of \$27,521 were used to pay Plan expenses for the year ended December 31, 2024.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

As a result of the Plan termination effective December 31, 2023, the Plan sponsor determined that liquidation of the Plan is imminent during 2024 when distributions under the plan of liquidation commenced. In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting from ongoing plan basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements.

Under the liquidation basis of accounting, assets are stated at their estimated net realized cash value expected to be collected in settling or disposing of assets during the liquidation process and liabilities are stated at their anticipated settlement amounts. Investments stated at fair value which approximates the amount the plan expects to collect. All expenses and income incurred as a result of the termination and liquidation have been recognized in the financial statements as of December 31, 2024.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investment Valuation and Income Recognition

The Plan's investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable are recorded as distributions on the basis of the terms of the Plan document.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements.

Benefit Payments

Benefit payments are recorded when paid.

Subsequent Events

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through February 4, 2026, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

The Variable Annuity Life Insurance Company (VALIC), the qualified institution, has supplied the Plan administrator with a certification as to the completeness and accuracy of the investment information, except for forfeitures held within the insurance company general accounts, reported by them reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 and the statement of changes in net assets available for benefits for the year ended December 31, 2024.

Reliance Trust Company and Standard Insurance Company, the qualified institutions, have supplied the Plan administrator with certifications as to the completeness and accuracy of investment information reported by them, with the exception of notes receivable from participants and the related interest, reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 and the statement of changes in net assets available for benefits for the year ended December 31, 2024.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Separate Accounts: Valued based on the net asset value (NAV) of units, which are based on market prices of the underlying investments, held by the Plan at year-end. NAV is a readily determinable fair value and is the basis for current transactions.

Insurance Company General Accounts: Considered to be nonbenefit responsive and are valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

NOTE 5 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6 PLAN TERMINATION

The Retirement Committee has resolved to terminate the Plan effective December 31, 2023, as disclosed in Note 1. Upon effective date of termination, all participants became 100% vested in their Company contributions.

NOTE 7 PLAN TAX STATUS

The Plan is placing reliance on a favorable opinion letter received from the Internal Revenue Service (IRS) on the volume submitter plan indicating that the Plan is qualified under Section 403(b) of the IRC and is, therefore, not subject to tax under current income tax law. The prototype plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 PARTY-IN-INTEREST TRANSACTIONS

The Plan investments are managed by the Variable Annuity Life Insurance Company, Standard Insurance Company, and Reliance Trust Company; therefore, the investment transactions qualify as party-in-interest transactions.

NOTE 9 INSURANCE COMPANIES

In 1998, the Plan entered into a group annuity contract with VALIC. As part of the contract, VALIC maintains a portion of the contributions in a "fixed account." The account is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by VALIC. The fixed accounts are included in the financial statements at market value because it is nonbenefit responsive. Upon termination of the investment contract, the lump sum liquidation value of the general account portion of the participant's accumulation value shall be equal to the product of (a) the participant's general account accumulation value on the liquidation date, reduced by the liquidation charge applicable on the liquidation date and (b) a market value adjustment percentage.

In 2021, the Plan entered into a group annuity contract with Standard Insurance Company. Standard maintains a portion of the contributions in a "Stable Asset Fund." The contract will pay benefits at contract value, but this is subject to certain liquidity restrictions being met determined by the issuer. Since the third party has not guaranteed liquidity for participant-initiated withdrawals, the contract is reported in the financial statements at fair value because it is nonbenefit-responsive. Investments in the insurance company general account are valued at fair value based on contributions made, less withdrawals and administrative expenses plus interest credited. The NAV increases with the daily equivalent of the crediting rate and the Plan's unit value increases along with the fund's NAV offset by the Plan's asset management fees. The crediting rate is guaranteed to not fall below 1%.

NOTE 10 NONEXEMPT TRANSACTION

The Company failed to remit employee contributions for a payroll period within the timeframe prescribed by the Department of Labor during 2023 and 2022. These are deemed prohibited transactions in accordance with ERISA and the IRC.
