INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Northwinds Holding, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



Note 1 Description of Plan

The following description of the Northwinds Holding, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions. On January 1, 2024, the Plan sponsor was changed from Isaac Heating & Air Conditioning, Inc. to Northwinds Holding, Inc. and the Plan name was changed from Isaac Heating & Air Conditioning, Inc. 401(k) Plan to Northwinds Holding, Inc. 401(k) Plan. In addition, in January 2024, three additional retirement plans were merged into the Northwinds Holding, Inc. 401(k) Plan.

General

The Plan is a defined contribution plan established for the benefit of the Northwinds Holding, Inc. (the Company) and its employees and employees of employers participating in the Plan. The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company’s management is responsible for oversight of the Plan and determining the appropriateness of the Plan’s investment offerings and monitoring investment performance.

Eligibility

Employees 18 years of age or older are eligible upon their hire date to make compensation deferrals into the Plan and participate in the employer matching contribution. Upon attainment of one year of continuous service (1,000 hours during the Plan year), employees are also eligible to receive discretionary employer profit sharing contributions, if any profit sharing contributions are declared or made for a Plan year.

Contributions

Participants may contribute up to 90 percent of pretax annual compensation, as defined by the Plan. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to defer compensation in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation, unless a different deferral rate is elected. Deferral rates automatically increase 1% each year until the deferral rate equals 10% of compensation for auto enrolled participants.

In January 2024, the Company adopted safe harbor matching provisions which provide for an employer matching contribution equal to 100% of a participant’s salary deferral up to 3% of compensation plus matching contributions of 50% of salary deferrals between 3% and 5% of a participant’s compensation. Employer safe harbor matching contributions were approximately \$2,070,000 in 2024. Employer discretionary matching contributions in 2023 were approximately \$221,000.

Note 1 **Description of Plan - Continued**

Contributions - Continued

The Company may also make discretionary profit sharing contributions as determined annually by the Board of Directors. No profit sharing contributions were made in 2024 or 2023.

Participants direct the investment of their contributions and employer contributions, if any, into various investment options offered by the Plan. Contributions are subject to certain statutory limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company matching contributions, Company profit sharing contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately vested in their voluntary contributions and employer safe harbor matching contribution plus earnings thereon. Vesting in the Company's profit sharing contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is 100 percent vested after six years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 10.50% per annum. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement or termination, a participant may receive a lump sum amount equal to the value of the participant's vested interest in his or her account balance.

Forfeited Accounts

Forfeited accounts may be used to pay Plan expenses or used to reduce employer profit sharing contributions. Forfeited non-vested accounts were \$59,238 and \$46,746 at December 31, 2024 and 2023, respectively. Forfeitures in the amount \$86,106 and \$126,648 were used to reduce employer contributions for the Plan years ended December 31, 2024 and 2023, respectively.

Note 2 **Summary of Significant Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company's management determines the Plan's valuation policies utilizing information provided by investment advisers and custodians. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Excess Contribution Refund Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions. The Plan refunded the 2023 excess contribution payable to participants prior to March 31, 2024.

Payment of Benefits

Benefits are recorded when paid.

Note 2 Summary of Significant Accounting Policies - Continued

Administrative Expenses

Certain administrative expenses of maintaining the Plan may be paid by the Plan or the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of the fair value of investments.

Date of Management's Review

The Plan Administrator has evaluated subsequent events for potential recognition and disclosure through October 14, 2025, the date the financial statements were available to be issued. Refer to Note 10 for a description of events subsequent to December 31, 2024.

Note 3 Certified Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in the fair value of investments, interest and dividends, and interest income on notes receivable for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, the trustee or custodian of the Plan.

Note 4 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6 Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their entire account balance.

Note 7 Plan Merger and Transfer of Assets

In January 2024, three defined contribution plans were merged into the Northwinds Holding, Inc. 401(k) Plan. The fair value and net assets transferred to the Plan on the date of the merger was \$11,914,231 and the employees of the companies sponsoring those merged plans became participants in the Northwinds Holding, Inc. 401(k) Plan.

Note 8 Tax Status

The Plan adopted a prototype profit sharing 401(k) Plan agreement that received an opinion letter dated October 6, 2020 from the Internal Revenue Service as to the prototype plan's qualified status. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 Risks and Uncertainties

Investment Risk

The Plan invests in various investment securities which, in general, are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10 Subsequent Events

In 2025, the Company amended the Plan Adoption Agreement to include recognition of service with certain other employers, modified the definition of early and normal retirement ages, accepted the merger of certain other defined contribution plans, and accepted the addition of certain additional participating employers. Participants should refer to the Plan agreement and plan amendments for a complete description of the amendments.
