- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting

As discussed in Note 2 to the financial statements, the Plan was terminated as of September 30, 2022, and management determined liquidation to be imminent. As a result, the Plan has chosen to present the financial statements on the liquidation basis of accounting as of December 31, 2024 and 2023 and for the year ended December 31, 2024. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date of the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

Other Matter — Supplemental Schedule Required by ERISA

The Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and is derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1. Description of Plan and Significant Accounting Policies

The following description of the Bluefield Regional Medical Center Retirement Savings Plan (Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan, which was established November 1, 2019, and restated effective March 8, 2021, to bring the Plan in compliance with the cumulative regulatory requirements of Internal Revenue Service Notice 2017-37, is a defined contribution plan available to employees of Bluefield Regional Medical Center (Plan Sponsor). Participants are eligible upon hire to make salary deferrals and to qualify for employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On October 1, 2019, Princeton Community Hospital Association, Inc. (PCHA) became the sole member of the Plan Sponsor. PCHA has endeavored to maintain the continuing operations of the Plan Sponsor, however, numerous market factors coupled with the unexpected and dramatic effects of the COVID-19 pandemic contributed to deterioration of the Plan Sponsor's financial condition. Because of consequent significant financial losses, the PCHA Board of Directors made the decision to permanently close the Plan Sponsor's inpatient and ancillary services effective July 30, 2020, impacting approximately 340 employees of the Plan Sponsor, however the associated physician practices continued to operate through the Plan Sponsor and were able to participate in the Plan. In April 2022, management transferred the employees of the Plan Sponsor's associated physician practices over to PCHA and terminated the Plan on September 30, 2022.

Effective with the termination of the Plan, all participants with an account balance remaining in the Plan became fully vested in all contribution sources, regardless of status or years of vested services. The Plan's termination ceased employee and employer contributions into the Plan and ceased new participant notes receivable from remaining Plan participants. Existing employees of the Plan Sponsor that become employees of PCHA will be eligible to participate in the available retirement plans of PCHA.

Plan Administration

A member of the Plan Sponsor has been designated as the Plan Administrator and as such is responsible for providing participants with information regarding rights and benefits under the Plan.

Contributions

After April 2022, no active participants remain in the Plan and therefore there are no participant contributions. Prior to that time, participants could make salary reduction contributions, including Roth contributions, to the Plan by electing to defer a specific percentage or dollar amount, limited to the maximum allowed under the Internal Revenue Code for such Plan year. The Plan also permitted participants to make catch-up contributions by the age of 50. Once participants completed 500 hours of service, the employer would make a matching contribution in an amount equal to 100% of the participant's deferral contributions up to 1% of the participant's compensation and an additional 50% of the participant's elective deferrals from 1% to 6% of the participant's compensation. In addition, the Plan accepted rollover contributions from other eligible retirement plans.

The Plan had an automatic enrollment feature where once an employee becomes eligible for the Plan, 8% of their eligible compensation was deferred. The amount would increase by 1% each Plan Year until the amount withheld reached 10% of the participant's compensation.

Participant Investment Options

Each Plan participant had the right to direct contributions and earnings of their account among investment vehicles provided under the Plan. Participants should refer to the most recent annual report of each investment fund for information on risk factors, asset concentrations, use of derivative financial instruments and other financial data. Participants could transfer funds between investment options at any time.

Participant Accounts

Prior to Plan termination, each participant's account was credited with the participant's elective deferrals, participant rollover contributions, employer contributions, and plan earnings (losses). Allocations were based on participant earnings or account balances, as defined. In addition, expenses to the Plan could be charged pro rata to each Participant in relation to the size of each Participant's account or could be charged equally to each Participant.

After the Plan termination, each participant's account is credited with an allocation of plan earnings (losses) and charged with benefit payments and administrative expenses.

Vesting

Participants are always 100% vested in their elective deferrals, including Roth 401(k) deferrals, catch-up contributions, and rollover contributions. The participant's vested percentage was attributable to matching contributions determined by the following schedule:

As previously disclosed, effective with the decision to terminate the Plan, all participants with account balances remaining in the Plan will become fully vested in all contribution sources, regardless of status or years of vested services.

Payment of Benefits

Upon retirement (normal retirement age is 65), attainment of age 59½, death, disability, or other termination of employment, as defined in the Plan document, participants or their spouses and/or beneficiaries receive their account as a lump sum cash payment. If the participant's account balance does not exceed \$5,000, the entire vested balance will be distributed in a single lump-sum payment in cash. If the participant's account balance exceeds \$5,000, the participant can receive a distribution of their vested account balance in a single lump-sum payment in cash, installments over a period of not more than the participant's assumed life expectancy, partial distributions, or an alternative annuity.

The Plan allowed for hardship withdrawals for certain participant needs as defined in the Plan document from participant elective contributions and related earnings. The employer had sole authority to authorize hardship withdrawals, pursuant to the Plan specifications.

Forfeitures

Individual accounts were forfeited when a participant terminated employment before being fully vested, and the non-vested portion of the terminated participant's account balance remains. Forfeitures could be used to reduce employer contributions or pay Plan administrative expenses. As of December 31, 2024 and 2023, forfeited non-vested accounts total \$17,771 and \$17,480, respectively. No forfeitures were used in 2024.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

Due to the decision to terminate the Plan, management determined that liquidation of the Plan is imminent and the financial statements as of December 31, 2024 and 2023 and for the year ended December 31, 2024, have been prepared using the liquidation basis of accounting. The accounting and reporting policies of the Plan conform to accounting principles generally accepted in the United States of America and to general practices within the employee benefit plan industry. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates. The principles and policies which significantly affect the determination of net assets available for benefits in liquidation and the changes in net assets available for benefits in liquidation are summarized below.

Under the liquidation basis of accounting, the Plan recorded the following cumulative effect adjustments to the statements of net assets available for benefits in liquidation available for benefits as of December 31:

Investment Valuation and Income Recognition

All investments in the statements of net assets available for benefits in liquidation as of December 31, 2024 and 2023, are reported at liquidation value. For all investments fair value approximates the amount the Plan expects to collect upon liquidation.

Mutual funds are stated as determined by quoted market prices, which represents the net asset value of shares held by the Plan at year end. The Plan's interest in the group annuity contract is valued based on the information provided by the issuer and is carried at the contract value which approximates fair value. See Note 6 for further information with respect to the Plan's investment contract.

Purchases and sales of securities are recorded on a settlement-date basis. Interest income and dividends are recorded on the liquidation basis, including amounts expected to be earned through the final distribution of Plan assets. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

Expenses of maintaining the Plan may be paid by the Plan Sponsor or by the Plan.

Subsequent Events

The Plan has evaluated subsequent events through January 5, 2026, the date the financial statements were available to be issued.

Note 3. Tax Status

The Plan operates under a non-standardized adoption agreement in connection with a prototype retirement plan and trust document sponsored by Great-West Trust Company, LLC (Great-West). This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 4. Exempt Party-In-Interest Transactions

Certain plan investments are managed by Empower Trust Company, LLC (formerly Great-West). Empower Trust Company, LLC is the trustee as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. There were no fees paid to Empower by the Plan for administrative services for the year ended December 31, 2024.

All other Plan administrative expenses for the year ended December 31, 2024 and 2023 were paid by the Plan Sponsor and not charged to the Plan. Additionally, certain administrative functions are performed by employees of the Plan Sponsor at no cost to the Plan.

Note 5. Investment Information Certified by the Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits in liquidation as of December 31, 2024 and 2023.
- Investment income as shown in the statement of changes in net assets available for benefits in liquidation for the year ended December 31, 2024.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 6. Investment Contract with Insurance Company

The Plan is invested in a fully benefit responsive group annuity contract with Empower Insurance Company of America (Empower). The fund invests in a group annuity insurance contract with Empower with the purpose to fund the guaranteed benefits for the Plan.

The group annuity contract is fully benefit-responsive; therefore, contract value is the relevant measurement attribute for that portion of the net assets available for benefits in liquidation attributable to the Plan. Contract value, which approximates fair value, as reported by the Plan, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

Upon discontinuance of the contract, contract value would be paid no later than 75 days from the date notice of discontinuance is provided. The contract does not have provisions to settle at a value other than contract value. The fund is not backed by specific securities but instead is backed by Empower's general account.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. The crediting interest rate for the years ended December 31, 2024 and 2023 is 1.70% and 1.55%, respectively. A single crediting rate is applied to all contributions made to the fund regardless of the timing of those contributions. Such interest rates are reviewed on a quarterly basis.

Note 7. Fair Value Measurement

Fair value as defined under GAAP is an exit price, representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3** Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds

Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits in liquidation up through the Plan's termination.
