## INDEPENDENT AUDITORS' REPORT

**To the Trustees of

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have audited the accompanying financial statements of Wholesale Supply Group, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). ### **Opinion**

**(1) DESCRIPTION OF PLAN**

The following description of the Wholesale Supply Group, Inc., 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all full-time employees of Wholesale Supply Group, Inc. (the Company) who have one year of service and are age twenty-one or older if hired on or after November 1, 1993. Anyone hired prior to November 1, 1993 is immediately eligible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established on August 1, 1993.

**Contributions**

Participants direct the investment of their contributions into an insurance investment contract offered by the Plan. The participants have various investment options within the insurance contract. The Company contributes 50 percent of the first 3 percent of base compensation that a participant contributes to the Plan. Additional amounts may be contributed at the option of the Company's board of directors.

**Participant accounts**

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contribution, (b) Plan earnings (losses), and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants are vested 20 percent in account balances after two years of service and an additional 20 percent for each succeeding year. An employee is 100 percent vested after six years of service.

**Payment of benefits**

Upon disability, retirement, termination of service, or death, a participant or beneficiary may elect to receive a lump-sum payment equal to the value of his account, or in installments over a fixed period of time. If a participant dies before retirement, their death benefits will be paid to their beneficiary in an amount equal to the vested account balance. All participants must begin withdrawing benefits no later than April 1st following the year in which the participant attains the applicable required minimum distribution age.

**Forfeited accounts**

At July 31, 2025 and 2024, forfeited nonvested accounts totaled \$733 and \$1,645, respectively. These accounts will be used to reduce future employer contributions. No employer contributions were reduced from forfeited nonvested accounts in 2025 or 2024.

**(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

**Use of estimates**

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment valuation and income recognition**

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will receive their non-forfeitable accrued benefit.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of withdrawals and certain advisory services are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

**Payment of benefits**

Benefits are recorded when paid.

**(3) CERTIFIED INVESTMENTS AND INVESTMENT INCOME**

The Plan has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower has certified that the following information, as well as the investment information in the notes to the financial statements and information included in the supplemental schedule as of and for the years ended July 31, 2025 and 2024 are complete and accurate.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**(4) INVESTMENT CONTRACT WITH INSURANCE COMPANY**

In 1993, the Company entered into a fully benefit-responsive investment contract with Great-West Life & Annuity Insurance Company. Great-West maintains the contributions in the general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the plan. The crediting rate is based on a formula established by the contract issuer. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Great West, represents contributions made under the contracts, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at July 31, 2025 and 2024 was \$488,745 and \$460,194.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents, (2) failure to comply with any provision contained in the contract, (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, (4) failure to qualify or become disqualified under Internal Revenue Code Section 401(a), as amended, or any required prohibited transaction exemption under ERISA, (5) premature termination of the contract. The plan administrator does not believe that any events which would limit the plan's ability to transact at contract value with participants are probable of occurring.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from the contract value. Such events include (1) the total amount of deposit received by the Company in the preceding twelve months is less than \$25,000, (2) the sum of all Participant Annuity Account Values falls below \$25,000, (3) the Group Contract holder fails to make deposits which have been deducted from participants' paychecks within 90 days of the date on which such deduction was made, (4) transfers to investment vehicles outside the Group Annuity Contract exceed 10% of the value of the Guaranteed and Variable sub accounts at the beginning of the calendar year

**(5) FAIR VALUE MEASUREMENTS**

FASB ASC 820-10 defines fair value as the price the Plan would receive upon selling an investment in an orderly transaction to an independent buyer in the principal or most advantageous market for the investment. FASB ASC 820-10 established a three tier hierarchy of inputs to establish a classification of fair value measurements for disclosure purposes. The three levels of the fair value hierarchy under FASB ASC 820-10 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted market prices that are observable for the asset or liability; (4) inputs that are derived principally from corroborated observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Pooled separate accounts - while some pooled separate accounts may have publicly quoted pricing inputs, the account values of separate accounts are not publicly quoted and are therefore classified as level 2 investments.

The Plan's policy is to recognize transfers of investments into or out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended July 31, 2025 and 2024, there were no transfers of investments into or out of Level 3.

**(6) PARTY IN INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by Great-West Life & Annuity Insurance Company, the custodian as defined by the Plan, and are managed by Empower Retirement Advisory Services and Ray M. Donohoo, advisors to the plan. These transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$6,835 for the year ended July 31, 2025.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**(7) INCOME TAX STATUS**

The Internal Revenue Service has determined and informed the Company by a letter dated November 14, 2022, that the plan is qualified, under the Internal Revenue Code (IRC). Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed, and being operated, in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified as of the financial statement date. Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**(8) RISK AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**(9) SUBSEQUENT EVENTS**

In preparing these financial statements, management has evaluated events and transactions for potential recognition or disclosure through February 3, 2026, the date which these financial statements were available to be issued.
