To Whom It May Concern:

I am writing on behalf of the Hypertrophic Cardiomyopathy Association (EIN 41-1855605) to respectfully request abatement of the \$750 late-filing penalty assessed for Form 5500 related to our 401(k) plan (Plan Number 316183).

The failure to timely file Form 5500 was due to an administrative error during our transition from ADP to Insperity as our professional employer organization (PEO). At the time of the transition, we mistakenly believed that Insperity would assume responsibility for filing the Form 5500. We later learned that the filing responsibility remained with ADP for 2024.

This oversight was unintentional and occurred despite our good-faith effort to comply with all reporting and regulatory requirements. Upon discovering the error, we acted promptly to address the issue and to ensure future compliance. We have since clarified filing responsibilities with our service providers and engaged Insperity to support ongoing payroll, benefits administration, and compliance oversight.

We respectfully request penalty abatement based on reasonable cause, as this was an isolated administrative error during a service-provider transition and not the result of willful neglect. We remain committed to full compliance with all IRS and Department of Labor requirements moving forward.
