Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

These additional procedures included comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. For information included in the supplemental schedule that agreed to or is derived from

the certified investment information, we compared such information to the related certified investment information.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Lazer Spot, Inc. 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan, established on March 1, 2003, that covers all eligible employees of Lazer Spot, Inc. (the “Company” or “Plan Sponsor”). The Plan qualifies as a safe harbor plan as described in Internal Revenue Code (“IRC”) sections 401(k)(12) and 401(m)(11) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Reliance Trust Company (the “Trustee”) is the Plan’s trustee. Automatic Data Processing, Inc. (“ADP”) Retirement Services is the Plan’s recordkeeper.

Eligibility

Employees who are at least 21 years of age and have three months of service with the Company are eligible to participate in the Plan as of the first day of the month coinciding with or following the date in which they satisfy the eligibility requirements. Employees who are regularly scheduled to work less than 1,000 hours per year, employees whose employment is governed by a collective bargaining agreement and does not call for participation in the Plan, and temporary and seasonal employees are excluded from eligibility in the Plan.

Contributions

Participants may make elective salary deferral contributions to the Plan, on a pretax or Roth basis, which are not to exceed statutory limits. Deferrals are limited to the lesser of 86% of a participant’s eligible compensation, as defined by the Plan, or the maximum amount allowable by the IRC. Participants 50 years of age or older may elect to make catch-up contributions up to the maximum amount allowable by the IRC. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Company provides a safe harbor matching contribution equal to 100% of the participant’s salary deferrals that do not exceed 4% of their eligible compensation. The safe harbor matching contribution is calculated and remitted to the Plan each payroll period.

The Company may also make a discretionary profit sharing contribution to the Plan. Only participants who are employed on the last day of the Plan year are eligible for the profit sharing contribution. The profit sharing contribution is allocated to each participant’s account based on their percentage of eligible compensation in comparison to total compensation of all eligible participants. For the year ended December 31, 2024, no profit sharing contributions were approved or made.

Participant Accounts

Participant accounts may be invested in one or more of the investment funds available under the Plan at the direction of the participant. Each participant’s account is credited with (a) participant’s contributions, (b) an allocation of Company contributions and (c) an allocation of investment earnings; and is charged with (a) withdrawals, (b) an allocation of investment losses and (c) administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are always 100% vested in their accounts attributable to salary deferrals including catch-up contributions, rollover contributions, safe harbor matching contributions, and discretionary profit sharing contributions. Accordingly, there are typically no forfeitures associated with participant accounts.

Payment of Benefits

Upon retirement, disability or death, a participant or beneficiary may receive the value of their account through a lump-sum distribution. In-service withdrawals are also permitted for participants who have attained age 59½. In general, if a participant's account balance, as defined in the Plan agreement, is greater than \$5,000 and employment is terminated other than due to retirement, disability, or death, the account may not be distributed before normal retirement age without the participant's consent. A participant's account balance less than \$5,000, but in excess of \$1,000 (the involuntary cash-out amount), will be paid as a direct rollover to an individual retirement account established by the Plan Sponsor for the benefit of the participant. However, regardless of a participant's election as to the payment, the Plan may, upon termination of service of a participant for any reason, pay the benefits owed in a lump sum if the account balance is less than the involuntary cash-out amount.

The Plan administrator may be required by law to recognize obligations the participant incurs as a result of court-ordered support or alimony payments. The Plan administrator must honor a qualified domestic relations order ("QDRO"). If a QDRO is received by the Plan administrator, all or a portion of the participant's account balance may be used to satisfy the obligation.

Hardship withdrawals are permitted if certain criteria are met, as defined by the Plan, and are subject to taxes in the year received by the participant. The Plan also allows in-plan Roth rollover contributions. Minimum required distributions for participants who have reached age 73 also apply per IRC regulations.

Distributions from the Plan will normally be subject to income taxes and in certain circumstances may also be subject to Internal Revenue Service ("IRS") penalties, unless the distribution is transferred to another qualified plan or individual retirement account.

Administrative Expenses

Administrative expenses relating to investment management, processing loans and distributions, and other recordkeeping fees are paid by the participants according to the Plan agreement. Other administrative expenses are paid by the Company and are not reported in these financial statements.

Notes Receivable from Participants

Plan participants may borrow from his or her fund accounts, a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance and can only have one loan outstanding at any time. Loan terms generally range from one to five years; however, if the loan is used for the purchase of a principal residence, the Plan administrator may permit a longer repayment term. The loans are secured by the balance in the participant's account and bear a reasonable rate of interest consisting of a fixed rate equal to the prime rate at the loan's inception plus one percent. Principal and interest payments occur ratably through regular payroll deductions. A participant loan totaling \$5,344 was transferred into the Plan during 2024.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investments Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a description of fair value measurements.

Income from investments is recognized when earned. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant's loan to be in default, the participant's loan balance is reduced and a benefit payment is recorded.

Benefit Payments

Benefit payments are recorded when paid, which is generally when incurred by the Plan.

Investment Expenses

Investment expenses charged by mutual funds and the collective trust fund at the individual participant level are included in net appreciation in fair value of investments.

Risks and Uncertainties

Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in risk in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Subsequent Events

The Plan evaluated its December 31, 2024 financial statements for subsequent events through October 15, 2025, the date the financial statements were available to be issued. There were no events that require adjustment to or disclosure in these financial statements.

NOTE 3 - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board Accounting Standards Codification (“ASC”) Topic 820, *Fair Value Measurements and Disclosures* (“ASC 820”) provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: valued at the quoted active market prices of shares held by the Plan at year-end.

Collective Trust Fund: valued at net asset value (“NAV”). The NAV is used as a practical expedient to estimate fair value and is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. The Putnam Stable Value Fund (the “Fund”) is a collective trust stable value fund with an intended purpose of providing stable principal and high current income. The Fund invests directly or indirectly in fully benefit-responsive investment contracts, and similar contracts issued by insurance companies, banks and other financial institutions. The Fund’s units are issued and redeemed daily at the constant NAV of \$1 per unit. Participant transactions (purchases and sales) may occur daily. There are no unfunded commitments or redemption restrictions. Certain events may limit the ability of the Fund to transact at the established NAV, such as mergers, mass layoffs, plan terminations, reorganizations, spin-offs and other events within the control of the Fund. Plan management believes that occurrence of these events and circumstances that would cause the Fund to transact at an amount different from the reported NAV is not probable.

The preceding methodologies described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Changes in Fair Value Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

The Company evaluated the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024 there were no transfers in or out of Levels 1, 2, or 3.

NOTE 4 - INFORMATION CERTIFIED BY TRUSTEE

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income, other income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue the contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will remain 100% vested in their accounts.

NOTE 6 - TAX STATUS

The Plan is operating under the ADP Retirement Services Prototype 401(k) and Profit Sharing Plan No. 5. ADP Retirement Services, which received an opinion letter from the IRS on October 6, 2020, stating that the prototype plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving this opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes is included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other applicable taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, and for the year ended December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the Plan's financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, the Plan is not currently under audit with respect to any tax periods in progress.

NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS

The Plan paid certain expenses related to operations and investment activity to various service providers. These transactions and transactions related to notes receivable from participants are party-in-interest transactions as defined by ERISA.
