Independent Auditors' Report

To the Administrative Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the SSP Innovations, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of February 15, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period January 1, 2023 to February 15, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of SSP Innovations, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of February 15, 2023 and December 31, 2022, and for the period of January 1, 2023 to February 15, 2023, stating that the certified investment information as described in Note 9 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statement section –

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of SSP Innovations, LLC 401(K) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Note 1: Description of Plan

The following brief description of the SSP Innovations, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Plan Merger

On February 15, 2023, the Plan merged into the Insuperity 401(k) Plan. An aggregate of \$18,237,552 was transferred out of the Plan during the period January 1, 2023 to February 15, 2023, and is included on the 2023 statement of changes in net assets available for benefits. As of the date of the merger, the Plan no longer had an interest in the SSP Innovations, LLC 401(k) Plan. The following disclosures apply to the Plan prior to the date of the merger.

General

The Plan is a defined contribution plan covering substantially all full-time employees of SSP Innovations, LLC (the Company). The Plan excludes non-resident aliens, as defined in the Plan document, union employees subject to collective bargaining units, and residents of Puerto Rico. The Plan was established on January 1, 2017 and most recently restated on February 18, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan sponsor and administrator is SSP Innovations, LLC and Principal Life Insurance Company, the custodian of the Plan (the Custodian), is responsible for oversight of the Plan, the appropriateness of the Plan's investment offerings, and monitoring investment performance. Some administrative expenses for the Plan are paid directly by the Company and are therefore excluded from these financial statements.

Certification

The Plan's Custodian has certified to the accuracy of the investment transactions, recognition of income, expenses, and assets held as of February 15, 2023 and December 31, 2022.

Contributions

Participants may contribute pretax annual compensation to the Plan. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants who have reached the age of 50 before the end of the plan year are eligible to make catch-up contributions. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation. The Company makes Qualified Safe Harbor matching contributions of 3% of employee's compensation for all eligible employees and also matches 50% of elective deferral contributions which are over 3% but are not over 5%. The Company made no contributions to the Plan during the period from January 1 to February 15, 2023 as employee and Company contributions were made to the Insuperity 401(k) Plan during this period.

Participants Accounts

Each participant's account is credited with the participant's contribution and allocations of (a)

the Company's matching contribution and (b) Plan earnings and losses, and (c) may be charged with an allocation of administrative expenses that are paid by the Plan. Participant contributions are recorded in the period during which the Company makes payroll deductions from the participant's earnings. Earnings are allocated on a fund-by-fund basis on the ratio of the participant's investments in the funds. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective deferrals including catch-up contributions plus actual earnings thereon. Participants are also immediately vested in rollover contributions and qualified matching and nonelective contributions.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance, subject to limitations imposed by the Internal Revenue Service (IRS). A participant can only have two loans outstanding at a time. Loan transactions are treated as transfers between the investment fund and the participant loan fund. The term for the repayment of the loan may not exceed five years, unless the loan qualifies as a home loan, in which the term will be established by the Plan Administrator at the time of the loan however may not be more than 10 years. The loans are secured by the vested balance in the participant's account and bear interest at a rate determined by the plan administrator, and are based on prevailing rates at the time the loan is approved. At February 15, 2023 and December 31, 2022, loans to participants totaled \$-0- and \$53,971, respectively.

Payment of Benefits

On termination of service due to death, disability, or retirement a participant will receive a single lump-sum amount equal to the value of the participant's vested interest in his or her account. If the participants account is \$5,000 or less, the Plan may automatically roll the participants vested account to an IRA in a direct rollover if the participants vested account is more than \$1,000, the participant has not reached age 65, or the participant did not elect to have the vested account paid in a single sum or rolled to another retirement plan or IRA.

Forfeitures

In accordance with the Plan provisions, forfeitures may first be used to pay administrative expenses or to reduce employer contributions other than elective deferral contributions, qualified matching contributions and qualified nonelective contributions. Any remaining forfeitures will be reallocated to participant accounts. At February 15, 2023, and December 31, 2022, forfeited non-vested accounts totaled \$-0-. These amounts will be reallocated to participants in the same manner as employer contributions after paying administrative expenses. During the period January 1, 2023 to February 15, 2023, and for the year ended December 31, 2022, no amounts were reallocated to participants.

Administration of Plan Assets

Contributions are held and managed by Principal Life Insurance Company, the Custodian, who invests cash received, allocates interest and dividend income, and makes distributions to participants. Employees of the Company perform certain administrative functions for the Plan. Such employees do not receive compensation from the Plan.

Note 2: Summary of Significant Accounting Policies

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan's administrator to make estimates and assumptions that affect the reported amounts of assets and changes therein, and disclosure of contingent assets. Accordingly, actual results may differ from those estimates.

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with U.S. GAAP.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of February 15, 2023, and December 31, 2022. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income are recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note 2: Summary of Significant Accounting Policies, continued

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Note 3: Fair Value Measurement

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs are based upon quoted market prices for similar instruments in active markets, quoted prices for identical or similar instruments in markets that are not active, and model-based valuation techniques, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. The Plan had no Level 2 or Level 3 investments at February 15, 2023, and December 31, 2022. As of February 15, 2023, the Plan had no assets in the plan.

Note 4: Plan Termination

Refer to Note 1 for discussion of the merger with another plan. This plan was effectively terminated and participants became 100% vested at the date of the transfer.

Note 5: Tax Status

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Plan was restated on February 18, 2022. The related plan was not included in the letter; however, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator and sponsor believe the Plan's tax position would be upheld under examination. Therefore, no provision for income taxes has been included in the Plan's financial statements. The Plan is subject to routine audits by tax authorities; however, there are currently no audits of any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2020.

Note 6: Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds and securities managed by Principal Life Insurance Company, who is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amount to \$2,220 for the period from January 1, 2023 to February 15, 2023. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 7: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
