Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of RENISHAW, INC. EMPLOYEE SALARY SAVINGS PLAN, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of RENISHAW, INC. EMPLOYEE SALARY SAVINGS PLAN's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. - the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of RENISHAW, INC. EMPLOYEE SALARY SAVINGS PLAN and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

NOTE 1—PLAN DESCRIPTION

Renishaw, Inc. Employee Salary Savings Plan (the “Plan”) is a defined contribution plan designed to operate under the provisions of Section 401(k) of the Internal Revenue Code (“IRC”). The Plan covers all eligible employees of Renishaw, Inc. (the “Company”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The following description of the Plan provides only summary information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

ELIGIBILITY

Each employee is eligible to make pre-tax deferrals to the Plan and receive Company Discretionary Matching contributions on the first day of the month immediately following the month of employment by the Company.

An Eligible Employee employed on or before June 30, 2014 shall become a Participant with respect to Company Discretionary Profit-sharing contributions on the first day of the month immediately following the month of employment by the Company.

Effective July 1, 2014, each employee of the Company who has attained 21 years of age and has completed one year of service is eligible for the Company Safe Harbor and Company Discretionary Profit-sharing contribution. An eligible employee will commence participation on the July 1st or January 1st immediately following the satisfaction of the previously mentioned eligibility requirements.

Effective July 1, 2022, the Plan eliminated the age 21 eligibility requirement. Thus, any eligible employee who meets the applicable service requirement (none for deferrals and match; one Year of Service for safe harbor and nonelective contributions) enters the Plan on the next applicable Entry Date for the relevant type of contribution regardless of their age.

Effective April 21, 2023, the Plan was amended to permit Participants to take in-service distributions on or after attainment of age 59-1/2 from any contribution source within the Plan (for example, matching contributions or safe harbor contributions) so long as that source is fully vested at the time they request a distribution.

CONTRIBUTIONS

Each year, participants may elect to contribute up to 100% of pre-tax annual compensation as defined in the Plan to a maximum of \$23,500 for a calendar year-end 2025 and \$23,000 for 2024. Participants who are at least age 50 may make additional “catch-up” contributions of \$7,500 in 2025 and 2024. Participants may also rollover amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Effective October 1, 2023, an autoenrollment feature was added to the Plan. Unless participants choose a different percentage or elect not to defer, they are initially set up for deferrals of 5% of their compensation.

Based on the discretion of the Board of Directors, the Company may, subject to certain limitations, make a matching contribution to the Plan for each participant in accordance with the terms of the Plan document. For 2025 and 2024, the Company made a matching contribution of 50% of employee’s deferral, up to 1% of their wages. The Company’s matching contribution was \$221,093 for 2025 and \$231,259 for 2024.

NOTES TO FINANCIAL STATEMENTS

NOTE 1—PLAN DESCRIPTION (Continued)

CONTRIBUTIONS (Continued)

The Company makes safe harbor contributions to each of the eligible employees which equals to 3% of each participant's eligible compensation. The Company may also elect to make a discretionary profit-sharing contribution. This contribution is participant-directed. The Company's safe harbor contributions and discretionary profit-sharing contribution totaled \$1,905,724 for 2025 and \$1,900,882 for 2024.

PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's contribution, the Company's discretionary matching contribution, the Company's safe harbor contributions, and an allocation of the Company's discretionary profit-sharing contribution, if applicable, and Plan earnings. Allocations are based on participant contributions, plan compensation, or Plan earnings, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

VESTING

Participants are 100% vested in their elective deferral, rollover contributions, and employer's safe harbor contributions, plus actual earnings thereon. Vesting in the Company's matching and discretionary profit-sharing contributions portion of their accounts, plus actual earnings thereon, is based on years of continuous service. Participants earn 25% per year vesting on Company's contribution portion and are 100% vested after four years of credited service.

PAYMENT OF BENEFITS

Upon termination of service due to retirement, disability or death, a participant may elect to receive a lump-sum payment, installment payments, or annuity payments. Participants may receive distributions of their elective deferral contributions plus actual earnings thereon under certain financial hardship circumstances.

Participant may also receive in-service distribution upon reach of retirement age.

FORFEITURES

Forfeitures attributable to employer profit sharing contribution and/or matching contribution shall be used to restore any participant's account balance that was forfeited and for which the participant has repaid his or her vested distribution or has made a valid claim. Any remaining forfeitures shall be used first by the Company to offset administrative expenses of the Plan to the extent they are Plan expenses and not settlor expenses and then shall be used to reduce employer profit sharing contributions and/or matching contribution otherwise payable to the Plan. For each plan year that forfeitures are allocated, the plan administrator shall designate the specific employer contribution or contributions that the forfeitures reduce.

Forfeitures totaled \$12,944 in 2025 and \$13,860 in 2024. Forfeitures allocated to participants were \$13,230 in 2025 and \$32,127 in 2024. Forfeitures used to pay administrative expenses were \$-0- in 2025 and \$519 in 2024. Forfeitures available for future use are \$40 as of June 30, 2025 and \$-0- as of June 30, 2024.

NOTES TO FINANCIAL STATEMENTS

NOTE 2—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING

The accompanying financial statements have been prepared using the accrual basis of accounting.

USE OF ESTIMATES

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

The Plan's investments at June 30, 2025 and 2024 are held by Fidelity Management Trust Company ("Fidelity"). The Plan's investments, other than the Morley Stable Value Fund and Guaranteed Interest Accounts, are stated at fair value at June 30, 2025 and 2024. If available, quoted market prices are used to value investments. Investments having no quoted market price are reflected at their estimated fair value as determined by the investment manager. Investments in pooled separate accounts are valued at the net asset value of shares held by the Plan at year-end. Investments in common collective trusts are valued based on the market value of the underlying securities.

Morley Stable Value Fund ("Fund"), a common collective trust ("CCT"), is invested primarily in guaranteed investment contracts ("GICs") and synthetic investment contracts, and cash and cash equivalents. GIC and synthetic investments contracts are fully benefit-responsive investment contracts. The Fund is stated at contract value (principal balances of the contracts, plus accrued interest at the stated rate, less payments received and contract charges by the insurance company), which is approximate fair value, as determined by Fidelity. The contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The market yield for the Fund was 2.62% for 2025 and 2.21% for 2024; with blended net crediting rate was 3.00% as of June 30, 2025 and 2.86% as of June 30, 2024.

Market value events may limit the ability of the Fund to transact at contract value with the issuer. Market value events are events or conditions that occur which are outside of the normal operation of the Fund and lead to any Fund disbursements which have or will have a material adverse effect on the operations of the Fund and a financial effect on the investment contract or wrap issuer's interest hereunder.

Such events may include but are not limited to: Fund administration is amended or changed, merger or consolidation of investors, group terminations or layoffs, implementation of an early retirement program, termination or partial termination of the Fund, failure to meet certain tax qualifications, participant communication that is designed to influence participants not to invest in the Fund, transfers to competing options without meeting the equity wash provisions of the Fund, and plan sponsor withdrawals without the appropriate notice to the Fund and/or issuer.

In the normal course of business, such events or conditions would not limit the ability of the Fund to transact at contract value with the participants in the Fund. The Fund is managed to maintain a certain amount of liquidity to provide for the day-to-day liquidity needs of participants as well as the occasional market value event.

NOTES TO FINANCIAL STATEMENTS

NOTE 2—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

INVESTMENT VALUATION AND INCOME RECOGNITION (Continued)

Net appreciation (depreciation) on investments held represents the change in market value of the investments from the beginning of the Plan year (or date the investments were purchased, if later) to the end of the Plan year. Dividends, interest, and appreciation (depreciation) are included in investment income (loss).

NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

ADMINISTRATIVE EXPENSES

Expenses of the Plan, to the extent that the Company does not pay such expenses, may be paid out of the assets of the Plan.

NOTE 3—FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTES TO FINANCIAL STATEMENTS

NOTE 3—FAIR VALUE MEASUREMENTS (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2025 and 2024.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end.

Level 2 and Level 3 Fair Value Measurements

Level 2 and Level 3 Fair Value Measurements are not applicable to the Plan for 2025 and 2024.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with FASB ASC subtopic 820-10, certain investments that are measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy.

Money market funds are valued at the net asset value (“NAV”) of shares held by the Plan at year-end. NAV is determined by each fund's trustee based on the fair value of the underlying securities held less liabilities held by the fund. This practical expedient is not used when it is determined to be provable that the fund will sell the investment for an amount different than the reported NAV. Plan transactions (issuance and redemptions) may occur daily. There are no restrictions on a participant's ability to redeem investments. However, withdrawals prompted by certain events (e.g., termination of the managed income portfolio, changes in laws and regulations) may restrict a participant's ability to redeem the investment at its NAV.

NOTE 4—INFORMATION CERTIFIED BY CUSTODIAN

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the custodian of the Plan, has certified that the following data included in the accompanying financial statements and schedule is complete and accurate.

- a. Investments, as shown in the accompanying statements of assets available for benefits as of June 30, 2025 and 2024.
- b. Investment income, as shown in the accompanying statements of changes in assets available for benefits for the years ended June 30, 2025 and 2024.
- c. The schedule of assets (held at end of year) as of June 30, 2025, as shown on Schedule H - Line 4(i).

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTES TO FINANCIAL STATEMENTS

NOTE 5—NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow up to 50% of their vested account balance, with a maximum loan amount of \$50,000. Repayments of principal and interest are made in equal monthly installments over the specified loan period (generally five years) through payroll deductions. Interest rates are determined by following procedures that consider the rates issued by lending institutions under similar circumstances.

NOTE 6—RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Company provides to the Plan certain accounting and administrative services for which no fees are charged. In addition, the majority of the expenses of the Plan are paid by the Company.

Plan investments are managed by the trustees of the Plan. The Plan's third-party administrator was Profit Planners, LLC from July 2023 to September 2023. Profit Planners, LLC was considered a party-in-interest. The Plan's asset custodian from July 2023 to September 2023 was Principal, which is also considered a party-in-interest. Effective October 1, 2023, the Plan's custodian and third-party administrator is Fidelity Management Trust Company.

NOTE 7—PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan at any time subject to the provisions of ERISA. If the Company should decide to terminate the Plan, participants would become 100% vested in the Company contribution portion of their accounts.

NOTE 8—TAX STATUS

The Company was a Prototype Non-Standardized 401(k) Plan ("Prototype Plan") sponsored by Principal Life Insurance Company which was adopted by the Company on July 1, 2014. The Prototype Plan obtained an opinion letter, but not a determination letter, in which the Internal Revenue Service ("IRS") stated that the Prototype Plan, as then designed, was in compliance with the applicable requirements of the IRC.

Effective July 1, 2022, the Company adopted a Non-Standardized Pre-Approved Profit Sharing ("Pre-Approved Plan") sponsored by Profit Planners, LLC. The Pre-Approved Plan obtained an opinion letter in which IRS stated that the Pre-Approved Plan, as then designed, was acceptable for use by the Plan under IRC. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement dates.

Effective October 1, 2023, the Company adopted a Pre-Approved Defined Contribution Plan designed by Fidelity Management & Research Co. The Pre-Approved Defined Contribution Plan obtained its latest opinion letter on June 30, 2020. The Company has not applied for its own determination letter from the IRS. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement dates.

NOTES TO FINANCIAL STATEMENTS

NOTE 8—TAX STATUS (Continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of June 30, 2025, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9—RISKS AND UNCERTAINTIES

The Plan may invest in various investments. Investments are exposed to various risks, such as interest rate, market, liquidity, and credit risks. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for Plan benefits.

NOTE 10—PROHIBITED TRANSACTIONS

During the plan year ending June 30, 2024, the Company failed to transmit participant contributions within the timeframe required by DOL Regulation 2510.3-102 totaling \$83,542 for 2024. \$83,542 was remitted to the Plan during the plan year ending June 30, 2024 along with the participants' lost earnings.

NOTE 11—SUBSEQUENT EVENTS

Management has evaluated subsequent events through January 23, 2026, the date which the financial statements were available for issue. Except as disclosed elsewhere in the financial statements, there were no other subsequent events which require disclosure.
