### Note 1. Description of the Plan

The following description of the Blue Ridge Bankshares, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### General:

The Plan is a defined contribution plan covering substantially all employees of Blue Ridge Bankshares, Inc. (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The trustee of the Plan is Alerus Financial, N.A. ("Alerus" or the "trustee") and it meets the definition of a qualified institution as defined in 29 CFR 2520.103-5 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA.

#### Contributions:

Each year, participants may contribute up to 95 percent of eligible compensation, as defined in the Plan. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan does not allow for contributions into the employer common stock. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions are invested in a designated balanced fund until changed by the participant. The deferral rate will increase by 1 percent each year until it reaches a maximum deferral rate of 6 percent. The Company contributes a Safe Harbor matching contribution of 100 percent of the first 5 percent of base compensation that a participant contributes to the Plan. Additional discretionary and profit-sharing amounts may be contributed at the option of the Company's Board of Directors. To be eligible for Company profit sharing contributions, participants must work 1,000 hours during the Plan year and be employed on the last day of the year, as defined. During the year ended December 31, 2024, the Company made \$1,869,684 in Safe Harbor matching contributions to the Plan. There were no discretionary or profit-sharing contributions for the year ended December 31, 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### Participant accounts:

Each participant's account is credited with the participant's contributions, Company contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting:

Participants are vested immediately in their voluntary contributions, and Company Safe Harbor matching contribution plus actual earnings thereon. Vesting in the Company's discretionary and profit sharing contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after 6 years of credited service.

#### **Note 1. Description of the Plan, Continued**

##### Notes receivable from participants:

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is one percent above prime rate and is fixed at the time of loan origination, as defined by the Plan. Principal and interest are paid ratably through payroll deductions.

##### Payment of benefits:

On termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or the installment options as provided by the Plan. Hardship distributions are permitted upon demonstration of financial hardship. All fully vested balances are available for distribution after the participant reaches the age of 59½.

##### Forfeited accounts:

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$4,159 and \$7, respectively. These accounts will be used to reduce any nonelective or matching contributions. During 2024, no forfeited nonvested accounts were used to reduce Company contributions.

##### Put option:

Under Federal income tax regulations, the employer common stock that is held by the Plan and its participants and is not readily tradeable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of the employer common stock distributed to participants for which there is no market. The put price is determined as of the most recent valuation date (each December 31) under the Plan. The Company can pay for the purchase with interest over a period of five years if fair market value of stock exceeds a specified limit as described in the Plan. Currently, the stock is readily tradable on an established market.

##### Voting of employer common stock:

With respect to any corporate matter which involves the voting of such shares at a shareholder meeting and which constitutes a merger, consolidation, recapitalization, reclassification, liquidation, dissolution, or sale of substantially all assets of a trade or business or a similar transaction specified in the regulations under Section 409(e)(3) of the Code, each participant will be entitled to give confidential instructions to the Trustee as to the voting rights attributable to the shares allocated to the participant's account. In that event, any allocated Company stock with respect to which voting directions are not given by the participant shall be voted by the Trustee as the Trustee, in its sole discretion shall deem appropriate.

Each participant is entitled to direct the Trustee as to the manner in which the Company stock which is entitled to vote and which is allocated to the Company stock account of such participant is to be voted. If the Trustee does not timely receive voting directions from a participant, the Trustee shall vote such Company stock.

#### **Note 2. Summary of Significant Accounting Policies**

##### Basis of accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein. Actual results could differ from those estimates.

##### Contributions:

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

##### Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

##### Payment of benefits:

Benefits are recorded when paid.

##### Expenses:

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and other distributions to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

##### Reclassification:

Certain reclassifications have been made to prior years' financial statements in order to conform with the current year presentation.

#### Subsequent events:

The Plan has evaluated subsequent events through February 4, 2026, the date the financial statements were available to be issued.

#### Recently issued accounting pronouncements:

Accounting standards that have been issued or proposed by the Financial Accounting Standards Board (FASB) or other standards-setting bodies are not expected to have a material impact on the Plan's financial statements.

### Note 3. Trustee Certifications

#### Note 5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Company common stock: Valued at the closing price reported on the active market on which the individual securities are traded.

Mutual funds: Valued at the closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market fund: The money market fund is invested in the Alerus Money Market Fund. Fair value is based on the NAV that can be validated with a sufficient level of observable activity (i.e., purchases and sales at NAV).

#### Note 6. Related-Party and Party in Interest Transactions

Certain Plan investments are managed by Alerus. Alerus is the trustee as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made direct payments to the third-party administrator totaling \$112,843 which were not covered by revenue sharing. The Company pays directly any other fees related to the Plan's operations.

#### Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their Company discretionary and profit sharing contributions.

#### Note 8. Tax Status

The Company has adopted a pre-approved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax provisions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for benefits.

### **Note 10. Subsequent event**

Effective January 1, 2025, the Plan document was amended to analyze employee deferrals and employer match based on the plan year instead of each pay period.

Effective January 1, 2026, the Plan document was amended to increase the eligibility service period from immediate to 3 months of services, the safe harbor match formula was adjusted from 100% of the first 5% of eligible compensation to the first 4% of eligible compensation deferred, and the eligible compensation definition expanded exclusions to include bonuses and various other fringe benefits.
