Note 1. Description of the Plan

The following brief description of the Blue Ridge Bankshares, Inc. Employee Stock Ownership Plan (the "Plan") provides only general information. Participants should refer to the Plan documents for a more complete description of the Plan's provisions.

General:

The Plan is an employee stock ownership plan sponsored by Blue Ridge Bankshares, Inc. (the "Company" or "Plan Sponsor"). The Plan covers substantially all employees of the Company. The Plan operates, in relevant part, as an employee stock ownership plan ("ESOP") and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended ("IRC") and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan has been designed to enable the Company to contribute common stock of the Company to its employees. The trustee of the Plan is Alerus Financial, N.A. ("Alerus" or the "trustee"). As of December 31, 2024, the Trustee of the Plan was Robin Due.

Transfer of plan assets:

The Board of Directors of the Plan Sponsor voted on November 17, 2021, to transfer the Plan matching fund account balances into the Blue Ridge Bankshares, Inc. 401(k) Plan effective December 31, 2021. As of December 31, 2021, the matching fund account balances of \$708,367 in cash and 101,778 shares of Blue Ridge Bankshares common stock were transferred to the control of Blue Ridge Bankshares, Inc. 401(k) Plan.

Plan termination:

On April 20, 2022, the Company's Board of Directors voted to terminate the Plan. Upon this date, all active participants became 100 percent vested.

Participants accounts:

Each participant's account was credited with the Company contributions, and is credited with allocations of Plan earnings. Participant accounts were charged with an allocation of administrative expenses that are paid by the Plan. Allocations were based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting:

All participants were 100 percent vested upon plan termination.

Payment of benefits:

On termination of service due to death, disability, retirement, hardships or other reasons, a participant or beneficiary may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account or in annual installments.

Put option:

Under Federal income tax regulations, the employer common stock that is held by the Plan and its participants and is not readily tradeable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of the employer common stock distributed to participants for which there is no market. The put price is determined as of the most recent valuation date (each December 31) under the Plan. The Company can pay for the purchase with interest over a period of five years if fair market value of stock exceeds a specified limit as described in the Plan. Currently, the stock is readily tradable on an established market.

Voting of employer common stock:

With respect to any corporate matter which involves the voting of such shares at a shareholder meeting and which constitutes a merger, consolidation, recapitalization, reclassification, liquidation, dissolution, or sale of substantially all assets of a trade or business or a similar transaction specified in the regulations under Section 409(e)(3) of the Code, each participant will be entitled to give confidential instructions to the Trustee as to the voting rights attributable to the shares allocated to the participant's account. In that event, any allocated Company stock with respect to which voting directions are not given by the participant shall be voted by the Trustee as the Trustee, in its sole discretion shall deem appropriate.

Each participant is entitled to direct the Trustee as to the manner in which the Company stock which is entitled to vote and which is allocated to the Company stock account of such participant is to be voted. If the Trustee does not timely receive voting directions from a participant, the Trustee shall vote such Company stock.

There were no unallocated shares as of December 31, 2024 or 2023.

Diversification:

Diversification is offered to participants close to retirement so they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who have attained age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25 percent of the number of post-1986 shares allocated to the participant's account, less any shares previously diversified. In the sixth year, the percentage increases to 50 percent. As of December 31, 2024 and 2023, there have been no participants that have elected this option.

Note 2. Summary of Significant Accounting Policies

Basis of accounting:

Due to the decision to terminate the Plan during 2022, the financial statements have been prepared using the liquidation basis of accounting.

Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Cash:

The Plan maintains cash balances at certain banks which at times may exceed the Federal Deposit Insurance Corporation limits. The Plan's non-interest bearing cash balances were insured to a maximum amount of \$250,000 per depositor at each financial institution as of December 31, 2024 and 2023.

Investment valuation and income recognition:

Investments are reported at liquidation value. Fair value approximates the amount the Plan expects to collect at liquidation. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on settlement-date basis. Interest income and dividends are recorded on the liquidation basis, including amounts expected to be earned through the final distribution of Plan assets. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits:

Benefits are recorded when paid. The Company expects all benefits to be distributed and the Plan to be fully liquidated during the first quarter of 2026.

Expenses:

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent events:

Management of the Plan has evaluated subsequent events through February 4, 2026, which is the date these financial statements were available to be issued.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023:

Money market fund: The money market fund is invested in the Vanguard Federal Money Market Fund. Fair value is based on the net asset value (NAV) that can be validated with a sufficient level of observable activity (i.e. purchases and sales at NAV).

Company common stock: Valued at the closing price reported on the active market on which the individual securities are traded.

Note 6. Related Party and Party-in-Interest Transactions

Certain Plan investments are managed by the trustee. Alerus is the trustee as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment as they are paid through revenue sharing, rather than direct payment. The Plan made direct payments to the trustee totaling \$1,725 which were not covered by revenue sharing. The Company pays directly any other fees related to the Plan's operations.

The Plan invests in Company common stock. These are related party and party-in-interest transactions.

Participant accounts are invested in the common stock of the Plan Sponsor.

Note 7. Plan Termination

As described in Note 1, the Plan Sponsor has elected to terminate the plan effective April 30, 2022. All participants became 100 percent vested in their Company contributions at that date.

Note 8. Tax Status

The Internal Revenue Service (the IRS) has determined and informed the Company by letter dated July 12, 2016, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. The plan administrator and Trustee believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Generally accepted accounting principles in the United States of America requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Risks and Uncertainties

The Plan investments consist primarily of the Company's closely-held common stock, which is exposed to various risks such as interest rate, market and credit risks, as well as valuation assumptions based on earnings, cash flows and/or other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the 2024 statement of net assets available for benefits.

Note 10. Subsequent Events

Since year end, the Plan Sponsor's stock has increased in value from \$3.22 per a share as of December 31, 2024 to \$4.27 per a share as of December 31, 2025. The closing stock price per share during 2026 has ranged between \$4.26 and \$4.42 per a share prior to financial statement issuance.
