## **INDEPENDENT AUDITOR'S REPORT**

Participants and Trustee  
Crean Lutheran High School 403(B) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Crean Lutheran High School 403(B) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statement of changes in net assets available for plan benefits for the years then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Crean Lutheran High School 403(B) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of June 30, 2025 and 2024, and for the years then ended, stating that the certified investment information, as described in Note 1 to the financial statements, is complete and accurate.

### **Opinion**

### NOTES TO THE FINANCIAL STATEMENTS

June 30, 2025 and 2024

#### **NOTE 1: DESCRIPTION OF THE PLAN**

The following description of the Crean Lutheran High School 403(B) Plan (the "Plan") provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering eligible employees who generally work 20 or more hours a week. The entry dates for the Plan are the first day of each calendar month coinciding with or following the date the employee meets the eligibility requirements. Beginning November 1, 2022, all eligible employees are automatically enrolled to contribute 3% to the plan unless they affirmatively elect not to participate. The Plan is designed to comply with Section 401(a) of the Internal Revenue Code as a defined contribution plan. The Plan is administered by Lutheran High South - Orange County, Inc. DBA Crean Lutheran High School (the "Organization"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and all requirements of Section 401(k) of the Internal Revenue Code.

#### **Plan Custodian and Recordkeeper**

Lincoln Financial Group Trust Company, Inc. ("Lincoln") acts as the custodian and recordkeeper. Lincoln has provided certifications that the information provided for the years ended June 30, 2025 and 2024 are complete and accurate.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at June 30, 2025 and 2024, and net depreciation and appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended June 30, 2025 and 2024, was obtained by the Plan Administrator and agreed to or derived from information certified as complete and accurate by Lincoln.

#### **Contributions and Funding Policy**

Based on their elections, Plan participants are entitled to defer up to 100 percent of their plan compensation up to the maximum contribution amount permitted under the Internal Revenue Code. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds and a guaranteed investment account. For the years ended June 30, 2025 and 2024, the Employer elected to make safe harbor matching contributions equal to 3% of the participant's plan compensation.

**Contributions and Funding Policy (continued)**

The Organization may, though not required to do so, make a discretionary contribution to all eligible participants. For the years ended June 30, 2025 and 2024, the Employer elected to make quarterly discretionary contributions equal to 5.3% of the participant's quarterly plan compensation. Contributions from the Organization are accrued by the Plan in the period when such contributions become an obligation of the Organization. The maximum participant elective contributions allowed under the Plan for the tax years ended 2025 and 2024 were \$23,500 and \$23,000, respectively (\$31,000 and \$30,500 for participants age 50 and over, respectively).

**Participant Account**

Each participant's account is credited with the participant's contribution and allocations of a) the Organization's contribution and b) plan earnings and charged with an allocation of certain expenses. Allocations are based on account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in employee, employer safe harbor matching, and employer discretionary contributions and related earnings thereon.

**Payment of Benefits**

Upon termination of service before the normal retirement age, a participant may elect to defer distribution until normal retirement age or receive a lump sum payment equal to the vested share of the participant's account. Benefits are available based on the vested share of the participant's accounts. Benefits can also be accessed in the event of disability or death. Additionally, the Plan allows participants to make early withdrawals for certain financial hardships.

**Forfeitures**

Forfeitures of non-vested contributions are used to either offset administrative expenses or reduce employer contributions. Forfeiture balances as of the years ended June 30, 2025 and 2024 were \$2,352 and \$2,206, respectively.

**Notes Receivable from Participants**

Loans to participants are authorized by the Plan Administrator who is responsible for determining the terms and conditions. These loans are available to all participants on a nondiscriminatory basis and secured by their account balance.

The loans generally must be repaid within five years, unless the loan is for the purchase of a personal residence. The Plan specifies that the rate of interest shall be a fixed rate of equal to the prime rate plus 1%. At June 30, 2025 there were 7 loans outstanding with an interest rate of 4.25% to 8.50%. Participant loans in the amount of \$70,131 at June 30, 2025 and \$80,799 at June 30, 2024 are included in the accompanying financial statements under the caption "Notes receivable from participants."

**NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements are presented on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

**Investment Valuation and Income Recognition (continued)**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses have been recorded for the years ended June 30, 2025 and 2024. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. For the year ended June 30, 2025 deemed distributions amounted to \$10,542. There were no deemed distributions for the year ended June 30, 2024.

**Payment of Benefits**

Benefits are reported when paid.

**Amounts Due Terminated Participants**

Amounts due terminated participants, if any, are included in net assets available for Plan benefits.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Organization. Expenses paid by the Organization are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation and appreciation of fair value of investments. Administrative and other expenses are recorded as incurred.

**Subsequent Events**

Subsequent events were evaluated through January 27, 2026, which is the date the financial statements were available to be issued.

**NOTE 3: FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1 – Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at measurement date.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly.

Level 3 – Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2025 and 2024.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities Exchange Commission. These funds are required to publish their net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following table sets forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of June 30, 2025 and 2024. Classification within the fair value hierarchy table is based on the lower level of any input that is significant to the fair value measurement.

**NOTE 4: GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY**

In 2015, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with The Lincoln National Life Insurance Company (“Lincoln National”). Lincoln National maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The guaranteed minimum interest rate is 1.0%. The crediting rate is based on a formula established by the contract issuer and is reviewed on a quarterly basis for resetting. For the years ended June 30, 2025 and 2024 the balance of the guaranteed investment contract was \$103,210 and \$145,948, respectively.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Lincoln National, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan's ability to transact at contract value with Lincoln National. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

**NOTE 5: PLAN TERMINATION**

Although the Organization has not expressed intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 6: TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated September 24, 2019, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**NOTE 7: RELATED PARTY TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by Lincoln, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$113,085 and \$90,387, respectively, for the years ended June 30, 2025 and 2024.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 8: RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 9: CORRECTIVE DISTRIBUTIONS**

During the year ended June 30, 2025, an operational error was identified related to employer discretionary contributions for a certain quarter of the Plan year. Employer discretionary contributions totaling \$2,331 were allocated to participants who were determined to be ineligible. Upon discovery, the Plan sponsor subsequently processed corrective distributions in the amount of \$2,331 in January 2026.

**NOTE 10: CORRECTIVE CONTRIBUTIONS**

During the year ended June 30, 2025, the Plan identified an operational error in which an eligible participant was not enrolled in the Plan on a timely basis in accordance with the terms of the Plan. In April 2025, to correct the operational error, the Plan Sponsor funded and contributed the participant's missed employee deferral opportunity of \$3,331 to the Plan along with an employer matching contribution of \$255. The Plan Sponsor also made an additional qualified nonelective contributive (QNEC) of \$899, including earnings, at that time on behalf of the participant.
