Managed Healthcare Partners, LLC was the Sponsor of the Caremax, Inc. 401(K) Plan (the "401K Plan"). On November 17, 2024, Caremax, Inc., et al (including Managed Healthcare Partners, LLC) (the "Debtor") filed a voluntary petition for relief under Chapter 11 of the Bankruptcy Code in the United States Bankruptcy Court for the Northern District of Texas (the "Court"). On January 31, 2025 the Court entered the *Findings of Fact, Conclusions of Law, and Order (I) Approving the Disclosure Statement on a Final Basis, and (II) Confirming the Third Amended Joint Chapter 11 Plan of CareMax, Inc. and its Debtor Affiliates* (the "Confirmation Order"), confirming the Bankruptcy Plan [Docket No. 587]. On February 3, 2025, the Effective Date of the Bankruptcy Plan occurred [Docket No. 596]. The Confirmation Order is final, non-appealable, and not subject to any pending appeal.

Through the Bankruptcy Plan, a Bankruptcy Plan Administrator was established to administer the Bankruptcy Plan and to make distributions to bankruptcy creditors. Advisory Trust Group, LLC was chosen to serve as the Bankruptcy Plan Administrator. Upon the Effective Date, the Bankruptcy Plan Administrator was vested with all of the power and authority set forth in the Bankruptcy Plan and otherwise as is necessary or proper to carry out the provisions of the Bankruptcy Plan, as applicable.

Prior to the Effective Date, the Debtor initiated the termination of the 401K Plan. Accordingly, the 401K Plan assets were recently fully distributed. The 2024 Form 5500 for the 401K Plan was prepared by ADP Retirement Services and signed by the Bankruptcy Plan Administrator, solely in this capacity. Accordingly, he cannot confirm the accuracy of all the information contained in the 2024 Form 5500.

For the reasons listed above, acceptance of the 2024 Form 5500 filing is requested.

## Reasonable Cause – Accountant’s Opinion

The plan sponsor, Managed Healthcare Partners, LLC, filed a voluntary petition for relief under Chapter 11 of the United States Bankruptcy Code on November 17, 2024. A bankruptcy plan was effective February 3, 2025 and a bankruptcy plan administrator was established to administer the bankruptcy plan.

As a result of the effective bankruptcy plan, information/documentation that would have been provided by the plan sponsor to the auditor was unavailable, so the opinion of an independent qualified public accountant was unable to be obtained for the 2024 Form 5500 filing. Additionally, the cost of meeting the requirement to obtain the opinion of an independent qualified public accountant would have been borne by the plan’s participants and would have served only to reduce the amounts available for distribution to those participants.

For the reasons listed above, exemption is requested from the requirement to obtain the opinion of an independent qualified public accountant for the 2024 Form 5500 filing.
