## Notes to the Financial Statements

### 1. Description of the Plan

The following description of the Tekla Research, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document and any amendments thereto for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan covering substantially all employees Tekla Research, Inc. (the Company or the Plan Sponsor) who have completed one month of service. Part-time employees who work more than 1,000 hours during the Plan year are also eligible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### *Trustee, Custodian and Administration of the Plan*

The trustee, custodian and recordkeeper of the Plan is Lincoln Financial Group Trust Company, Inc. (Lincoln). The administrator of the Plan is the Company. Lincoln holds all assets of the Plan in accordance with the service provider contract with the Company. The Plan Administrator determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### *Eligibility*

Employees of the Company are considered eligible for participation once they have completed one year of service, defined as 1,000 hours of service, except for: (1) individuals who are not reported in the payroll record as a common law employee; (2) individuals who became employees because of Code 410(b)(6)(c) transaction; and (3) individuals who are part-time who do not work at least 1,000 hours during the Plan year. Employees become eligible to participate upon completion of one month of service from their employment commencement date. There is no minimum age for Plan eligibility.

#### *Contributions*

Each year, participants may contribute up to 100% of their pretax annual compensation, as defined in the Plan up to the maximum amount available by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also allows in-Plan Roth rollover conversions and Roth contributions.

The Company may also make certain contributions to the Plan on behalf of Plan participants. The Company may make an employer discretionary matching contribution of 100% of the first 2% and 50% of the next 4% of elective deferral contributions made by participants to the Plan. The Company also contributes a non-elective safe harbor contribution to the Plan of 3% of each participant's eligible compensation. A discretionary profit-sharing contribution may be made at the option of the Company's management. A participant must complete three consecutive months of service during the Plan year prior to terminating employment in order to receive the discretionary profit-sharing contribution. During the year ended December 31, 2024, the Company did not make a discretionary

profit-sharing contribution to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

### ***Participant Accounts***

Each participant's account is credited with the participant's contributions, including amounts rolled over from other qualified plans, and the Company's matching and non-elective safe harbor contributions, as well as allocations of the Company's profit-sharing contribution, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are immediately vested in their voluntary contributions, rollover contributions, and non-elective safe harbor contributions, plus actual earnings thereon. Vesting in the Company's employer matching and profit-sharing contributions is based on years of continuous service. A participant vests ratably over five years of credited service or in the event of death or total and permanent disability.

### ***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to (i) the lesser of \$50,000, reduced by the highest outstanding balance of any prior loans from the plan during the prior one-year period or (ii) 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through monthly payroll deductions. The notes are repaid ratably through payroll deductions over a period of five years or less, unless used to purchase a principal residence up to 15 years. These loans are subject to certain restrictions as defined by the Plan Document and applicable restrictions under the Internal Revenue Code (IRC).

### ***Payment of Benefits***

Upon termination of service due to death, disability, retirement, termination of service or any other reason, a participant or beneficiary may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments, subject to certain rules as defined in the Plan. The Plan also allows for hardship withdrawals in the event of a proven financial hardship.

The Plan also provides for mandatory cash-out distributions. In the event that a participant's account balance is below \$7,000 upon termination of employment with the Company, the Plan will immediately distribute the account balance in a lump sum without the participant's consent. Participants who have account balances in excess of \$7,000 on the date of termination of employment with the Company, will be required to provide written consent for any such distribution or rollover to another Plan.

### *Forfeitures*

When an employee terminates prior to full vesting, the Plan's cumulative, unvested matching and profit-sharing contributions made on behalf of the participant, as well as earnings and losses thereon, are transferred to the Lincoln Stable Value Account as a forfeiture. Forfeitures may be utilized to reduce employer contributions or pay Plan expenses. After five consecutive one-year breaks in service, forfeitures of terminated, non-vested participant accounts are treated as additional discretionary contributions and allocated, based on Plan provisions, to participant accounts. Non-vested employees who have had breaks in service less than five years with the Company are eligible to restore to their account any forfeited employer contributions, subject to the Plan provisions.

As of December 31, 2024 and 2023, the total forfeiture balance included in the Lincoln Stable Value Account was \$7,425 and \$13,539, respectively. Forfeitures totaling \$88,803 were used to reduce employer contributions during the year ended December 31, 2024.

## **2. Summary of Significant Accounting Policies**

### *Basis of Accounting*

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### *Use of Estimates*

The preparation of financial statements in conformity with GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from estimated amounts.

### *Investment Valuation and Income Recognition*

Investments are reported at fair value, except for the Plan's direct investment in the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for additional information related to fair value measurements.

The Plan's shares of mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at the unpaid principal balances plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

### ***Payment of Benefits***

Benefits are recorded when paid.

### ***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

## **3. Certified Investment Information**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Lincoln, a qualified institution.

## **4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.

- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 or 2023. The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023:

## 5. Guaranteed Investment Contract with Lincoln Financial Group

The Plan invests in a fully benefit-responsive guaranteed investment contract through a group annuity contract with Lincoln National Life Insurance Company (LNLIC). LNLIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by LNLIC, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date without giving notice of such termination at least 90 days in advance of the termination date and electing one of the payment options in the contract specifications. Upon notice, the insurance company will immediately begin the process of termination and make the appropriate payout according to the timing specified under the payment option.

### **6. Related Party Transactions and Party-in-Interest Transactions**

Certain Plan investments are in funds and accounts that are managed by Lincoln. Participant loan and distribution processing fees are paid to Lincoln by participants. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

### **7. Income Tax Status**

Effective October 1, 2023, the Plan adopted the Non-Standardized Pre-Approved Profit Sharing Plan with CODA (Lincoln Pre-Approved Plan) established by Lincoln. The IRS ruled on June 30, 2020, that the Lincoln Pre-Approved Plan, including related amendments, as designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since the adoption of the Lincoln Pre-Approved Plan. The Plan Administrator believes the Plan is currently designed and is being operated in accordance with the IRC.

GAAP requires the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **8. Risks and Uncertainties**

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

### **9. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to reduce or discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

### **10. Subsequent Events**

The Plan Administrator has evaluated subsequent events through September 18, 2025, the date the financial statements were available to be issued. The Plan Administrator is not aware of any subsequent events which would require recognition or disclosure in the financial statements.
