### **Report on the Audit of the Financial Statements**

#### ***Opinion***

We have audited the financial statements of the RSS, LLC Employee Benefit Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and benefit obligations as of April 30, 2025 and 2024, and the related statements of changes in net assets available for benefits and changes in benefit obligations for the year ended April 30, 2025, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and the benefit obligations of the RSS, LLC Employee Benefit Plan as of April 30, 2025 and 2024, and the changes in its net assets available for benefits and its benefit obligations for the year ended April 30, 2025, in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. ## RSS, LLC Employee Benefit Plan Notes to Financial Statements

---

### Note 1 – Description of Plan

The following description of RSS, LLC Employee Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General** – The Plan provides health and welfare benefits to substantially all full-time employees of Rex Signature Services, LLC (Plan sponsor and Employer), who have at least 60 days of service, are regularly scheduled to work at least 30 hours per week, and are not covered by a collective bargaining agreement. Retirees, part-time employees who are scheduled to work less than 30 hours per week, and temporary employees are not eligible to participate in the Plan. Eligible employees (Participants) enter the Plan on the first day of the month following 60 days of service. The Plan also provides health benefits to eligible dependents of each participant. As required by the Consolidated Omnibus Budget Reconciliation Act (COBRA) of 1985, the Plan includes a continuation of coverage option to certain terminated, retired, and totally disabled participants and their covered dependents for a period not to exceed 18 months. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Contributions** – The Plan is funded through participant and employer contributions at a level sufficient to pay for the benefits provided by the Plan, which is developed by the Plan's third-party actuary annually. Participants electing medical and dental benefits are required to contribute specified amounts depending on the type of coverage. Participant contributions to the Plan are made on a pre-tax basis pursuant to §125 of the Internal Revenue Code.

**Self-insured benefits** – The Plan provides health benefits including medical, major medical, hospital, surgical, and dental services to eligible employees and to their covered dependents. Claims for these benefits are subject to various deductible and co-payment amounts. The Plan provides these benefits on a self-funded basis, subject to a stop loss limit. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only arrangements. The claims processors pay claims directly to providers on behalf of participants and then are reimbursed by the Plan. Despite the Plan's utilization of third-party claims processors, ultimate responsibility for payments to providers is retained by the Plan. The Plan also utilizes a pharmacy benefit manager that periodically makes rebates or refunds to the Plan based on the Plan's actual utilization pattern of specific drugs. Neither the Plan nor the Plan sponsor is entitled to the Medicare subsidy under the Medicare Prescription Drug Improvement and Modernization Act of 2003.

Employees who are offered coverage through a state approved apprenticeship program are not eligible for these health benefits under the Plan.

**Stop loss coverage** – In an effort to limit its exposure for self-insured benefits, the Plan sponsor maintains a stop loss insurance policy insuring the Plan. In the event that claims paid exceed certain deductible level per individual per year, benefits that exceed the deductible, if any, will be reimbursed by the insurance company. In 2025, the Plan submitted evidence and received approval for stop loss recovery of \$1,096,103. As of April 30, 2025 and 2024, receivable for stop loss recovery is \$188,229 and \$649,076, respectively.

### **Notes to Financial Statements**

---

**Insured benefits** – The Plan fully insures the life insurance benefits (basic, supplemental, and dependent), accidental death and disability benefits (basic, supplemental, and spousal), short-term disability, and vision benefits. The Plan sponsor purchases annual insurance contracts for these insured benefits. Premiums for basic life insurance and basic accidental death and dismemberment insurance programs are paid by the Employer, whereas premiums for all other insured benefits are paid by participants through payroll deductions.

**Flexible spending account** – The Plan has a flexible spending account (FSA) that is funded solely through participant contributions. Participants may specify dollars, subject to an annual limit, to be deducted from their pay on a pre-tax basis to be set aside for qualified out of pocket health expenses and/or dependent care expenses. In 2025, participants contributed \$95,457 towards the FSA. Any unused funds at the year-end are forfeited, with the exception of \$640 per participant, which are allowed to roll over into the following year. The Plan had no material forfeitures in 2025.

**Health savings account** – The Plan has a health savings account (HSA) for the exclusive benefit of its eligible participants, their legal spouses, and eligible dependents. The Employer makes an annual contribution of \$500 to enrolled individuals and \$1,000 for enrolled families. In 2025, the Employer contributed \$42,700 towards eligible HSA accounts; the participants contributed \$80,255 towards their HSAs.

Eligible participants may specify dollars, subject to an annual limit, to be deducted from their pay on a pre-tax basis to be set aside in their HSA accounts to pay current and future health care costs. The associated activity in their HSA accounts is excluded from the Plan's financial statements as the accounts are owned and maintained by the participants.

**Plan termination** – Although it has not expressed any intention to do so, the Plan sponsor has the right under the Plan to modify the benefits provided to and contributions required of participants, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits or on account of the participants. No assets of the Plan may revert to the Employer or be used for purposes other than for the exclusive benefit of the Plan's participants.

#### **Note 2 – Summary of Significant Accounting Policies**

**Basis of accounting** – The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Concentration of credit risk** – Certain Plan assets are held in a Voluntary Employees Beneficiary Association (VEBA) Trust (Trust). Each month, the Employer remits the amounts withheld from participants, as well as an Employer contribution, to the Trust accounts held at a bank. Deposits maintained in the Trust accounts are restricted for payments of Plan claims and FSA benefits. Accounts at the bank are insured by a government agency up to \$250,000. At times the balance in the Trust accounts may exceed the insured limit.

**Contributions receivable** – Participants and employer contributions due but not received at year-end are recorded as contributions receivable in the accompanying statements of net assets available for benefits.

**Flexible spending account** – The FSA is a component of the Plan; as such, unused amounts available to participants at year-end are included in the accompanying statements of net assets available for benefits, and the associated activity (contributions and benefits paid) is included in the accompanying statement of changes in net assets available for benefits. The available balance is \$20,222 and \$25,144 at April 30, 2025 and 2024, respectively.

**Health savings account** – The HSA is a component of the Plan; however, the associated activity (contributions and benefits paid) is excluded from the Plan's financial statements because the Plan is not obligated to pay the benefits.

**Payment of benefits** – Claim payments and FSA benefits are recorded when paid from the Plan's Trust accounts. Premiums are paid from the general assets of the Plan sponsor and are recorded when due as premium payments in the accompanying statement of changes in net assets available for benefits. There were no unpaid premiums at April 30, 2025 or 2024.

**Rebates and stop loss recovery** – Rebates from prescription drug programs are recorded when earned from the provider and netted with claims paid in the accompanying statements of changes in net assets available for benefits. Stop loss recovery is recorded when approved by the insurance company and is netted against payments for medical and dental claims paid in the accompanying statement of changes in net assets available for benefits.

**Administrative expenses and provider fees** – Fees for claim processing, FSA and HSA administration, health screening, and health network fees are paid by the Plan, which are recorded as expenses when incurred in the accompanying statement of changes in net assets available for benefits. All other administrative expenses are absorbed by the Employer.

**Subsequent events** – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued. The Plan has evaluated subsequent events through February 4, 2026, the date the financial statements were available to be issued.

#### **Note 3 – Benefit Obligations**

Qualified medical and dental costs incurred by participants and their dependents are covered by the Plan. At the end of any plan year, there may be claims that have been incurred by the participants and their dependents that have not yet been reported to the Plan, including claims related to those participants and their dependents who are covered under COBRA.

As of April 30, 2025 and 2024, incurred but not reported (IBNR) medical and dental claims are estimated to be \$845,300 and \$1,160,000, respectively.

This amount was determined by the Plan's third-party actuary subsequent to year-end using the lag factor method outlined in the Actuarial Standards of Practice from the American Academy of Actuaries, except for the last two months closest to the valuation date. This lag factor method used actual historical claims data up to 24 months from the Plan to develop the most likely completion factors specific to its own claim payment patterns. This historical claims data was presented as a lag triangle showing claims by incurred and paid dates. This data was used to calculate how complete each incurred month was for each month of payment. These completion factors were analyzed additionally to discover the variability inherent in the factors to determine an appropriate level of margin to include in the estimate. The two months closest to the valuation date were developed using a projection methodology by projecting historical incurred claims per employee per month forward and checking this for reasonableness against what was paid as of the valuation date.

The valuation did not take into consideration of any anticipated reimbursements for stop loss for claims that were incurred prior the valuation date but that were not received as of the valuation date. Additionally, the valuation did not take into consideration of any prescription drug rebates, or any administrative fees that would result from processing runout claims in the event of a contract termination (if any). As such, there is a reasonable possibility a significant change in this estimate could occur in the near term. The Employer is obligated to contribute amounts necessary to pay for the benefits of the Plan, which may ultimately exceed the estimate.

#### **Note 4 – Party-in-Interest Transactions**

The Plan sponsor has contracts with several third parties for administrative services. Benefit & Risk Management Services, Inc. processes medical and dental claims, Igoe & Company, Inc., administers the FSA and HSA benefits, HealthCheck 360 (a division of Butler HealthCorp Inc.) provides employee wellness services, Health Advocate provides employee advocacy services, PrudentRx provides pharmacy management, and Anthem Blue Cross and Blue Shield provides network services. In 2025, the Plan paid \$573,356 for services provided by the parties-in-interest.

#### Note 5 – Tax Status

The VEBA Trust established under the Plan to hold the Plan's assets obtained an exemption letter dated June 30, 1992, in which the Internal Revenue Service stated that the Trust, as then designed, was tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code (Code). The Plan and Trust are required to operate in conformity with the Code to maintain the tax-exempt status of the Trust. Although the Trust has been amended since receiving the determination letter, the Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code, and therefore believes the related Trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
