Independent Auditors' Report

To the Plan Administrator
Better Community Living, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Better Community Living, Inc. 401(k) Plan (f/k/a 401(k) Profit Sharing Plan for Employees of Better Community Living, Inc.) (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of June 30, 2025 and December 31, 2024, and the related statement of changes in net assets available for benefits (modified cash basis) for the period of January 1, 2025 to June 30, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of June 30, 2025 and December 31, 2024, and for the period of January 1, 2025 to June 30, 2025, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note 2.
- the information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements and supplemental schedules are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with auditing standards generally accepted in the United States of America will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note 2.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

Note 1 – Description of the Plan

The following brief description of the Better Community Living, Inc. 401(k) (the "Plan") is provided for general information purposes only. More complete information is provided within the Plan documents.

General

The Plan is a contributory, defined contribution plan covering substantially all employees of Better Community Living, Inc. (the "Company"). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Company is also the plan administrator and plan sponsor. Voya Retirement Insurance and Annuity Company ("Voya") is the trustee and custodian of the Plan's assets.

The Plan was amended and restated effective January 1, 2025. The Plan, prior to the restatement, was named 401(k) Profit Sharing Plan for Employees of Better Community Living, Inc. Mutual of America Life Insurance Company ("Mutual of America") was the trustee and custodian for the plan year ended December 31, 2024.

Eligibility

Employees of the Company are eligible to participate in the Plan if they have attained age 18. Effective January 1, 2025, the minimum service requirement for employee contributions is 90-days. Previously, there was no minimum service requirement for employee contributions. Employer matching contributions are subject to a minimum service requirement of 12 months.

Contributions

Participants in the Plan may contribute up to 100% of their annual compensation, subject to limitations of the Internal Revenue Code ("IRC"). Participants have the option of making pre-tax savings contributions and after-tax Roth contributions to the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

For eligible participants, the Company matches a discretionary percentage at an amount equal to a percentage of the participants' salary reduction contributions that are deferred during the Plan year. During the period of January 1, 2025 to June 30, 2025 the Company made a \$55,593 matching contribution.

Participant accounts

Each participant's account is credited with the participant's contributions as well as allocations of the Company's matching contributions. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Employees who enter the plan after December 31, 2024 are immediately vested in their contributions plus actual earnings thereon. Vesting in the employer matching contribution portion of their accounts plus actual earnings thereon is based on elapsed time over a 5-year graded vesting schedule.

Employees who entered the plan prior to January 1, 2025 are 100% vested in their voluntary contributions and the employer matching contributions plus earnings thereon.

Notes to Financial Statements

Notes receivable from participants

Participants in the Plan may elect to borrow from their vested account balances a minimum of \$1,000 up to a maximum of 50% of their vested account balance or \$50,000, whichever is lower. The notes are secured by the balance in the participant's account and, as of June 30, 2025, bear interest at rates ranging from 5.00% to 9.50%. Uncollectible notes receivable are charged to the participant's account. All notes must be repaid within five years, except for notes used to acquire a principal residence, which must be repaid within ten years. The interest rate charged on notes receivable from participants is commensurate with the current commercial rates charged on similar loans made by persons in the business of lending money.

Payment of benefits

Employees are eligible for benefits at normal retirement age (65), or their retirement date if later, or upon death or disability. Employees may elect to receive benefits in a lump-sum cash payment, various annuities, or through a rollover to an IRA or Qualified Plan in accordance with Plan documents. An employee may request withdrawal from their account upon attaining age 59-1/2 and in the case of hardship as defined by the Plan document.

Note 2 – Summary of significant accounting policies

Basis of accounting

The Plan prepares its financial statements and supplemental schedules on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Under the modified cash basis of accounting, contributions and expenses are not recognized until received or paid, respectively.

Accounting estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Administrative expenses

Certain costs of plan administration are absorbed by the Company. Investment related expenses are included in net appreciation in fair value of investments.

Investment valuation and income recognition

The Plan's investments are stated at fair value except for its benefit-responsive investment contract (the Mutual of America Interest Accumulation Account) which was valued at contract value (see Note 5). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See the discussion under *Fair Value Measurements* for a description of valuation methodologies used for assets measured at fair value.

Purchases and sales of securities are recorded on a trade-date basis. Gain or loss on sales of investments is based on average cost. The Plan presents the net appreciation or depreciation in the fair value of its investments in the Statement of Changes in Net Assets Available for Benefits which consists of the realized gains or losses and the unrealized appreciation and depreciation on those investments. Interest income is recorded, as earned, on an accrual basis. Dividend income is recorded on the ex-dividend date.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of benefits

Benefits are recorded when paid.

Note 4 – Fair value measurements

The Fair Value Measurements topic of the FASB Accounting Standards Codification (FASB ASC) establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are: Level 1, defined as observable inputs such as quoted prices in active markets; Level 2, defined as inputs other than quoted prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore requiring an entity to develop its own assumptions. The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Pooled separate accounts and collective investment trusts are investments measured at fair value using the NAV per share (or its equivalent) practical expedient and have not been categorized in the fair value hierarchy. This practical expedient is not used when it is determined to be probable that a fund will sell an investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

The fixed account is valued by discounting the related cash flows based on current yields of similar instruments. The fixed account has been categorized as Level 2 within the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Investment contracts

In 2014, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Mutual of America Life Insurance Company (“Mutual of America”). Mutual of America maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. The crediting rate was based on a formula established by the contract issuer but could not be less than 1 percent.

In connection with the Plan’s transition to a new trustee and investment custodian in January 2025, the guaranteed investment contract with Mutual of America was terminated.

In January 2025, the Plan entered into an investment contract issued by Voya Retirement Insurance and Annuity Company. Participants may ordinarily direct the withdrawal or transfer of all, or a portion, of their investment account. Contract value approximates fair value and represents contributions made to the account, plus earnings, less participant withdrawals and administrative expenses. The Plan may not transact at contract value with the issuer when total amounts disbursed from the account in a given calendar year exceed 20% of total assets in the account at the beginning of the Contract Year, as defined in the contract. For the investment contract in effect at June 30, 2025, the minimum crediting interest rate guaranteed for the life of the contract is 1%.

Note 6 – Plan termination

Although it has not expressed any intent to do so, the Sponsor has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 7 – Tax status

The Internal Revenue Service has determined and informed the Company by letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examinations by Federal or State tax authorities. The plan administrator has concluded that as of June 30, 2025, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 – Related party transactions

Affiliates of the Plan's trustee provide recordkeeping services to the Plan. The administrative fees associated with the recordkeeping services qualify as party-in-interest transactions. Notes receivable from participants are also considered party-in-interest transactions.

Note 9 – Risks and uncertainties

The Plan provides for various investment options which invest in pooled separate accounts, collective investment trusts, and other investment securities. Investment securities are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the financial statements.

Note 11 – Prohibited transactions

In 2025, a series of contributions were remitted to the Plan more than 15 days after the amounts were available for transfer. The delinquent contribution amounts totaled approximately \$28,000 and consisted of employee contributions and participant loan repayments. Department of Labor (DOL) Regulation 2510.3-102 requires that participant contributions be remitted to the Plan on the earliest date on which they can be reasonably segregated from the Company's general assets, but in no event later than the 15th business day following the end of the month in which amounts are contributed by employees or withheld from their wages. As a result, the delinquent contributions are considered prohibited transactions. The delinquent contributions were transferred to the Plan in February 2025 but were not corrected to include the participants' lost earnings. The Company will calculate and fund the lost earnings associated with the delinquent contributions during the year ending June 30, 2026.

Note 12 – Subsequent events

The Plan has evaluated subsequent events and transactions through December 29, 2025, the date the financial statements were available to be issued. There were no subsequent events or transactions that occurred that would require recognition or disclosure in the financial statements.
