### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the statements or information regarding assets so held are prepared and certified to by a qualified institution in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of and for the years ended June 30, 2025 and 2024, stating that the certified investment information, as described in Note 2 to the financial statements, is complete and accurate.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

### NOTES TO FINANCIAL STATEMENTS

---

#### 1. DESCRIPTION OF PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following description of Provident Charter School 403(b) Plan (Plan) provides only general information. Participants should refer to the plan adoption agreement for more complete information.

*General* - The Plan, adopted effective January 1, 2016 and amended and restated effective January 1, 2020, is a defined contribution plan which covers substantially all full-time employees of Provident Charter School (Sponsor). There are no minimum age or service requirements to enter the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Use of Estimates* - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the dates of the financial statements and the reported amounts of changes in assets during the reporting periods. Actual results could differ from the estimates.

*Investment Valuation and Income Recognition* - Investments are carried at their fair value based on published quotations. The Plan presents net appreciation or depreciation in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation or depreciation on these investments, in the statements of changes in assets available for benefits. Gains and losses on securities sold or redeemed are determined on the basis of specific identification. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

*Contributions* - Participants may elect to contribute up to 100% of eligible compensation, as defined in the plan document, to the Plan each year, subject to certain limitations under the Internal Revenue Code. Participant contributions are recorded in the period during which payroll deductions are withheld from Plan participants' earnings.

The Plan provides for discretionary nonelective contributions for all eligible employees. For the years ended June 30, 2025 and 2024, the nonelective contribution was 10% of eligible compensation.

*Participant Accounts* - Participant accounts are credited with participant contributions, employer contributions and plan earnings. Earnings are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. The benefit to which a participant is entitled is the value of a participant's vested account.

*Investment Options* - Participants may direct their contributions and employer contributions into various investment options, and may change their investment options at any time.

*Risks and Uncertainties* - The Plan's funds are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of assets available for benefits.

*Vesting* - Participant contributions and earnings thereon are fully vested and nonforfeitable at all times. Nonelective contributions and the earnings thereon vest according to the following schedule:

<u>Years of Service</u>	<u>Percentage</u>
Less than 2	0%
2 but less than 3	20%
3 but less than 4	40%
4 but less than 5	60%
5 but less than 6	80%
6 and more	100%

A year of service is defined as 1,000 hours or more within the Plan year.

*Payment of Benefits* - On termination of service due to death, disability, retirement, or other reasons, and subject to certain restrictions, a participant or designated beneficiary may elect to receive an amount equal to the vested value of his or her account, a rollover to another qualified plan or individual retirement account, or installment payments subject to applicable tax withholding requirements. All distributions are subject to the provisions of the Plan.

*Rollovers* - Employee rollover contributions represent nonforfeitable contributions from other qualified plans.

*Forfeitures* - Forfeitures represent the portion of non-vested benefits remaining in the Plan for all terminated employees. Forfeitures may be used to reduce employer contributions or pay Plan expenses. Forfeitures were approximately \$154,000 and \$67,000 for the years ended June 30, 2025 and 2024, respectively, and were used to reduce employer contributions. Remaining forfeitures available for utilization in future periods were approximately \$76,000 and \$8,000 at June 30, 2025 and 2024, respectively.

*Participant Loans* - Loans to participants are not permitted.

*Administrative Expenses* - Either the Sponsor or the Plan may pay the Plan's expenses as provided by the plan adoption agreement.

*Fair Value Measurement* - U.S. GAAP establishes a framework for measuring the fair value of financial assets. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

At June 30, 2025 and 2024, plan investments consist of mutual funds, which are valued at the quoted prices of the respective funds at year end (level 1 measurement).

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Further, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting dates.

*Reclassifications* - Certain amounts in the 2024 financial statements have been reclassified to conform to the 2025 presentation.

*Subsequent Events* - Management has evaluated subsequent events through January 29, 2026, the date which the financial statements were available to be issued.

## **2. CERTIFIED FINANCIAL INFORMATION**

Capital Bank and Trust Company, the custodian, has certified that the following data included in the financial statements is complete and accurate.

- Investments as shown in the statements of assets available for benefits as of June 30, 2025 and 2024.
- Net investment income, as shown in the statements of changes in assets available for benefits for the years ended June 30, 2025 and 2024.
- The schedule of assets held for investment purposes at June 30, 2025, as shown on the accompanying supplemental schedule.

## **3. PLAN TERMINATION**

Although it has not expressed any intention to do so, the employer has the right to terminate the Plan subject to the provisions of ERISA. In the event of termination, all participants shall become 100% vested in their accounts.

**4. INCOME TAX STATUS**

The Plan is a non-standardized pre-approved plan for which the third-party administrator obtained a favorable opinion letter dated March 31, 2017 in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified. Accordingly, no provision for income taxes has been included in the Plan's financial statements. Management believes there is no liability related to uncertain tax positions at June 30, 2025 or 2024. The Plan is no longer subject to tax examinations for years prior to June 30, 2022.

**5. RELATED PARTIES AND PARTIES-IN-INTEREST**

Capital Bank and Trust Company serves as the custodian of the Plan and provides access to the American Funds mutual funds. Capital Bank and Trust Company and American Funds are part of the Capital Group and, accordingly, are considered to be parties-in-interest.

Neither the Sponsor nor the employees involved in the administration of the Plan receive compensation from the Plan.
