Re: Explanation for Late Filing of Form 5500 for Retirement Plan,

EIN [46-0747793/001

Plan Year End 12/31/2023

I am writing to acknowledge and explain the late filing of the Form 5500 for the above-referenced retirement plan. The return was filed on 4/13/2024. I take full responsibility for this delinquency and the lack of adequate oversight that led to the delay.

In 2023, our benefits/HR administrator departed unexpectedly, and responsibility for the Form 5500 was not reassigned promptly. During the transition, key tasks including gathering Schedule(s) and engaging our third-party administrator were overlooked. I mistakenly believed that a short plan year/extension applied to our plan and failed to verify the actual due date. This misunderstanding, coupled with inadequate internal controls, resulted in the missed deadline.

While I relied on outside professionals for plan administration, it was ultimately my responsibility to verify that the filing was completed on time. I recognize that our internal controls were insufficient and that this was a preventable lapse.

We implemented a calendar with multiple reminders (responsible party and backup) and added a secondary review checkpoint 30 days before each filing deadline.

Training will be provided for the staff responsible for filing requirements, extensions, and documentation retention.

If this letter is in response to an IRS/DOL penalty notice dated 1/28/2026, I respectfully request penalty abatement based on reasonable cause. The delay resulted from the circumstances described above, despite our good-faith efforts. We have corrected the filing and implemented controls to prevent recurrence.
