### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Exodus Global, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

#### Note 1. Plan Description

The following description of Exodus Global, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering substantially all employees of Exodus Global, LLC, Oilquick Americas, LLC, and Hilltop Farms, LLC (collectively, the Company or Plan Administrator) who have completed two months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company has a group contract with Voya Retirement Insurance and Annuity Company (Voya) and has appointed Voya as the custodian of the Plan. The custodian is responsible for maintaining custody of the Plan's assets, processing contributions and distributions, and executing transactions to appropriate investment options. The Retirement Plan Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

**Contributions:** The Plan allows participants to elect to contribute an amount of their eligible compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Each year, the Company may elect to make matching contributions and non-elective contributions. For the year ended December 31, 2024, the Company made matching contributions of 50% of the first 6% of compensation that a participant contributes to the Plan. The Company did not elect to make non-elective contributions during 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant accounts:** Each participant's account is credited with the participant's contributions and Company matching contributions, if any, as well as allocations of the Company non-elective contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on eligible participant compensation, participant account balances, or specified participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes receivable from participants:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account. Note terms range from one to five years or up to 15 years for the purchase of a primary residence. The note interest rate is set at 1% above the prime rate, as defined. Interest rates ranged from 8.5% to 9.5% at December 31, 2024, and notes mature through June 2029. Principal and interest is paid ratably through payroll deductions.

**Vesting:** Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. Participants vest 20% for each year of service and are 100% vested after five years of service, upon attainment of retirement age, or death or permanent disability during the term of employment.

**Forfeited accounts:** As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$335 and \$240, respectively. These accounts may be used to restore previously forfeited account balances, fund Company contributions, or to pay administrative expenses. During 2024, forfeited accounts of \$12,720 were used to partially fund Company contributions.

**Payment of benefits:** On termination of service, a participant can elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. The Plan may make mandatory distributions of account balances that are \$7,000 or less. If the Plan elects to make a mandatory distribution, participant balances that are less than \$1,000 at the time of termination will be paid out in cash in a lump sum, and balances between \$1,000 and \$7,000 will be rolled over into an individual retirement account designated by the Plan Administrator. The Plan allows for in-service and hardship distributions to participants subject to certain restrictions.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The Plan's financial statements are presented on the accrual basis of accounting.

**Use of estimates in the preparation of financial statements:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment valuation and income recognition:** The Plan's investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measurement attribute for fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by Plan's investment advisors, custodian, and other third parties. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Contributions:** Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

**Payment of benefits:** Benefits are recorded when paid.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make note repayments, and the Plan Administrator deems the participant note to be in default, the participant note balance is reduced, and a benefit payment is recorded.

Notes receivable from participants are classified as an investment for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule, Schedule H, line 4i—schedule of assets (held at end of year).

**Administrative expenses:** Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and payment of benefits are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are charged against net appreciation of fair value of investments.

**Subsequent events:** The Plan has evaluated subsequent events through December 10, 2025, the date the financial statements were available to be issued.

#### Note 3. Information Certified by Voya

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified as complete and accurate by Voya, a qualified institution:

#### Note 4. Fair Value Measurements

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Pooled separate accounts:** Pooled separate accounts are valued at the net asset value (NAV) of the units of accounts held by the Plan. The NAV is used as a practical expedient to estimate fair value. The NAV of the account is reported by the account manager at year-end, and is based on the underlying quoted market price of the assets that comprise each account. This practical expedient would not be used if it is determined to be probable that the Plan will sell the investment for an amount different from the NAV. Each pooled separate account's underlying assets is composed primarily of an individual mutual fund or collective investment fund. Pooled separate accounts are valued daily based on the NAV of the shares of the underlying investments.

In accordance with U.S. GAAP, the pooled separate accounts held by the Plan are not classified in the fair value hierarchy table that prioritizes the inputs to valuation techniques used to measure fair value because they are measured at NAV per share as a practical expedient.

Allocation percentages are monitored to achieve the best risk adjusted performance based on the stated objectives and target allocations of the particular fund.

The redemption notice period disclosed in the table above reflects the notice period required if the contract was terminated. For individual participant transactions, there is no redemption notice period required.

#### Note 5. Group Annuity Contract With Voya

The Plan has a group annuity contract with Voya that currently invests contributions in the Voya Fixed Account A and previously in the Voya Fixed Account. The Fixed Account A and Fixed Account are fixed annuity general account products that meet the fully benefit-responsive investment criteria. The Fixed Account is closed to any type of contributions. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

The contract meets the fully benefit responsive investment contract criteria and therefore is reported at contract value. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

The annuity contract does not have a stated maturity date.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

#### Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to amend or terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### Note 7. Tax Status

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 8. Related-Party Transactions and Party-In-Interest Transactions**

Certain Plan investments are shares of pooled separate accounts or an investment contract managed by Voya, the custodian as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the custodian as well as other service providers are included in administrative expenses in the statement of changes in net assets available for benefits. During the year ended December 31, 2024, the Company paid certain administrative expenses for the Plan which have been excluded from these financial statements. Certain administrative functions are performed by employees of the Company. No such employee receives separate compensation from the Plan.

#### **Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment balances have occurred since December 31, 2024, or will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for benefits.
