Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the 2024 Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Other Matters**

#### ***2024 Supplemental Schedule Required by ERISA***

The supplemental schedule listed in the table of contents, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

*Auditor's Report on the 2023 Financial Statements*

Predecessor auditors performed an audit of the 2023 financial statements of the Plan. In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the plan that were certified by a qualified institution. Their report dated February 12, 2025 indicated that (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agreed to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

## **Note 1. Plan Description**

### ***General***

The following description of the SDC Group 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

The Plan was established on January 1, 2016, by Southern Development & Construction, Inc. (the “Plan Sponsor” or the “Employer”). The Plan, as amended and restated, is classified as a defined-contribution plan covering employees who reached the age of 21 (except those covered under a collective bargaining agreement, and non-resident aliens), and completed one hour of service in a six-month period from the date of hire. The purpose of the Plan is to reward eligible employees of the Employer for long and loyal service by providing them with retirement benefits. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan’s trustee is responsible for oversight of the Plan and determines the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the Board of Directors.

Inspira Financial Trust, LLC (“Inspira”), formerly known as Millennium Trust Company, LLC, serves as both directed trustee and custodian of the Plan assets with MTG LLC (“Betterment Securities”), a broker-dealer registered with the U.S. Securities and Exchange Commission (“SEC”), authorized to hold Plan assets and act as Inspira’s servicing agent.

### ***Contributions***

Each year, participants may contribute a percentage of their pre-tax or after-tax (Roth) annual compensation, as defined in the Plan, up to the annual limits established by the Internal Revenue Service (“IRS”). The Plan provides for automatic enrollment whereby new participants are automatically enrolled in the Plan with a default deferral rate set at 3% of eligible compensation unless they affirmatively elect not to participate in the Plan.

The Employer may make discretionary matching contributions, as well as profit-sharing contributions, as defined by the Plan. Employees are eligible to receive an allocation of Employer profit-sharing contributions if they completed 1,000 hours of service during the applicable period and are employed at the end of the applicable period. During the year ended December 31, 2024, the Employer did not make any profit-sharing contributions to the Plan.

### ***Participant Investment Account Options***

Upon enrollment in the Plan, participants may elect to have their employee and Employer contributions, and related earnings thereon, allocated to one or more investment options offered by the Plan.

### ***Participant Accounts***

Under the Plan, a separate account is maintained for each participant. Each participant’s account is credited with the participant’s contribution and allocations of the Employer’s contribution and Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions, plus actual earnings thereon, as well as certain special contributions, if any. Vesting in the Employer matching and profit-sharing contributions is based on years of continuous service, as follows:

Less than 2 years	0%
2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 or more years	100%

***Forfeited Accounts***

Forfeitures of terminated participants' non-vested accounts are used to reduce future Employer contributions to the Plan and pay for certain Plan administration expenses. At December 31, 2024 and 2023, the Plan had approximately \$193,000 and \$105,000, respectively, of forfeited, non-vested accounts, which will be used to reduce future Employer contributions. During the year ended December 31, 2024, approximately \$46,000 forfeitures were used to offset Employer contributions.

***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 minus the highest outstanding balance of loans in the past 12 months, or one-half of present value of their vested account balance. Participant notes receivable transactions are treated as a transfer to (from) the Investment Fund from (to) the Participant Notes Receivable Fund. Participants may not have more than one note receivable outstanding from the Plan at the same time. The notes are collateralized by the balance in the participant's account and bear interest at a rate equal to the Prime Rate plus one percentage point, as determined by the Plan administrator. Principal and interest is paid ratably through payroll deductions.

***Payment of Benefits***

Upon the death, permanent disability, or retirement of participants at the age of 65, their entire account balances become fully vested. Distribution of benefits may be made in one lump-sum cash payment equal to the participant's vested account balance. Participants who terminate for reasons other than death, disability, or retirement are entitled only to their vested balances payable in a lump-sum distribution. As of December 31, 2024 and 2023, there were no unpaid amounts allocated to participants who elected to withdraw from the Plan but had not yet been paid.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are presented on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

***Administration and Other Costs***

Plan administration costs charged to the Plan for the year ended December 31, 2024 were approximately \$24,000. Certain other administration costs are paid by the Employer. Investment fees, commissions, and related expenses are included in net change in fair value of investments in these financial statements.

***Investment Valuation and Income Recognition***

The Plan's investments include registered investment companies, which are stated at fair value.

Investments held in registered investment companies are recorded at their reported net asset value ("NAV"), which is computed based on the estimated fair value of the funds' underlying securities, less any fund liabilities. Valuation methods used by Betterment Securities are based on quoted market prices, as well as quotes from pricing services and brokers.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balance, plus accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

***Contributions***

Contributions from Plan participants and the matching contributions from the Plan Sponsor are recorded in the year in which the employee contributions are withheld from compensation.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Excess Contributions Payable***

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants before March 15, 2025.

**Note 3. Certification of Plan Trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedules is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedules.

**Note 4. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Note 5. Tax Status**

The Plan is designed to be a qualified trust under Section 401 of the Internal Revenue Code (the "IRC") and is subject to the provisions of ERISA. Effective January 1, 2021, the Plan adopted a Prototype Pre-Approved Profit-Sharing Plan with a Cash or Deferred Arrangement ("CODA"), sponsored by CCH Incorporated d/b/a ftwilliam.com, which received a favorable opinion letter, dated June 30, 2020, in which the IRS stated that the prototype plan, as then designed, qualified under Section 401 of the IRC. The Plan has been amended since receiving the most recent determination letter. The Plan administrator believes that the Plan, as currently amended, is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's accompanying financial statements.

**Note 6. Disclosures About Fair Value of Plan Assets and Liabilities**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Observable inputs such as quoted prices in active markets.
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

***Registered Investment Companies***

Registered investment companies are publicly traded investments and are valued based on quoted market prices reported on the active market which the funds are traded.

**Note 7. Risks and Uncertainties**

The Plan's investments are not insured and are subject to credit and market risks. Financial information relating to those investments is included in these financial statements, based on information provided by Betterment Securities.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 8. Related-party and Party-In-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain Plan investments are managed by the custodian. As described in Note 2, the Plan paid certain expenses related to the Plan operations and investment activity to various service providers, including the custodian. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Plan administration costs charged to the Plan for the year ended December 31, 2024, was approximately \$24,000. These transactions qualify as exempt party-in-interest transactions under ERISA.

**Note 9. Subsequent Event**

On May 28, 2025, Provac Services LLC and Sun Truck Materials, entities related to the Plan Sponsor via common ownership, adopted the Plan.
