
To Whom it may Concern:

We have received information indicating the Plan's 5500 filing was late or deficient. The plan has filed the Form 5500 with a statement of reasonable cause, and we ask the Service to review the reasonable cause statement that was filed with the plan, and we ask for an abatement of the penalty listed.

The filing was not submitted as required because Majestic Meat was sold in September 2024, and I was unaware that a final filing was needed as the plan was closed and had no assets at year end 2024. In addition, the email whereas our payroll company was sending the completed form was being sent to an email that is no longer monitored or owned by Majestic Meat. Raymond Zaelit got an email yesterday from the Department of Labor and that was the first time we were aware that something was supposed to be filed, and we were delinquent. I immediately got on the phone to get this resolved as soon as possible and get the form submitted.

The Form 5500 was filed on 02/04/2026 with the reasonable cause statement attached to the filing. If the Service needs anything else to make a decision, I'll be happy to provide it.
