Independent Auditor's Report

To the Plan Trustees and Plan Administrator
Vietnam Veterans of San Diego, Inc. 403(b) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Vietnam Veterans of San Diego, Inc. 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Vietnam Veterans of San Diego, Inc. 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Vietnam Veterans of San Diego, Inc. 403(b) Plan, and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Vietnam Veterans of San Diego, Inc. 403(b) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 - Description of Plan:

The following description of the Vietnam Veterans of San Diego, Inc. 403(b) Plan (the “Plan”) provides only general information. For additional information concerning the Plan’s provisions, participants should refer to the Plan Agreement and Summary Plan Description.

General

The Plan is a defined contribution plan covering the employees of Vietnam Veterans of San Diego, dba Veterans Village of San Diego (the “Company” and “Employer”). An employee will become a participant in the Plan on the first day of employment. Employees must complete one year of service to be eligible for employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Company has appointed Lincoln Financial Group as the Custodian of the Plan assets, with authority over management, record-keeping, investment of Plan assets, and Plan accounting and reporting. Effective January 1, 2019, the Company has also appointed American United Life Insurance Company, a OneAmerica Company, as the Custodian of the Plan assets, with authority over management, record-keeping, investment of Plan assets, and Plan accounting and reporting.

Contributions

Participants may make Elective Deferral Contributions up to 100% of compensation, up to the maximum dollar amount established by the Internal Revenue Code (IRC) of pretax annual compensation, as defined in the Plan. Participants age 50 and older may make catch-up contributions to a maximum dollar amount established by the IRC. Participants may also contribute amounts representing distributions from other qualified plans (rollovers).

The Plan also provides for a Company contribution at the discretion of the Company. The Company contributed 3% of compensation for eligible employees.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, Company contributions, and allocation of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participants’ account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Participants direct their salary deferral contributions and their allocated share of Employer contributions into various investments, which are more fully described in the Plan’s literature. The Plan currently offers a variety of mutual funds, mutual funds in pooled separate accounts (“PSA”), and two guaranteed-interest accounts (“GIA”). Participants may change their investment options any time throughout the year.

Each PSA investment option allows transfers; however, the portfolios are monitored for transfer/reallocation activity, and may be restricted under certain conditions. The transfer restriction applies to all participant-directed transfers out of the investment option, excluding transfers made under a dollar cost-averaging program, a rebalancing program, or, if applicable, any asset allocation program. Employee deferral and Company matching contributions into the investment option are not impacted by such restrictions. GIAs allow participants to make transfers as frequently as on a daily basis.

Vesting

Participants are immediately vested in their employee contributions and earnings thereon. Employees hired prior to July 1, 2017 are 100% vested in the employer contributions and earnings thereon. Effective July 1, 2017, employees vest according to a three-year cliff vesting schedule.

Forfeitures

Forfeitures are used to pay Plan expenses and may be used to reduce the Company contributions or pay Plan expenses for the Plan year in which the forfeiture occurs. Forfeitures totaling \$26,664 were used to reduce the Company's contribution for the year ended December 31, 2024. There were no forfeitures applied to the Plan's expenses for the year ended December 31, 2024. Forfeited non-vested accounts totaled \$1,868 and \$2,697 at December 31, 2024 and 2023, respectively.

Notes Receivable from Participants

Loans are available to participants, subject to certain limitations. The Plan allows participants to take a loan, provided all outstanding loans do not exceed 50% of the participant's account balance, not to exceed \$50,000. If 50% of the total account value is less than \$10,000, a participant can borrow the lesser of \$10,000 or 100% of the vested account value. During the term of the loan, a portion of the participant's account equal to the outstanding principal of the loan, plus any interest that has accumulated on that amount, will be set aside in a loan reserve account. The loans bear interest at rates established when the loan is granted. Interest rates were 5.25% to 7%, on the participants' loan balances for the years ended December 31, 2024 and 2023. Loans are repaid through payroll withholding, generally over five years; however, the Plan provides for longer maturities if the loan is used to acquire the participant's principal residence.

Payment of Benefits

Upon termination of services due to death, disability, or retirement, a participant or his/her beneficiary may elect to receive an amount equal to the value of the participant's vested interest in his/her account in either a lump-sum amount or through various annuities, based on the participant's election. Participants with account balances of \$5,000 or less will receive a lump-sum distribution upon termination of service with the Company. Participants with account balances of greater than \$1,000 but less than \$5,000, a direct rollover will be made to an individual retirement account, unless otherwise directed by the participant.

Participants may receive withdrawals for reasons of financial hardship. These withdrawals are included with benefits paid, and cannot exceed the participant's voluntary contributions and vested Employer contributions plus earnings.

Administrative Expenses

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. All accounting and legal services and administrative fees (other than loan and investment transfer fees) of the Plan are either provided or paid for by the Company, at no cost to the Plan.

Note 2 - Significant Accounting Policies:

Accounting Method

The financial statements of the Plan have been prepared on the accrual basis of accounting, which is in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). Employee and Employer contributions were recognized in the period that contributions are due.

Guaranteed interest contracts held by a defined contribution plan are reported at contract value, which is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

The Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans* allows a plan administrator of a 403(b) plan to exclude certain contracts and accounts from plan assets, for purposes of ERISA's annual reporting and audit requirements, under specified conditions. Therefore, effective January 1, 2009, the Plan has excluded from the investments in the accompanying statement of net assets available for benefits certain custodial and fixed accounts issued to current and former employees prior to January 1, 2009. The related investment income and distributions have also been excluded in the accompanying statement of changes in net assets available for benefits. See Note 4 for excluded investments.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Fair Value Measurements

Fair value accounting standards define fair value, establish a framework for measuring fair value, outline a fair value hierarchy based on inputs used to measure fair value, and enhance disclosure requirements for fair value measurements. The fair value hierarchy distinguishes between market participant assumptions based on market data obtained from sources independent of the reporting entity (observable inputs that are classified within Level 1 or 2 of the hierarchy), and the reporting entity's own assumptions about market participant assumptions (unobservable inputs classified within Level 3 of the hierarchy).

- Level 1 inputs are quoted prices in active markets for identical investments that the Plan has the ability to access at the measurement date.
- Level 2 inputs are inputs, other than quoted prices included within Level 1, that are observable for the investment, either directly or indirectly.
- Level 3 inputs are unobservable inputs for the investment.

The Plan's statements of net assets available for benefits include the following financial instruments that are required to be measured at fair value on a recurring basis:

- Investments in mutual funds are considered Level 1 assets, and are reported at fair value based on quoted net asset values of the shares held by the Plan at year-end.

Fair Value Measurements (Continued)

- Investments in pooled separate accounts (PSAs) are segregated investment accounts established by The Lincoln National Life Insurance Company or Lincoln Life & Annuity Company of New York. The value of the Plan's investment in the PSAs is equal to the contract value. The contract value is equal to the number of participation units owned under the contract in each PSA, times the unit value of the participation units. The PSAs are reported at fair value based on the unit value of the underlying assets owned by the fund, minus the fund's liabilities, divided by the number of participation units outstanding. This value is also commonly referred to as the net asset value (NAV). This is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the pooled separate accounts, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Investment Valuation and Income Recognition

Investments held in mutual funds and pooled separate accounts are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Investments held in guaranteed interest accounts are reported at contract value (Note 5).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable From Participants

Participant loans are reported at their unpaid balances, plus any accrued and unpaid interest.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Expenses of the Plan, including legal, audit, administrative, and Custodian expenses, are generally paid by the Company, with the exception of certain administrative expenses which are paid for by the Plan and charged to participants' accounts. The Plan paid \$549 in administrative expenses for the years ended December 31, 2024.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term, that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Note 4 - Information Prepared and Certified by the Custodians:

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to the Plan's investments disclosed in the accompanying financial statements, including investments held at December 31, 2024, net appreciation in fair value of investments, interest and dividend income and notes receivable for the year ended December 31, 2024, was obtained or derived from information certified as complete and accurate by Lincoln Financial Group and American United Life Insurance Company, the Custodians of the Plan.

Certain investments held by Lincoln Financial Group have been excluded from the financial statements and supplemental schedule as of, and for, the years ended December 31, 2024 and 2023 as permitted by Department of Labor Field Assistance Bulletin 2009-02. If the excluded investments, as reported by the Custodian, were included, net assets available for benefits would increase by approximately \$104,559 and \$89,047 as of December 31, 2024 and 2023, respectively. Further, investment gains of \$15,511 for the year ended December 31, 2024 related to such accounts, as identified by the Custodian, have also been excluded from the accompanying statement of changes in net assets available for benefits.

Note 5 - Guaranteed Interest Contracts:

The Plan has a fully benefit-responsive guaranteed investment contract with Lincoln National Life Insurance Company ("Lincoln"), totaling \$224,605 and \$227,723 at December 31, 2024 and 2023, respectively. Lincoln maintains the contributions in a general account. The account is credited with earnings on the underlying investments, and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer, but may not be less than 4 percent. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria, and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts, because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Lincoln, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all, or a portion of, their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers, and that also would limit the ability of the plan to transact at contract value with the participants.

Note 5 - Guaranteed Interest Contracts:

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines; (2) a breach of material obligation under the contract; (3) a material misrepresentation; (4) a material amendment to the agreement without the consent of the issuer.

The Plan has a fully benefit-responsive guaranteed investment contract with American United Life Insurance Company, totaling \$9,340 and \$10,079 at December 31, 2024 and 2023, respectively. American United Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0.50% percent. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria, and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts, because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by American United Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all, or a portion of, their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers, and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines; (2) a breach of material obligation under the contract; (3) a material misrepresentation; (4) a material amendment to the agreement without the consent of the issuer.

Note 6 - Party-In-Interest Transaction:

Certain Plan investments are shares of mutual funds held in pooled separate accounts managed by Lincoln Financial Group, the Custodian, as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions. The Plan paid contract administrator fees totaling \$40 to Lincoln Financial Group, and \$509 to American United Life Insurance Company, for the year ended December 31, 2024. In addition, the Plan may pay fees for investment management services which are included in net appreciation in fair values of investments.

Note 7 - Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA.

Note 8 - Tax Status:

The Plan is intended to comply with the applicable requirements of Section 403(b) of the IRC. The terms of the Plan have been prepared to conform to the sample language provided by the Internal Revenue Service (IRS) in Revenue Procedure 2007-71 (or the draft Listing of Required Modifications issued April 4, 2009). A tax determination letter program is not yet available for IRC Section 403(b) plans through the IRS; however, the Plan administrator believes the Plan is currently designed and being operated in compliance with applicable requirements of the IRC, and, as such, is exempt from federal income taxes. The Plan administrator intends to apply for a determination letter on the Plan once the IRS opens such a program. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b).

The Plan believes that it has appropriate support for any tax position taken, and, as such, does not have any uncertain tax positions that are material to the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examination for years prior to 2020.
