## INDEPENDENT AUDITOR'S REPORT

Board of Trustees

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Iron Workers Local 404 Annuity Fund, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for benefits as of April 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Iron Workers Local 404 Annuity Fund's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended April 30, 2025 and 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Iron Workers Local 404 Annuity Fund and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Iron Workers Local 404 Annuity Fund's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

The following brief description of Iron Workers Local 404 Annuity Fund is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

*General*

The Plan is a collectively bargained multi-employer defined contribution annuity plan, which covers any person employed in the collective bargaining unit after January 1, 1995 by employers who have agreed, by collective bargaining with the union, to participate in the Plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All funding is made by the employers according to the collective bargaining agreements. Participant accounts are credited for the amount of contributions received and allocation of Plan earnings in accordance with their investment direction net of investment expenses and an allocation for administrative and operating expenses based on a per-account charge. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants are immediately vested in their contributions plus actual earnings thereon.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Accounting*

The financial statements of the Plan are prepared using the accrual method of accounting.

Investment contracts held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

*Contributions*

The Plan is being funded through a pension trust administered by a Board of Trustees consisting of equal representation by the union and the employers. All contributions are paid by the employers based on a fixed hourly contribution rate. The collective bargaining agreement requires contributions to the Plan based on hours paid at a rate of \$7.00 per hour. Contributions due at April 30<sup>th</sup> and received during the normal cut-off period are recorded as receivable. No provision has been made for delinquent contractors' contributions based on the uncertainty of collection.

*Participant Loans*

The Plan allows participants to borrow up to 50% of their account balance up to a maximum of \$50,000. The repayment period for nonresidential loans may not exceed five years, whereas loans used to finance the participant's primary residence must be repaid within 15 years. Loans bear interest at 2% above the prime rate for the first day of the month in which the loan is approved. A maximum of two loans are permitted at any time. Participants should refer to the Plan agreement for more complete information. Notes receivable from participants are measured at their unpaid principal balance. Delinquent and pending default loans are included in allowance for uncollectible and netted against participant loans receivable.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

*Investment Valuation and Income Recognition*

Investments are reported at fair value, except for fully benefit-responsive contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Cash*

The Fund maintains cash deposits in a financial institution. Accounts at this institution are insured by the Federal Deposit Insurance Corporation up to \$250,000. At April 30, 2025, the amount of deposit exceeded the insured amount by approximately \$340,000.

*Tax Status*

The Plan has obtained a determination letter from the Internal Revenue Service stating that the Plan, as then designed, is in compliance with the applicable requirements of the Internal Revenue Code. The Plan's administrator and the Plan's counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

*Use of Estimates*

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results may differ from those estimates.

*Payment of Benefits*

Upon termination of service due to death, disability, or retirement, a participant may elect to receive a lump sum amount equal to the value of the participants' vested interest in his or her account. If an individual account balance is in excess of \$5,000, they may choose one of the following benefit options: (1) a lump sum distribution, (2) monthly joint and survivor annuity payments, (3) specified monthly payments until their individual account is exhausted, or (4) a combination lump sum payment and specified monthly payment. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Benefit payments are recorded when paid.

*Plan Termination*

The Board of trustees may terminate, amend, modify or suspend the Plan in whole or in part at any time. However, in any such event, the participants' rights to their accrued benefits are non-forfeitable.

*Subsequent Events*

Management has evaluated events and transactions occurring subsequent to April 30, 2025 for items that should potentially be recognized or disclosed in these financial statements. The evaluation was conducted through the date these financial statements were available for issue and has nothing of significance to note.

**3. INFORMATION CERTIFIED BY THE CUSTODIAN**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the department of Labor Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, Empower Annuity Insurance Company of America, has certified that the following data included in the accompanying financial statements and supplemental schedules is complete and accurate.

**4. FAIR VALUE MEASUREMENTS**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels: Level 1 consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using

Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used for investments for which level 1 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Financial assets valued using Level 2 inputs are based on observable inputs other than quoted market prices in active markets for identical assets. The fair values of the separate investment accounts is the net fair value of the underlying assets as determined generally by using commercial quotation services.

For a description of the valuation methodologies used for assets measured at contract value see Note 6. There have been no changes in the methodologies used at April 30, 2025 and 2024.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at reporting date.

The following table presents the fair value hierarchy for the balances of the assets of the Plan measured at fair value as of April 30, 2025 and 2024.

**5. INVESTMENT CONTRACT WITH INSURANCE COMPANY – SEPARATE INVESTMENT ACCOUNTS**

The Plan has investment contracts with Empower Annuity Insurance Company of America (EAICA). EAICA maintains the contributions in pooled accounts. The accounts are credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses. The assets of the Separate Investment Accounts (SIA) are separate from EAICA's General Investment Account. EAICA invests these accounts according to the stated objectives of the various SIAs. The principal is not guaranteed. Contract holders are allocated units of the SIA, not specific securities. The value of the SIA units is the net fair value of the underlying assets as determined generally by using commercial quotation services.

The contracts are included in the financial statements at fair value. Fair value includes reinvested dividend and interest income, received and accrued, realized gains and losses, and unrealized gains and losses of the underlying SIA assets. SIA's do not pay dividends or interest to a plan. The underlying investments' performance (interest, dividends, and realized and unrealized gains) is reflected in the unit value.

**6. INVESTMENT CONTRACT WITH INSURANCE COMPANY – GUARANTEED INTEREST ACCOUNTS**

The Plan entered into a benefit-responsive investment contract with EAICA. EAICA maintains the contribution in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The contract is included in the financial statements at contract value as reported to the Plan by EAICA. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract values at April 30, 2025 and 2024 were \$11,565,847 and \$12,575,891, respectively. The crediting interest rate is based on a formula agreed upon with the issuer and it is guaranteed not to fall below the minimum percentage set at the beginning of the year. Such interest rates are reviewed on a semi-annual basis for resetting.

Certain events may limit the Plan's ability to transact at contract value with EAICA. Such events include, but may not be limited to the following: (a) temporary absence, (b) change in position or other occurrence qualifying as a temporary break in service under the Plan, (c) transfer or other change in position resulting in employment by an entity controlling, controlled by, or under other common control with the employer, (d) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the Plan sponsor's business, (e) removal from the Plan of one or more groups of classifications of participants, (f) partial or complete Plan termination, or (g) Plan disqualification. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable to occur.

**7. RELATED PARTY & PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds and investment contracts managed by EAICA. EAICA is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$51,204 and \$38,603 for the years ended April 30, 2025 and 2024, respectively.

Fees paid for legal, accounting and other professional services rendered by parties-in-interest were based on customary and reasonable rates for such services.

All of these parties-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

**8. PLAN AMENDMENTS AND MODIFICATIONS**

The Plan has been amended and modified to define and clarify the participant loan provisions and hardship distributions.

The Plan amended the required minimum distribution age from 70½ to 72 in accordance with SECURE Act and from 72 to 73 in accordance with SECURE Act 2.0.
