INDEPENDENT AUDITOR'S REPORT

To the Administrator of Strada 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America. We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedules Required by ERISA

The supplemental schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

AS OF DECEMBER 31, 2024 AND FOR THE PERIOD AUGUST 1, 2024 THROUGH DECEMBER 31, 2024

1. DESCRIPTION OF PLAN

The following description of the Strada 401(k) Plan (“the Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General—On July 12, 2024, Alight Solutions, LLC announced the sale of payroll and professional services business to Axiom Buyer, LLC, a newly-formed entity and an affiliate of H.I.G. Capital, L.L.C. As a result of this divestiture, on August 1, 2024, the Payroll and Professional Business 401(k) Plan was created, and was subsequently renamed to Strada 401(k) Plan. The Plan is a defined contribution plan covering substantially all employees of Axiom U.S. Payroll Parent, LLC (the “Company” or “Plan Sponsor”). The Board of Directors of the Company has appointed the Axiom U.S. Payroll Parent, LLC U.S. Benefits Administration and Investment Committee (the “Committee”) to control and manage the operation and administration of the Plan.

Northern Trust Company serves as the Plan’s trustee. Alight Solutions LLC functions as the Plan’s recordkeeper. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Plan Amendments — Effective September 27, 2024, the Plan was amended to change its name from Payroll and Professional Business 401(k) to “Strada 401(k) Plan”.

Participant Contributions—Participant contributions are withheld from participants’ compensation and are remitted to the Plan as soon as administratively feasible, in accordance with the Department of Labor’s regulations.

Participants may contribute a percentage of their compensation to the Plan each year, subject to the limitations, as defined in the plan document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Additionally, during the year, a substantial amount of rollover activity occurred as participants in the Alight 401(k) plan, i.e., the plan before divestiture, rolled over their account balances into the Strada 401(k) Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible participants are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions are invested in an age-appropriate target date portfolio fund until changed by the participant. The plan also includes an auto-escalation provision whereby auto-enrolled participants receive a 1% increase to the default deferral rate each year.

Employer Contributions—Employer contributions consist of Safe Harbor matching contributions and Annual Retirement Account Contributions (RACs). Generally, the Company matches 100% of the first 1%, and 50% thereafter, up to 6% of eligible compensation that a participant contributes each pay

period. The RAC is an automatic non-elective Company contribution provided to certain eligible participants who are employed on the last day of the plan year. The RACs are 2.5% of a non-management participant's annual eligible compensation. Management participants do not receive RAC.

Participant Accounts—Each participant's account is credited with the participant's contributions and related Safe Harbor matching contributions and RACs (as applicable), and Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments—Participants may direct the investment of their contributions and any Safe Harbor or RAF contributions and/or account balances into various investment options offered by the Plan and may change investments and transfer amounts between funds daily. Participants may also direct their investments through a trustee sponsored brokerage account, which offers the option to invest in a variety of individual stocks and mutual funds.

Vesting—Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company matching contribution and RAC portion of their accounts is based on years of continuous service. A participant is 100% vested after two years of credited service.

Notes Receivable from Participants—Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balance in the participant's account, and bear interest at a rate commensurate with local prevailing rates at the time funds are borrowed as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions. Loan terms range from 1 to 5 years; however, terms may exceed 5 years for the purchase of a primary residence. As of December 31, 2024, participant loans have maturities through 2030 at interest rates ranging from 8.75% percent to 9.50% percent.

Payment of Benefits—On termination of service with the Company (including termination due to death, disability or retirement), a participant may elect a distribution of their vested balance as a lump sum distribution, period installment payments, or through partial distributions. Otherwise, distributions generally begin on a participant's mandatory commencement date.

Participants can also make in-service withdrawals from after-tax,, rollover or Roth rollover contributions.

Participants are also eligible to make hardship withdrawals from their deferred contributions in the event of certain financial hardships. Following a hardship withdrawal, participants are not allowed to contribute to the Plan for a period of six months.

Forfeited Accounts—In accordance with the provisions of the Plan, forfeitures arising from non-vested employer contributions may be used first to restore previously forfeited amounts for terminated participants who become reemployed before incurring five consecutive one-year breaks in participation, make corrective allocations to participant accounts, pay plan administrative expenses, or reduce future employer contributions. Forfeitures are tracked and applied in accordance with the Plan document. As of December 31, 2024, forfeited nonvested accounts totaled \$6,510. During 2024, no forfeitures were used by the Plan Sponsor.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting—The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates—The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties—The Plan provides various investment options to its participants. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the value of the participants' account balances and the amounts reported in the financial statements.

Investment Valuation and Income Recognition—Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net (depreciation) includes the Plan's gains and losses on investments bought and sold as well as those held at year end.

Contributions—Participant contributions are recorded when withheld. Safe Harbor matching contributions and RACs from the Company are recorded when earned.

Notes Receivable from Participants—Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the plan document.

Payment of Benefits—Benefits are recorded when paid. There were no participants who elected to withdraw from the Plan, but had not yet been paid at December 31, 2024.

Administrative Expenses—Administrative expenses of the Plan are paid by the Plan or Plan Sponsor, as provided in the Plan document. Participants also pay administrative costs for loans, distributions and qualified domestic relation orders.

All investment management and transaction fees directly related to the Plan investments are paid by the Plan. Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, investment management fees and operating expenses are reflected as a reduction of investment return for such investments.

Excess Contributions Payable — The Plan is required to return contributions received during the Plan year in excess of the IRC limits. There were no excess contributions due to participants as of December 31, 2024.

3. CERTIFIED INVESTMENT INFORMATION

The following is a summary of the information regarding the Plan as of December 31, 2024 and for the period August 1, 2024 through December 31, 2024, included in the Plan's financial statements and supplemental schedule that were prepared by or derived from information prepared by Northern Trust, the trustee of the Plan and furnished to the Plan administrator. The Plan administrator has obtained a certification from the trustee that such information is complete and accurate.

The self-directed brokerage account and associated is not certified. The amounts not certified include \$29,241 of investments at fair value as of December 31, 2024.

4. FAIR VALUE MEASUREMENTS

ASC 820, Fair Value Measurements and Disclosures, provides a framework for measuring fair value. That framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows: Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Asset Valuation Techniques—Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds—Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Short-term Investment Fund—The fund is a common collective trust. Fair value is determined as the NAV of units of the fund. The NAV per share is determined and published and is the basis for current transactions. The fund's primary objective is to operate with a stable NAV of \$1.00. There are no unfunded commitments or redemption restrictions associated with the short-term investment fund.

Self-Directed Brokerage Account—Primarily includes a variety of common stocks and mutual funds. Common stock is valued at the closing price reported on the active market on which the individual securities are traded. Mutual funds are valued consistent with the description above.

5. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are mutual funds managed by Northern Trust Company, the trustee, as defined by the Plan. Fees paid for investment management services were included as a reduction of the return earned on each fund.

The Plan also allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan, including the Company. The Plan also issues loans to participants, which are secured by the vested balances in the participants’ accounts. These transactions qualify as exempt party-in-interest transactions.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

7. TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 10, 2025, that the Plan and related trust were designed in accordance with the applicable regulations of the Internal Revenue Code (IRC). The Company and Plan management believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC, and the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

8. SUBSEQUENT EVENTS

Subsequent events were evaluated through February 6, 2026, the date the financial statements were available to be issued. Other than disclosed in Note 7, no events occurred that require additional disclosure or adjustments to the Plan's financial statements.
