I am writing to explain the late submission of Raw Juice's Form 5500 for the 2024 plan year, which was due on 10/15/2025.

Due to tough company circumstances, namely a decision to close several locations at the end of this year, we were unable to complete the filing on time. These discussions and decisions were not handled lightly as we are forecasting for next year, and it simply took up too much of my time, causing the regrettable delay.
