## INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of the  
International Union of Painters and  
Allied Trades District Council 21  
Ralph Williams Scholarship Fund

### Opinion

We have audited the financial statements of the International Union of Painters and Allied Trades District Council 21 Ralph Williams Scholarship Fund (the Fund), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits (cash basis) as of April 30, 2025 and 2024, and the related statements of changes in net assets available for benefits (cash basis) for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Fund (cash basis) as of April 30, 2025 and 2024, and the changes in its net assets available for benefits for the years then ended, in accordance with the cash basis of accounting as described in Note 1.

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Fund and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### Basis of Accounting

As described in Note 1, these financial statements were prepared using the cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the cash basis of accounting as described in Note 1, and for determining that the cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all Fund amendments; administering the Fund; and determining that the Fund's transactions that are presented and disclosed in the financial statements are in conformity with the Fund's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

**NOTES TO FINANCIAL STATEMENTS**

APRIL 30, 2025 AND 2024

**NOTE 1. DESCRIPTION OF FUND AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Type of Activity** - The Fund provides financial assistance, through the awarding of scholarships, to eligible members and members' dependent children of International Union of Painters and Allied Trades District Council 21 (the Council) which represents members primarily employed in painting, glazing, glassworking, and other industries in eastern Pennsylvania, New Jersey, and Delaware.

**Method of Accounting** - The accompanying financial statements have been prepared using the cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Accordingly, revenue is recognized when received rather than when earned and expenses are recognized when paid rather than when the obligation is incurred.

**Funding Policy and Revenue Recognition** - The Fund is funded by contributions from members via participating employers under the terms of collective bargaining agreements (CBA). Member contributions are accounted for as exchange transactions when received. The contributions are due on a monthly basis. It is the policy of the Trustees to pursue monies due.

**Cash** - Cash consists of cash in checking accounts available for immediate withdrawal.

**Scholarship Awards** - Scholarship awards are recorded when paid by the Fund.

**NOTE 2. DESCRIPTION OF THE FUND**

The Fund was organized effective January 1, 2003, pursuant to an agreement and declaration of trust (the Trust) dated August 27, 2003, between the Council and Employers in the industry who have entered into collective bargaining agreements with the Council. The Trust was amended on January 1, 2017.

The Plan of Benefits was established for the purpose of providing financial assistance to members of the Council who are employed by participating employers and to the members' dependent children who have demonstrated scholastic ability, good character, and qualities of leadership who might not otherwise be able to afford a college education.

**NOTE 2. DESCRIPTION OF THE FUND (continued)**

The Council and certain Employers have entered into collective bargaining agreements that result in an employee contribution to the Fund for each full-time employee. These funds are to be disbursed in accordance with the Plan of Benefits adopted by the Trustees on August 27, 2003 and amended on January 1, 2017.

During the year ended April 30, 2025 and 2024, the member contribution rate was between \$.05 per hour and \$.12 per hour depending on the area that the member works.

**NOTE 3. PRIORITIES IN THE EVENT OF TERMINATION**

Should the Trust be terminated or liquidated, the Trustees shall turn over any surplus monies in the Fund to any similar Trust Fund for use for the same purposes as contemplated by this Fund, provided that the Fund to which any surplus monies are turned over shall be exempt under Section 501(c)(3) or (9) of the Internal Revenue Code.

**NOTE 4. INCOME TAX STATUS**

The Fund qualifies as a tax exempt organization under Section 501(c)(5) of the Internal Revenue Code.

Management is required to evaluate tax positions taken by the Fund and recognize a tax liability if the Fund has taken an uncertain position that, more likely than not, would not be sustained upon examination by the U.S. Federal, state, or local taxing authorities. The Fund is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Typically, Fund tax years will remain open for three years; however, this may differ depending upon the circumstances of the Fund.

**NOTE 5. CASH CONCENTRATIONS**

The Fund places its cash with financial institutions deemed to be creditworthy. Cash balances may at times exceed the insured deposit limits. As of April 30, 2025, the Fund's cash in excess of FDIC coverage totaled \$245,868.

**NOTE 6. RELATED PARTY TRANSACTIONS**

The Council provides office facilities, office personnel, equipment, and certain other expenses to the Fund at no charge. The Scholarship Fund reimburses the Council for postage and office expenses. The Fund reimbursed the Council \$110 and \$154 during the years ended April 30, 2025 and 2024, respectively.

During the year ended April 30, 2025, the Council's Golf Outing Fund donated \$159,455 to the Fund.

**NOTE 6. RELATED PARTY TRANSACTIONS (continued)**

During the year ended April 30, 2025, the Council reimbursed the Fund \$8,027 for Council expenses initially paid by the Fund.

The Fund has common Trustees and shares collection services with other IUPAT District Council No. 21 Benefit Plans and related entities. The cost of the collection services is initially paid by the IUPAT District Council No. 21 Welfare Fund (the Welfare Fund). The Fund reimbursed the Welfare Fund \$514 and \$760 during the years ended April 30, 2025 and 2024, respectively. In addition, the Fund reimbursed the Welfare Fund \$1,935 for golf outing expenses initially paid by the Welfare Fund on the Fund's behalf.

The above transactions qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules of ERISA.

**NOTE 7. SUBSEQUENT EVENTS**

The Fund has evaluated subsequent events through December 30, 2025, the date the financial statements were available to be issued, and they have been evaluated in accordance with relevant accounting standards.


