In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Independent Dialysis Foundation, Inc. Retirement Plan and Trust's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

***Auditors' Responsibilities for the Audit of the Financial Statements***

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Independent Dialysis Foundation, Inc. Retirement Plan and Trust's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Independent Dialysis Foundation, Inc. Retirement Plan and Trust's ability to continue as a going concern for a reasonable period of time.

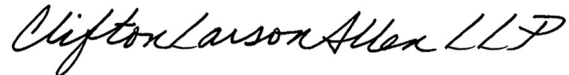

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedules are fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 1 DESCRIPTION OF PLAN**

The following description of Independent Dialysis Foundation, Inc. Retirement Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all eligible employees of the Independent Dialysis Foundation, Inc. (the Organization), who have completed one year of service (as defined as 1,000 hours or more) and have attained age 21 or older. Per-diem and nonresident alien employees are exempt from participation in the Plan. Plan entry dates are twice a year on October 1 and April 1. The Plan was effective October 1, 2009. The Plan is subject to the provisions of ERISA.

In September 2009, the Board of Directors of the Organization (the Board) approved the merger of the assets of the Independent Dialysis Foundation, Inc. Money Purchase Plan and Trust into the Plan effective October 1, 2009. At that time, all eligible participants of the Independent Dialysis Foundation, Inc. Money Purchase Pension Plan and Trust were allowed to participate in the Plan.

**Contributions**

Each year the Organization makes a discretionary contribution subject to Board approval. For the years ended September 30, 2025 and 2024, the Organization approved a discretionary contribution equal to 2.5% of a participant's eligible compensation. Employees must have worked at least 1,000 hours and be employed on the last day of the Plan year to be eligible for the discretionary contribution unless death, retirement, or disability has occurred during the year. Participants may only contribute amounts representing distributions from other qualified defined contribution plans.

**Participant Accounts**

Accounts are not participant directed. The money that is invested is managed by the trustee of the Plan. Each participant's account is credited with (a) the Organization's contribution, and an allocation of (b) Plan earnings (losses), and (c) an allocation of administrative expenses. Allocations of contributions are based on the participant's compensation as a percentage of the total compensation of all Plan participants. Allocations of Plan earnings (losses) and administrative expenses will be allocated to participants on the Plan valuation date, with the amount of a participant's share determined by the relative amount of the participant's account balance as compared to the total account balance of all participants. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are vested in the Organization's contributions and the related earnings thereon according to the following vesting schedule:

Participants terminating due to death, disability, or retirement immediately vest in their portion of Employer contributions. Participants are always fully vested on their rollover contributions and related earnings thereon.

**Payment of Benefits**

Participants or their beneficiaries are eligible for distributions upon termination, death, disability, normal retirement at age 65, early retirement at age 60 with five years of service, or for in-service withdrawals upon reaching age 65. Distributions upon termination will commence as soon as administratively feasible following the allocation of all contributions related to the Plan year in which the participant's account balance becomes distributable. A participant may request a partial interim distribution of 50% of their vested account balance provided that they are at least age 62 or has become disabled under the terms of the Plan and there is an anticipated material delay of more than 180 days beyond the applicable valuation date or the first date the participant become entitled to a distributions. The remaining balance will be distributed as soon as administratively feasible after the valuation of the current Plan year is completed. The participant's vested account balance will be distributed in the form of a lump sum distribution or partial withdrawals as requested by the participant. Participants or beneficiaries whose account balances do not exceed \$5,000 will be distributed in a lump sum or rolled over to an individual retirement account and must be distributed as soon as practicable. Effective January 1, 2024, the mandatory cash-out limit was increased to \$7,000. Benefits are recorded when due and payable in accordance with the terms of the Plan.

**Forfeitures**

The Plan provides that forfeitures of nonvested contributions, if any, shall be applied to reduce the Organization's contributions and administrative expenses to the Plan. Approximately \$938 and \$1,848 were used to reduce the Organization's contributions during the years ended September 30, 2025 and 2024, respectively. No forfeitures were used to reduce administrative expenses during the years ended September 30, 2025 and 2024. As of September 30, 2025 and 2024, forfeited nonvested accounts totaled \$-0-.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

**Contributions**

Organization contributions are record in the year in which compensation used to calculate the contribution is earned.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Administrative expenses of the Plan are paid by the Plan and the Organization. Expenses that are paid directly by the Organization are excluded from these financial statements. Certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Subsequent Events**

The Plan has evaluated subsequent events through January 27, 2026, the date the financial statements were available to be issued.

**NOTE 3 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liabilities;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in methodologies used at September 30, 2025 and 2024.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Exchange Traded and Closed - End Funds:* Valued at the NAV of units held by the Plan at year-end, in active markets.

*Government Securities:* Valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing value on yields currently available on comparable securities of issuers with similar credit ratings.

**NOTE 4 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their entire accounts.

**NOTE 5 RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

The Plan investments are managed by Morgan Stanley Smith Barney; therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in administrative expenses. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 6 TAX STATUS**

The Plan is based on a pre-approved nonstandardized 401(k) profit-sharing plan. The pre-approved nonstandardized 401(k) profit-sharing plan obtained its latest determination letter in which the Internal Revenue Service (IRS) stated that the Plan is in compliance with the applicable requirements of the Internal Revenue Code (IRC). Plan management and the Plan's tax counsel believe the Plan is currently designed and being operated in compliance with applicable requirements of the IRC. Therefore, they believe that the Plan was qualified as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities which are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
