### Note 1: Description of Plan

The following description of the BVO Holdings 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### General

The Plan is a participant-directed contribution plan sponsored by BVO Holdings Corporation (the Company). Employees who are 20 or older are eligible to participate in the Plan on the first day of the month following the completion of six consecutive months of employment. As of January 1, 2024, long-term part-time employees who worked more than 500 hours in three consecutive years may participate in the Plan.

#### Contributions

Participants are allowed to make pretax, after-tax (Roth), or a combination of pretax/after-tax contributions to the Plan, up to 100% of eligible compensation, as defined by the Plan and subject to Internal Revenue Service (IRS) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated target fund until changed by the participant.

The Company may make discretionary matching contributions equal to a percentage of the amount participants elect to contribute, which is determined by the Company on an annual basis. The discretionary matching contribution does not apply to participant catch-up contributions. In 2024, the Company declared discretionary matching contributions of 50% up to 6% of employee deferrals (maximum match of 3%).

The Company may also make discretionary non-elective contributions equal to a percentage of a participant's compensation, which is also determined by the Company on an annual basis. The Company did not make a discretionary non-elective contribution for the 2024 plan year. For Company non-elective contributions, participants must have 1,000 hours of service during the year and must be employed on December 31 of the year of award in order to receive the contribution.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, Company discretionary matching contributions, as well as allocations of (a) the Company's discretionary non-elective contribution, if any, and (b) Plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Note 1: Description of Plan** (Continued)

#### **Vesting**

Participants are immediately vested in their contributions plus actual earnings (losses) thereon. Company contributions and any earnings (losses) thereon vest at a rate of 20% per year beginning with the second year of service. Participants become fully vested after six years of service.

A participant is fully vested upon the attainment of normal retirement age, death or disability.

#### **Payment of Benefits**

Upon retirement at normal retirement age, disability, death, or termination of employment, a participant or his or her beneficiary can elect to receive either a lump-sum amount equal to the value of their vested account, or monthly, quarterly, semi-annual, or annual installments. In addition, hardship distributions are permitted if certain criteria are met. Participants may elect a combination of the two methods of distribution. In-service distributions are permitted for participants who have attained age 59 ½. Mandatory distributions of Plan accounts occur for participants who have severed employment and have a balance of \$7,000 or less.

#### **Forfeitures**

Plan forfeitures arise as a result of participants who terminate service with the Company before becoming 100% vested in the Company contributions. All forfeitures are used to offset future Company contributions or to pay Plan expenses, as directed by the Plan Administrator. At December 31, 2024 and 2023, forfeited nonvested account balances totaled \$37,795 and \$19,465, respectively. During 2024, \$91,173 and \$33,421, of forfeitures reduced Company's matching contributions and paid Plan expenses, respectively.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### **Use of Estimates in Preparation of Financial Statements**

The preparation of the accompanying financial statements in conformity with GAAP requires management to make estimates and assumptions that directly affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results may differ from those estimates.

### Note 2: Summary of Significant Accounting Policies (Continued)

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments include the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Payment of Benefits

Benefits paid to participants are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain administrative expenses related to distributions directly attributable to a participant's transaction are deducted from that participant's account. Investment-related expenses are included in net appreciation in fair value of investments.

#### SECURE 2.0 Act of 2022

The SECURE 2.0 Act of 2022 (SECURE 2.0), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine the optional provision(s) to elect in the future.

#### Subsequent Events

Subsequent events have been evaluated through January 6, 2026, which is the date the financial statements were available to be issued.

Effective on February 7, 2025, the Plan removed Vobeve, LLC as a participating employer of the Plan, as a result of Vobeve, LLC filing chapter 11 bankruptcy. As a result, a partial Plan termination has occurred, with all Company contributions of affected employees becoming fully vested.

Effective on July 1, 2025, the Plan added Drink Lick, LLC as a participating employer of the Plan. As of this date, Drink Lick, LLC employees are eligible to participate in the Plan.

### Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Stable value collective trust fund:* The fund primarily consists of high-quality guaranteed investment contracts and similar agreements, valued at the NAV of units from insurance companies, banks, and other financial institutions. The NAV is used as a practical expedient to estimate fair value, except when it is probable that the fund will sell the investment for an amount different from the reported NAV. Investments in the stable value collective trust can be purchased and sold continuously. A notice of redemption is not required. The Plan has no obligation to buy additional units.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 4: Information Prepared and Certified by the Trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Empower Trust Company, LLC, the Trustee of the Plan.

### Note 5: Risks and Uncertainties

The Plan's investments are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

### Note 6: Tax Status

The Company has adopted a nonstandardized pre-approved plan, which the IRS has determined to be qualified under Section 401(k) of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the Plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan is qualified and the related trust was tax-exempt at the financial statement date.

### Note 7: Party-In-Interest Transactions

As noted in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions qualify as party-in-interest transactions. These transactions are not, however, considered prohibited under ERISA.

#### **Note 8: Plan Termination**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue or amend its contribution amounts at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

#### **Note 9: Excess Contributions Payable**

At December 31, 2024 and 2023, amounts payable to participants totaling \$13,332 and \$10,327, respectively, for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants prior to March 15, 2025 and March 15, 2024, respectively.
