To Whom It May Concern,

I am writing as the administrator on behalf of IntegrisRx, LLC, the plan sponsor of the above-referenced retirement plan, to formally request a waiver of the late filing penalty assessed in connection with the Integris, Rx 401(k) & Profit Sharing Plan Form 5500.

Our company was acquired in August 2024. Prior to the acquisition, payroll and 401(k) plan services were administered by ADP Retirement Services. The plan's final 401(k) transaction occurred in October 2024. The plan has had no contributions since that time.

We reasonably relied on ADP Retirement Services to notify us of any remaining compliance obligations related to Form 5500 following the cessation of plan activity. ADP had previously indicated that they would contact us approximately six months after the final transaction regarding any Form 5500 filing requirements. However, no such notification was received in April or May 2025.

On January 17, 2025, ADP Retirement Services notified us that they would not be performing 2024 year-end compliance testing because the plan was no longer serviced by ADP and/or had no contributions for the 2024 plan year. Following this communication, we proactively contacted ADP Retirement Services to confirm whether any Form 5500 action was required, and during that call we were advised that no further action was needed for the 2024 Plan Year.


It was not until we received the Department of Labor notice dated January 28, 2026, that we became aware that a Form 5500 filing was still required and considered late. Upon learning this, we immediately began taking steps to address the filing.

The late filing was not the result of willful neglect, but rather due to reasonable reliance on our prior service provider during a post-acquisition transition period, combined with the absence of plan activity and explicit guidance received from ADP.

Given these circumstances, we respectfully request that the late filing penalty be waived. We believe the facts demonstrate good-faith compliance efforts and prompt corrective action once the issue was identified.
