#### 1. Description of Plan:

The following description of the Command Medical Products, LLC Employees Savings Trust (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more comprehensive description of the Plan's provisions.

- a) **General**—The Plan is a defined contribution plan covering all eligible employees of Command Medical Products, LLC (the Company). Employees become eligible on the first day of the month following employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan is a 401(k) defined contribution plan covering substantially all full-time employees of Command Medical Products, LLC (the "Company") who are age eighteen or older and have completed at least one month of service. Employees that are part of a union, nonresident aliens, or are residents of Puerto Rico are not eligible for participation. Employees who become eligible to participate are automatically enrolled in the Plan on the first day of the month coinciding with or following the date they meet the requirements.

- b) **Contributions**—Each year, participants may contribute from 1% to 80% of eligible pre-tax annual compensation, as defined by the Plan. Additional "catch-up" contributions can be made to the Plan if the participant is at least age 50 by the end of the plan year up to the amount allowed by law. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans ("rollover contributions"). Participants direct the investment of their contributions, as well as Company contributions to their participant account, into various investment options offered by the Plan. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral set at 3% of eligible compensation with annual increases of 1% up to a total contribution of 10%, and their contributions are invested in a designated fund until changed by the participant. The Company contributes 50% of the first 5% of eligible compensation. Contributions are subject to certain limitations allowed by law.

All Company contributions are invested as directed by the participants. Contributions are subject to certain limitations and eligibility requirements.

Company match contributions for the years ended December 31, 2024 and 2023 were \$123,286 and \$126,682, respectively.

The Company, at its discretion, may also make an annual contribution to the Plan that will be allocated to eligible participant accounts as specified by the Plan. In order to receive this nonelective contribution, participants must be employed on the last day of the Plan Year, unless in the case of death, total and permanent disability, or termination on or after Normal Retirement Age of sixty-five. No such contributions were made for the years ended December 31, 2024 and 2023.

- c) **Participants accounts**—Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and, (b) Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. The Company currently offers 6 collective trust funds and 21 mutual funds as investment options for participants. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- d) **Vesting**—Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts is based on years of continuous service. Participants vest based on the following schedule:

After 4 year	100%

Participants that do not meet these service requirements will become fully vested in Company contributions in the event of death or total and permanent disability.

- e) **Notes receivable from participants**—Participants may borrow from their fund a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance. The loans are secured by the balance in the participant's account and bear interest an interest rate of prime plus 2% (currently 5.25% to 10.50%). Principal and interest is paid ratably through weekly payroll deductions.

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The Plan allows only one outstanding loan at a time, along with an additional "home-loan", provided the repayment period is greater than 5 years. The loans are secured by the balance in the participant's account. The loan interest rate is set at a commercially reasonable rate of 2 percent above the prime rate, which is determined on the 14<sup>th</sup> day of each month. Principal and interest is paid ratably through payroll deductions. Loans are repayable within 5 years unless the loan is used for the purchase of a primary residence, in which case the loan may be repaid within a period of up to 30 years.

- f) **Payment of benefits**—Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. Participants may also take in-service distributions at the age of 59 ½, or in the event of financial hardship. Partial withdrawals and hardship distributions must be at least \$500. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Absent the participant's election to roll distributions into another qualified plan or receive a lump sum payment, vested balances over \$1,000 but not exceeding \$5,000 for terminated participants are rolled over to an individual retirement plan designated by the plan administrator. The participant's contributions and vested portion of employer contributions may also be withdrawn for certain hardship situations.

- g) **Administrative plan expenses**—The Plan permits payment of administrative expenses to be made from the Plan’s assets and for them to be allocated either proportionately based on the value of account balances or as an equal dollar amount based on the number of participants in the Plan. However, certain operating expenses of the Plan, such as audit fees, are paid by the Plan Sponsor. Plan administration and investment management fees reduce participants’ account balances. Expenses relating to specific participant transactions (i.e., loan setup, distribution request, etc.) are charged directly against the appropriate participant’s account.

The Plan has a revenue-sharing arrangement with a registered investment advisor for the reimbursement of Plan expenses. Revenue earned from this agreement is used to pay expenses. During the year ended December 31, 2024, \$10,314 was earned from this agreement and was used to pay expenses.

- h) **Forfeited accounts**—At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2,611 and \$10, respectively. These accounts may be used to reduce future employer contributions or pay plan expenses. During the year ended December 31, 2024, \$7,850 was used to reduce employer contributions.
- i) **Plan amendments**—The Plan was amended on March 1, 2024, to change the Company’s name to “Command Group Acquisition, LLC”, the EIN to “93-3954461”, and the Plan name “Command Group Acquisition, LLC. Employees Savings Trust”. The Plan was also amended August 1, 2024, to change the Company’s name to “Command Medical Products, LLC” and the Plan name “Command Medical Products, LLC. Employees Savings Trust”. Effective January 1, 2025 the Trustee was changed from Reliance Trust Company to ADP Retirement Trust Services, LLC.

## 2. Summary of Significant Accounting Policies:

- a) **Basis of presentation**—The financial statements of the Plan are prepared on the accrual basis of accounting.

- b) **Investment valuation and income recognition**— Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

- c) **Notes receivable from participants**—Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document, therefore no allowance for credit losses has been recorded as of December 31, 2024 and 2023.
- d) **Payment of benefits**—Benefits are recorded when paid
- e) **Use of estimates**—The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.
- f) **Subsequent events**—The Plan has evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through October 8, 2025, the date the financial statements were available to be issued. Other than the amendments discussed at Note (1)(i), no other subsequent events requiring recognition or disclosure have been identified.
- g) **Administrative expenses** - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

#### 4. Investments and Fair Value Measurements:

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, level 2 inputs consist of quoted prices for similar assets or liabilities in active markets or quoted prices for identical or similar assets in inactive markets; and level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open end mutual funds registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust – The units of the common collective trust account is stated at fair value as determined by the issuer of the account based on the fair value of the underlying investments. Individual participant accounts invested in the common collective trust account are maintained on a unit value basis.

**5. Plan Termination:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

**6. Tax Status:**

The Plan is a pre-approved defined contribution plan (“Pre-approved Plan”) sponsored by ADP, LLC (“ADP”). ADP obtained its latest opinion letter dated October 06, 2020 that the Pre-approved Plan, as then designed, was in compliance with the applicable requirements of IRC. is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan management believes that the Plan is currently designed, and is currently being operated, in compliance with applicable requirements of the IRC and, therefore, believes that the Plan is qualified, as the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

**7. Parties-in-Interest:**

During the year, Plan investments were managed by ADP, LLC. ADP, LLC provided administrative services to the Plan, and therefore qualifies as a party-in-interest to the Plan. Reliance Trust Company served as trustee to the Plan and therefore qualifies as a party-in-interest to the Plan.

**8. Risks and Uncertainties:**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
