Notes to Financial Statements For the Year Ended June 30, 2025

Note 1 - Description of the Plan

The following description of the Seattle Academy of Arts and Sciences 403(b) Retirement Plan (the Plan) provides general information only. Participants should refer to the plan agreements for complete information regarding the Plan's definitions, benefits, eligibility, and other matters.

General - The Plan is a defined contribution plan that was established effective September 1, 1984 for the benefit of employees of the Seattle Academy of Arts and Sciences (the Sponsor). Nonresident aliens and employees who are also students are not eligible to participate in the Plan. Collectively bargained (union) employees, temporary employees, per diem employees, coaches, reclassified employees, and employees under the age of 21 may contribute employee deferrals into the Plan but they are excluded from receiving employer nonelective contributions.

TIAA and NWPS perform recordkeeping services for the Plan. All contributions are made to Matrix Trust Company (Matrix). Existing TIAA or CREF contracts will remain with TIAA or CREF unless a participant makes an election to transfer their account balance from TIAA or CREF to Matrix or take a qualified distribution from their account. The Plan is intended to be a plan that meets the requirements of Section 403(b) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions - Participants may contribute to the Plan through voluntary deferrals of earned compensation as pre-tax or Roth deferrals. Eligible employees may contribute up to 100% of their compensation to the Plan. Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions to the Plan. Participants who have completed at least fifteen years of service with the Sponsor may make additional catch-up contributions to the Plan not to exceed \$3,000 per plan year and \$15,000 over the life of the participant. Participants may also contribute amounts representing distributions from other eligible retirement plans (rollover).

The Sponsor may make discretionary nonelective contributions to the Plan. Employees meet eligibility requirements by completing 90 consecutive days of service with at least one hour of service credited during each scheduled workday during the 90 day period. The nonelective contribution is allocated to participants as a uniform percentage of participant compensation. For the year ended June 30, 2025, the Sponsor elected to contribute 8% of a participant's eligible compensation. The Sponsor may make discretionary matching contributions. There were no discretionary matching contributions for the plan year ended June 30, 2025.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts - Participants are allowed to direct contributions into various investment options that offer a diversity of investment risk and return. Each participant's account is credited with the participant's contributions and sponsor nonelective contributions, as well as allocations of plan earnings or losses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in all contributions to the Plan plus actual earnings thereon.

Note 1 - Continued

Benefits Paid to Participants - Upon termination of service, death, disability, or attainment of age 59½, a participant or beneficiary may elect to receive a distribution of their vested account balance. The distribution may be in the form of a lump-sum payment, installment payments, or annuity distribution options. Participants may request an in-service distribution from their rollover contributions at any time prior to severance. The Plan also provides for hardship withdrawals in accordance with provisions specified in the plan document.

Notes Receivable From Participants - Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account. Loans are secured by the balance in the participant's account. Interest rates are set at .25% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

Note 2 - Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits - Benefits are recorded when paid. When a participant's accumulation in the TIAA Traditional Annuity is converted to a lifetime payout annuity, the present value of the stream of payments is equal to the accumulated balance, and the entire amount is recorded as a distribution in the statement of changes in net assets available for benefits.

Notes Receivable From Participants - Notes receivable from participants are measured at their unpaid principal balance. Accrued but unpaid interest, if any, would not have a material impact on the Plan's financial statements. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the loan balance is reduced, and a benefit payment is recorded.

Investment Valuation and Income Recognition - Investments are reported at fair value except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Transaction based fees for notes receivable from participants and benefit payments are charged directly to participant accounts. Certain investment related expenses are charged directly against the fund's investment performance and, therefore, are not separately disclosed in the accompanying financial statements.

Subsequent Events - The Plan's management has evaluated subsequent events through February 9, 2026, the date on which the Plan's financial statements were available to be issued.

Note 3 - Fair Value Measurements

GAAP defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under this guidance are described as follows:

Level 1 - Unadjusted quoted prices available in active markets for identical assets or liabilities;

Level 2 - Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or

Level 3 - Unobservable inputs that are significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2025 and 2024.

Pooled Separate Account - The TIAA Real Estate Account (REA) is a pooled separate account which funds variable annuity contracts issued by TIAA. The fair value of accumulation units held in the REA is published daily and based on market values of the underlying real estate properties determined by external appraisals, which are estimates of property values based on a professional's opinion. The REA may also hold real estate-related marketable securities which are valued using independent pricing sources. Accumulation units in the REA are available for transactions at the closing accumulation unit value on any day the New York Stock Exchange (NYSE) is open for business. Transfers out of the REA are limited to one per calendar quarter.

Variable Annuity Accounts - CREF is a registered investment company and consists of eight investment accounts which fund variable annuity contracts issued by CREF. TIAA Access accounts are fund variable annuity contracts issued by TIAA. The fair values of accumulation units held in CREF and TIAA Access accounts are based on each account's daily published Net Asset Value (NAV). NAV is based on the market value of its underlying securities determined by market quotations or prices obtained from independent pricing sources. The CREF Money Market Account is valued at amortized cost, which approximates fair value. Accumulation units in CREF accounts and TIAA Access accounts are available for transactions at the closing accumulation unit value on any day the New York Stock Exchange is open for business.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Fixed Annuity Contracts - As discussed in Note 4, the Plan's TIAA Traditional Annuity Group Retirement Annuity (GRA) contracts are not considered fully benefit-responsive. Nonfully benefit-responsive investment contracts are required to be reported at fair value; however, the Plan's financial statements reflect GRA contracts at their contract value. Contract value is the aggregation of contributions, plus interest, less any withdrawals. Reporting GRA contracts at contract value did not have a material effect on the Plan's financial statements as contract value approximates a discounted cash flow value calculated using an appropriate risk-adjusted market discount rate which correlates closely with TIAA's Traditional Annuity's historical crediting rates. Fair value is determined annually for financial statement reporting purposes. In determining the reasonableness of the methodology, the Plan's management evaluates a variety of factors including review of existing contracts, historical returns, market conditions, and overall credit ratings. Certain unobservable inputs are substantiated utilizing available market data (e.g. Treasury yields).

Note 4 - Fixed Annuity Contracts

The TIAA Traditional Annuity is a guaranteed investment contract (fixed annuity contract) available as an investment option to plan participants. Each contract is fully and unconditionally guaranteed by TIAA. As an insurance company, TIAA is required to maintain contingency reserves to ensure that it will be able to fulfill its contractual obligations to policyholders.

The Plan holds three types of TIAA Traditional Annuity contracts including GRA, Supplemental Retirement Annuities (SRA), and Group Supplemental Retirement Annuities (GSRA). The type of contract through which a participant invests in the TIAA Traditional Annuity determines the applicability of certain account features, such as the guaranteed minimum interest rate, additional interest declarations, the degree of liquidity of the participant's account, and the options for receiving income upon retirement.

GRA contracts allow participant-initiated lump-sum withdrawals within 120 days following termination of employment and are subject to a 2.5% surrender charges. Other participant-initiated withdrawals or transfers must be spread over ten annual installments. GRA contracts do not meet the fully benefit-responsive investment contract criteria and are reported at contract value, which approximates fair value.

SRA and GSRA contracts are fully cashable in a lump-sum and without a surrender charge. The SRA and GSRA contracts meet the fully benefit-responsive investment contract criteria and are reported at contract value. Contract value is the aggregation of contributions, plus interest, less any withdrawals. For SRA and GSRA contracts, no events are probable of occurring that might limit the ability of the Plan to transact at contract value with TIAA and that also would limit the ability of the Plan to transact at contract value with participants.

During the accumulation phase of the contract, contributions purchase a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. The participant's principal, plus a specified minimum rate of interest, is guaranteed by TIAA's claims-paying ability. The TIAA Traditional Annuity also provides the potential for additional interest if declared by TIAA's Board of Trustees. Additional interest, when declared, remains in effect for the declaration year, which begins each March 1 for accumulating annuities, and January 1 for lifetime payout annuities. Additional interest is not guaranteed for future years. Together, the guaranteed minimum and additional amounts make up the crediting interest rate.

The Plan also holds a fixed annuity contract with The Standard (Standard Stable Asset Fund). The Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The Standard is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula set by The Standard and is reviewed on a quarterly basis for resetting. The effective annual guaranteed yield on the contract will never be less than 1.0%.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Therefore, the Standard Stable Asset Fund is considered to be fully benefit-responsive. Certain events limit the ability of the Plan to transact at contract value with The Standard. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment may apply. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with The Standard or participants.

The Standard may terminate the contract within 30 days advance written notice for reasonable cause and settle at an amount different than contract value. Examples of such events include plan disqualification, failure to maintain assets of at least \$25,000, and the Sponsor's failure to abide by state or federal law.

Note 5 - Certified Information

Certain information in the accompanying financial statements and supplementary information related to investments held as of June 30, 2025 and 2024, and investment income or loss for the year ended June 30, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by Matrix Trust Company, Teachers Insurance and Annuity Association of America (TIAA), College Retirement Equities Fund (CREF), which are qualified institutions. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 7 - Tax Status

The Sponsor adopted a Thorson, Barnett & McDonald, P.C. 403(b) volume submitter plan document. Thorson, Barnett & McDonald, P.C. received an approval letter from the IRS dated March 31, 2017, which states that the volume submitter plan document satisfies the applicable provisions of Section 403(b) of the IRC. The Plan's management believes that the Plan is currently designed and being operated in a manner that would not jeopardize the tax benefits associated with these arrangements. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax periods in progress.

Effective July 1, 2025, the Sponsor adopted an Eisenhower Carlson PLLC pre-approved plan document. Eisenhower Carlson PLLC received an approval letter from the IRS dated May 1, 2023, which stated that the form of the plan document satisfies the applicable provisions of the IRC.

Note 8 - Party-in-Interest Transactions

The Plan invests in variable and fixed annuity contracts and a pooled separate account issued by TIAA. TIAA is one of the Plan's recordkeepers and, therefore, transactions with TIAA qualify as party-in-interest transactions. The Plan also issues loans to participants. These transactions are party-in-interest transactions.

Note 9 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
