INDEPENDENT AUDITORS' REPORT

To the Participants and Plan Administrator of
Stars Company Retirement Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Stars Company Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Stars Company Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section -

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting, described in Note 2.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Stars Company Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter - Basis of Accounting

We draw attention to Note 2 to the financial statements, which describe the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the modified cash basis of accounting, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Stars Company Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

(1) Description of plan:

The following description of the Stars Companies Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General -

The Plan is a defined contribution plan established on March 1, 1997 for all eligible employees of Midway Star Salon Services LLC (the “Company”). An employee is eligible to enter the Plan on the completion of three consecutive months of service, and the attainment of age 18. Union members, non-resident aliens and leased employees are not eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions -

Eligible Participants may elect to contribute any dollar amount or percentage from 1 to 100 percent of pretax annual compensation as defined by the plan in addition to after tax Roth contributions. In 2024, the Company made a matching contribution of an amount equal to 25% of employee contributions up to 6% of compensation, for participants who had achieved three consecutive months of service. In no event may a Participant fund elective deferrals of more than the currently applicable limit under Section 402(g) of the Internal Revenue Code for the year 2024 (\$23,000).

The Plan allows, at the discretion of the Company, a profit-sharing contribution to be made each year. For the plan year ending December 31, 2024, a profit sharing contribution was not made.

As provided for in Internal Revenue Code Section 402(g), participants who will reach age 50 or older in a given plan year are permitted to make an additional \$7,500 pre-tax contribution, called a catch-up contribution, without being subject to the normal limits.

Participant accounts -

Each participant’s account is credited with the participant’s contribution, the company’s matching contributions, Plan earnings (losses) and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting -

Participants are vested immediately in their own contributions and actual earnings thereon. Vesting in the Company’s matching and profit-sharing contributions is based on years of continuous service. Under the plan’s “cliff-vesting” schedule, a participant is 100% vested after 3 years of vesting service. No set number of hours will be required to be worked during the vesting service period.

(1) Description of plan (continued):

Notes receivable from participants -

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by a portion of participants' account balance. Loans may be extended for periods not to exceed five years, except when loan proceeds are used for the purchase of the borrower's primary residence, in which case the loan may be extended up to thirty years. The interest rate is computed using the prime rate (as specified in the Wall Street Journal) plus 2%. Loan repayments are made through payroll deductions.

Interest income from the notes is recorded on the cash basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Distributions and withdrawals -

Upon participant termination due to death, disability of service, retirement or due to other reasons, the participant may choose to receive a lump-sum amount equal to the vested portion of his or her account, non-recurring partial payments, or installment payments.

Forfeited Accounts -

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$4,679, respectively. These accounts will be used to pay the Plan's administrative expenses or to reduce future employer contributions. During the year ended December 31, 2024, employer contributions were not reduced from forfeited non-vested accounts.

(2) Summary of significant accounting policies:

Basis of accounting -

The financial statements of the plan are prepared on the modified cash basis of accounting, which is a basis other than accounting principles generally accepted in the United States of America. Under this method, revenue is recognized when received rather than when earned, and expenses are recognized when paid rather than when the related obligation is incurred. Modifications to the cash basis of accounting result from reporting investments at fair value and excess contributions on the accrual basis.

Use of estimates -

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosures of contingent assets and liabilities. Accordingly actual results could differ from those estimates.

(2) Summary of significant accounting policies (continued):

Investment valuation and income recognition -

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses, unrealized appreciation and depreciation, and dividends have been combined and shown as net appreciation (depreciation) by the record keeper and in these financial statements. Dividends are recorded on the date received by the custodian. Interest income is recorded on the cash basis.

Notes receivable from participants -

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Excess contributions payable -

Amounts payable to participants for contributions in excess of the amount allowed by the IRS are recorded as a liability, with a corresponding reduction to contributions. For the year ended December 31, 2024, the Plan failed the Actual Deferral Percentage (ADP) Non-Discrimination Test. As a result of the failure, excess contributions of \$32,116 were required to be distributed to highly compensated employees (HCEs). The required distributions, including earnings, were made to the affected HCEs on March 3, 2025, which was within the permissible period to avoid excise tax. The Plan is now in compliance with the Internal Revenue Code requirements regarding the ADP test for the 2024 plan year. There were no excess contributions in the year ended December 31, 2023.

Payment of benefits -

Benefits are recorded when paid.

Expenses -

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

(3) Fair value measurements:

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical similar assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

(3) Fair value measurements (continued):

Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 and 3 inputs for the periods presented.

Level 1 Inputs - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs - Observable inputs other than Level 1 prices, such as quoted prices for identical or similar assets or liabilities that are observable either directly or indirectly.

Level 3 Inputs - Unobservable inputs that are derived from predictable assumptions that cannot be corroborated by observable market data - normally internally generated management assumptions developed from the perspective of market participants.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at quoted market prices which represents the net asset value ("NAV") of shares held by the Plan at year-end.

(3) Fair value measurements (continued):

Gains and losses included in changes in net assets available for benefits for the years ended December 31, 2024 and 2023, are reported in net appreciation in fair value of investments.

The Plan's policy is to recognize transfers between Levels 1 and 2, and in and out of Level 3, as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024, there were no transfers between Level 1 and 2 and no transfers into or out of Level 3.

(4) Certified investments:

(5) Plan termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants will become fully vested in their account balances. Any unallocated assets of the Plan should be allocated to participants accounts and distributed in such a manner as the Company may determine.

(6) Tax status:

The Plan has adopted a prototype "standardized" plan and the prototype sponsor (CCH Incorporated) has received a determination letter from the Internal Revenue Service dated June 30, 2020, indicating that the prototype Plan is a qualified plan meeting the requirements of applicable sections of the Internal Revenue Code. Although the plan has been amended since the formation, the Plan administrator believes that the Plan is designed, and currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt. An IRS Cycle 3 plan restatement and new adoption agreement was prepared in 2021, effective for January 1, 2022.

(6) Tax status (continued):

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain positions that are more likely than not to be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken or expected to be taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021. In addition, there have been no tax-related interest or penalties for periods presented in these financial statements.

(7) Risk and uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits (modified cash basis).

(8) Party-in-interest transactions:

Certain Plan investments are managed by Ascensus Trust Company. Ascensus Trust Company is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Ascensus Trust Company received certain direct fees, which amounted to \$85,636 for the year ended December 31, 2024 and are included on the accounting statement of changes in net assets available for benefits as administrative fees. In addition, there were indirect fees paid by the Plan for investment management and advisory services which were absorbed in investment income and not readily determinable.

The Plan issues loans to participants, which are secured by a portion of participants' account balance. These transactions qualify as exempt party-in-interest transactions.

(9) Subsequent events

The Plan management has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.
